I have just checked up with George 0. Foster, the registrar of the University, and find that "Hi" Arnold was in school but one year, the academic year of 1914-15. It is necessary for a student to be in school one academic year before he is eligible to compete in any varsity sport.

So this one year genure of Arnold's would make it proof positive that he never competed in any track events in which he represented the University of Kansas. Doubtless he was in intramurals, inter-class competition, and he perhaps

was a pretty fast man and created quite a bit of discussion by his performances which lead to conversation regarding his outstanding achievements.

Then, to confirm matters I called W. O. Hamilton, who was track coach and basketball coach as well as athletic manager during this year of 1914-15. Hamilton is in the automobile business here in Lawrence, and I thoroughly drilled him on Arnold's performances. He said that he was sure that Arnold did not compete for the varsity.

And as far as breaking any records is concerned, Cupid Haddook and Fay R. Moulton, two boys from Kansas City, held the records for the 100 yard dash; that was 10.1.

Perhaps in some intramural meet "Hi" might have run, jumped and vaulted to exceptional heights, but that would

only be intranurals.

Before | go any farther | am going to ask you a leading question. When I started to dictate this letter I was stopped by the question: "How in the world did that name ever attach itself to Dr. Allen?" If I ever knew I have forgotten and I wish you would tell me. Perhaps I should address you as Dr. Allen anyway but I never think of you that way and it really sounds too dignified. Now to business.

I am writing to you in the hope that you may help me in obtaining some information which I desire to write a story about a former K. U. athlete, H. N. Arnold, known as "Hi," who I understand attended K. U. around 1913-15. He now is a rancher and extensive Hereford breeder at Buffalo, Okla., where he operates a 10,000 acre ranch. My informant tells me that he was a record holder in the one hundred yard dash at K. U. at one time, was a discus thrower and broad jumper.

If it is possible for you to have someone give me the information about Mr. Arnold's career at K. U., at least such parts of it as can be included in a story concerning him, I shall appreciate it very much indeed. Mr. Arnold lives now just across the state line from another famous athlete, Jesse Harper and I understand they get together occasionally for athletic reminiscences. Perhaps someone else would be the proper person for me to address to get this information but you are the one I know best and I naturally thought of you. Bill Hargiss has been at K. U. but a comparatively short time and perhaps would not know this man, even by reputation.

Believe it or not, I haven't seen a basketball game nor attended a football game or a K. U. relay in two or three years, not, however, because of lack of inclination.
