Dear Dr. Voltmer:

We are very happy to have your acceptance to play the basketball game here on December 3rd. I am enclosing two copies of the contract signed by Mr. Gwinn Henry, our Director of Athletics. Will you kindly sign one copy and return it to us?

We cannot promise you a game for the 1939 schedule, but we will do the best we can. We are planning to go either east or west, and that may take up most of our schedule.

We will be glad to have Coach Scott assist in the demonstrations on Saturday afternoon, December 3. We will use our varsity squad for those demonstrations and of course he and I will get together so that we won't tire any of the players unduly.

I have just received the notice of your Homecoming Program on November 11, and also the list of students and faculty of the Warrensburg Normal who emlisted for service in the World War. In scanning over this list I find the names of many boys whom I knew so well when I was teaching at Warrensburg who are either deceased or are not reported.

My own brother, Richard C. Allen, was killed five years ago above the United States Military Academy at West Point. He was an aviator, an inspector for the Department of Commerce. He was at the time flying home to Haddenfield, New Jersey, for a birthday dinner with his wife and young child, and something went wrong with the engine and he baled out, but the parachute failed to open in time. He was dashed to death.

There are many others on this list whose whereabouts I can furnish, and I will be glad to send this later.

I will, of course, respond to President Diemer and Miss Landsiedel in answer to the invitation to attend the Home-coming celebration. I am afraid I will not be able to avail myself of the opportunity to visit you on Armistice Day, but I congratulate you on this fine move to get the old timers back. If there is any possible way, I should like to be at Warrens-burg to greet these friends.

Dear Dr. Voltmer:

Your favor of September 26th received. I am sorry that it would not be possible to offer you a guarantee of \$150.00. I would kindly call your attention to the fact that five years ago the University of Kansas played at Warrensburg for a guarantee of \$100.00. We had won four or five championships in the Big Six, but we did not consider our prestige in the matter. We went down to Warrensburg and played the game because it was an early season game; we went for the good that both of us could get out of it. I think we figured up the expenses of driving over and coming back, and it came to a little less than \$100.00 so we just agreed with Tad Reid that we would play for that amount.

In this game on December 3rd we would admit all the high school players and coaches who would come in for the clinic Saturday afternoon. It was my notion that we would not have much of a gate. So sure am I of this that I would be willing to offer you the entire gate receipts if you would not care for the guarantee.

I have had letters from six or eight schools asking us for this early season game, but I remembered a few years ago when Tad Reid came over here when the athletic shake-up was on, and he made a statement to the committee that we played every team in Kansas but would not accommodate him by playing his team. Of course, he had forgotten that just three years previously we had done this very thing, and only for a kindly accommodation.

I remember years back when the University of Kansas offered me a football game and a basketball game, I told them we would come for whatever they thought was right. I did not want any more than expenses, because I knew that these small schools do not draw much away from their own territory.

This game, of course, would be on Saturday night and all the merchants would be unable to attend the game on account of their business. So you can see why I consider \$100.00 a very liberal guarantee.

We have a great number of games rather definitely scheduled for next year. We plan to go to the East coast or the West coast, and either way we have tentatively committed ourselves, so for that reason I would not care to sign a two year contract. However, it has been our policy to play these smaller schools, and I could assure you that if we did play you the next year or the year following that we would play at your school for the same guarantee that you would receive here. I consider this eminently fair, as I do when I offer you the \$100.00 guarantee, because it is exactly what we got when we played at your place in the last basketball contest between our two respective schools. The game that I refer to was played in December, 1933. You can look it up in your records and I think you will find my statement quite correct.

If you are further interested in a game I will be glad. to hear from you.



Dear Dr. Voltmer:

Some time ago you wrote me about a basketball game. At that time we had all of our dates arranged, but it looks as if there may be a slip up in one of our games that we may not carry through. If that is the case, I am thinking about the possibility of having a clinic game here on Saturday, December 3rd.

We are playing the Oklahoma Aggies at Stillwater at the dedication of their new field house with a seating capacity of 9,000, on December 9 and 10. Our Big Six coaches meeting is Friday night, December 2nd, and the basketball rules meeting is Saturday morning, December 3rd, at ten o'clock in Kansas City at the Notel Kansas Citian. I thought it might be a nipe thing if we could arrange a clinic game for the evening of December 3rd.

In the afternoon we could meet with demonstrations for the high school coaches of Kansas and Missouri and have our groups demonstrate the necessary fundamentals and formations.
