Dear Mr. Allen:

I have your letter of July 3 regarding the possibilities of bringing Mr. Quigley down here to Austin for our two-game series with your school.

As I explained to you in a previous letter, this series with the University of Kansas is an experimentation for us and we feel sure that we will not be able to make expenses on it after raising the first guarantee that we offered. The interest in basketball here in Austin does not reach its peak until well after Christmas, and I feel sure that we cannot make expenses on this series. In view of this fact, I feel sure that we must do everything to curb our expenses and try to stay within our basketball budget. Two years ago we played the University of Southern California at approximately the same time that our games are scheduled and we suffered a considerable loss. I agree with you that basketball lacks uniformity, but I feel that our officiating here in the Southwest Conference is something like that in the Big Six. Last Christmas we played a two-game series with the University of Oklahoma here at Austin and at that time we used Southwest Conference officials, and I honestly believe that Coach McDermott was well satisfied.

I do not feel hesitant in the least way in recommending Ziggy Sears for our games. At the present, Mr. Sears is the Umpire in the National League and has many years experience in both football and basketball officiating. I believe that Mr. St. Clair, newly appointed Commissioner here in the Southwest Conference, will agree that Mr. Sears is one of the best officials in the game today, and I wish that you would have him suggest the second official from this Conference to work with Mr. Sears in this series.

I am certainly in favor of uniformity in the officiating of basketball, and I will do everything that I possibly can to help improve that condition, but under the present circumstances I feel it will be impossible for us to bring Mr. Quigley to Austin.

Dear J. W.:

Thank you for your good letter of the 26th instant.

You know, J. W., since I have corresponded with Jimmie Stewart and with Jack Gray I have just come to the conclusion that we would rather let the commissioner pick the men from down in Texas territory. I do not want them to feel that I think it is necessary for me to bring an official along with me. That was far from my thoughts, and with the best of grace I am leaving it up to the commissioner to pick them. I know that he is fully competent to do a good job on the first picking of any man.

We always pay Quigley \$20.00 and expenses. Some people have felt that Quigley was high on expenses and we always had a stated guarantee and he worked on that basis. We paid him \$7.20 from Lawrence, Kansas, to St. Marys, Kansas, and return. That took care of his hotel bill and all traveling expenses, and whatever he wanted to do after we paid his expenses was his own business. He preferred to get that sort of a guarantee for each game and then he could arrange his schedule as he saw fit. We have no quarrel with that, and I am very sure that Quigley would have been fair. I also thought that he would aid as a drawing card and he would more than pay for some of his expense.

Now, regarding Billy Dewell. I find that I did not make myself clear in my letter. I meant next year, a year after this one, when S.M.U. would be playing up here. We haveasigned a reciprocal two-year guarantee with S.M.U. and Texas, so both groups will play in Lawrence. And when I referred to next year I meant the year after this one coming up. I regretted that it would not be possible for Billy Dewell to captain his S.M.U. team when they play here. I find that I did not make myself plain to dimmie or to you because Jimmie wrote me the same type of letter as you have written.



I know he was playing this year, but I referred to the time that we would play S.M.V. at Lawrence. I know that he will give us plenty of trouble this year, and I know that if he played next year he would also give us plenty of trouble. I perhaps should have made myself more plain. I am sending you a copy of a letter that I wrote Mr. Jack Gray, basketball coach at the University of Texas. This has reference to the problem of a 50 - 50 ratio on empenses for the officials. Since we are to play two games at Dallas and two games at Leurence on reciprocal guarantees, I personally could not see why we should not share in the matter of expenses of the officials as well as the other 1toms. However, this morning Mr. Henry passed on to me the signed contracts for the two games at Dallas, and it is perfectly agreeable to me that your Cosch Baccus submit a list of names to me, or we can loave it to J. I am sending you a carbon copy of the letter I wrote to Jack Gray, basketball coach at the University of Texas, in response to his contention that we pick two Texas officials there, and two Missouri Valley officials when they come up here next year.

I have a similar letter from J. H. Stewart, director of athletics at SMU, saying that J. W. St. Clair has been appointed commissioner of officials and he would perhaps select officials for the games.

I assure you that I have no desire to pleasent myself as being afraid of the kind of a game that they might officiate, but I thought it would be better for all concerned to have one official from each locality, this arrangement to be reciprocal at both places.

I am glad to have your good letter of the 8th instant and am happy to know that you will be able to come to Lawrence in 1939. I certainly have no desire to disagree with any of your selections, but since we are signing a reciprocal guarantee for the same price in Lawrence as you pay us in Austin, I do not see that the guarantee is any more one way than the other whether for a conference or a non-conference game.


