





I have always been very fond of the personnel at the Municipal Auditorium, and I count them my very best friends. I was under the impression the policy would come from higher up and was not blaming you at all.



Mr. Lower met a very tragic death at the hand of a drunken guard on July 18th, and Mr. Hoff took over Mr. Lower's duties immediately.






