tive of the department in which the student elects to do his major work. Therefore, students desiring graduate credit for summer work must enroll with the dean of the Graduate School, and graduates of institutions other than the University of Kansas must present a complete official transcript of their college records to the dean of the Graduate School. It is highly important that this transcript be sent to the dean one month or more in advance of enrollment.

Students who neglect to furnish evidence that they are eligible for admission to the Graduate School will be enrolled only provisionally, and graduate credit for part or all of their work will be forfeited if it appears subsequently that they are not eligible for unconditional admission.

EXPENSES

FEES*

Matriculation Fee. Every person when he first presents himself for admission to the University is required to pay a matriculation fee. This fee is payable only once. For residents of Kansas the fee is \$10, for nonresidents it is \$20.

Definition of Residence. The residence of persons entering any of the state institutions of higher education is determined by an act of the legislature (L. 1938, sp. sess., ch. 70), which reads as follows:

"Persons entering the state educational institutions who if adults have not been, or if minors, whose parents have not been residents of the state of Kansas for six months prior to matriculation in the state educational institutions, are nonresidents for the purpose of the payment of matriculation and incidental fees: Provided further, That no person shall be deemed to have gained a residence in this state for the aforesaid purpose while or during the elapse of time attending such institution as a student, nor while a student of any seminary of learning, unless, in the case of a minor, his parents shall have become actual residents in good faith of the state of Kansas during such period, or unless, in the case of a minor, he has lived with or been supported by his parents or either of them for three years or more prior to enrollment and during said years has been a resident in good faith of the state of Kansas."

INCIDENTAL FEE. There is required by law the following incidental fee:

Part-time Fees. Provision is made for persons to take part-time work at an hourly rate, as follows:

Limited Enrollment Fee: A student who, for good reason, is forced to reduce his scholastic load may, with permission of his dean, take a limited enrollment of not to exceed three hours, with or without credit, for incidental fees as follows: At Lawrence, \$2.50 an hour if he is a resident of Kansas, \$7.50 an hour if he is a nonresident; at Kansas City, \$5 an hour if he is a resident of Kansas, \$12.50 an hour if he is a nonresident.

Professional Fee: A person of mature age who is already engaged in a profession or life work may enroll in not to exceed three hours, with or without
