

1. Qualifications:

(b) Good physical specimen with military bearing.

- 4. Students who are found unsatisfactory in the course at the Physical Instructors' School shall be transferred to general detail.

I should have written you long before this, but we have had a lot of sickness in the office, and I have been pretty busy with some Washington representatives.


