EXECUTIVE ORDER NO. 34-44

THE FOLLOWING NAMED MEN HAVE BEEN PLACED ON ACADEMIC RESTRICTION. THEY SHOULD SURRENDER THEIR LIBERTY CARDS AT THE V-12 OFFICE BY 1200 SATURDAY 5 AUGUST 1944. THIS RESTRICTION IS BASED ON GRADES FOR THE PERIOD ENDING 1 AUGUST 1944.

WHILE ON ACADEMIC RESTRICTION, THESE MEN WILL ENGAGE IN NO EXTRA-CURRICULAR ACTIVITIES. THEY WILL BE ON STATION BOUNDS EXCEPT FOR THE AFTERNOON RECREATION HOUR, 1630-1730, MONDAY THROUGH FRIDAY, AND FROM 1330 SATURDAY TO 1530 SUNDAY.

IF TRAINEES, ON RESTRICTION, WISH TO LEAVE LAWRENCE SATURDAY NIGHT, THEY MUST APPLY TO THE EXECUTIVE OFFICER FOR THEIR LIBERTY CARDS.
