EXECUTIVE ORDER NO. 9-44

THE FOLLOWING NAMED MEN HAVE BEEN PLACED ON ACADEMIC RESTRICTION FOR PERIOD ENDING 1 APRIL 1944. THEY SHOULD SURRENDER THEIR LIBERTY CARDS AT THE V-12 OFFICE BY 1200, WEDNESDAY 12 APRIL 1944.

WHILE ON ACADEMIC RESTRICTION, THESE MEN WILL ENGAGE IN NO EXTRA-CURRICULAR ACTIVITIES. THEY WILL BE ON STATION BOUNDS EXCEPT FOR THE AFTERNOON RECREATION HOUR, 1630-1730, MONDAY THROUGH FRIDAY, AND FROM 1330 SATURDAY TO 1530 SUNDAY.

IF TRAINEES, ON RESTRICTION, WISH TO LEAVE LAWRENCE SATURDAY NIGHT, THEY MUST APPLY TO THE EXECUTIVE OFFICER FOR THEIR LIBERTY CARDS.

THE BASIS FOR ACADEMIC RESTRICTION IS AS FOLLOWS: 8 hrs. D; 5 hrs. F; 4 hrs. F; 1 hr. D; 3 hrs. F; 3 hrs. D; 2 hrs. F; 5 hrs. D; 1 hr. F; 7 hrs. D.
