Dear Coach Uhls:

Yes, indeed, I remember you very distinctly, even when you were at Osawatomie. It is interesting how these things recur to an individual.

Now, back to pages 292 and 332. I can see how these might confuse you, but if you will take exhibits 107 to 113, inclusive, I am sure that that zone play will agree with yours. I think what confused you was looking at the diagram on 292 and seeing 3 advance so far up in the defensive court against 3. I made these diagrams to show the ordinary play against the man to man defense which might shift to a zone without calling time out. They do this so much in our part of the country. They will start with a stiff man to man and then shift to a zone, and I believe that I can explain to you well enough that if I had set the zone man back there so far in the court, then many of the critics would say, "We do not play that way - we move the man up and then drop him back for strategy's sake."

This is to mask some of their intended strategy. Now, by the same token, each of the defensive men signifies a certain opponent for whose movements he will be personally responsible during these regular game situations. Now that makes each man responsible, yet they can trade or switch, whether the game be a man to man or a zone game. If the opponents play a zone, then the defense can shift to meet them, but suppose they go to a man to man set up very quickly. Then the assignments hold good and there is no confusion.

There are very few tip-top teams that play a zone exclusively. Oregon used a zone devense because they had three men - 6.8", 6.4" and 6.4" - in a triangular zone defense under the basket. Then they had Wally Johansen and Captain Anet, two fast men, to harry the other shooting opponents out in front of the giant trio. Any team can play a zone game with such tall specimens as Oregon had. However, not one bit of credit should be detracted from the Oregon coach or the Oregon team. They had a great outfit.

But Oregon did use screening plays against a man to man team, and that is what I tried to bring out. Whenever you have a team playing man to man against you, then a coach is wise if he will use screening plays because they just naturally set up more easily. And then when they use a zone defense against you I have endeavored to show what to do if you have a set scheme of offense to work against them. That is why on Diagrams 80 to 83 inclusive I have shown plays that will work against a very efficient team. It will be very difficult to work in under the basket against a zone defense, but you can flatten their defense and then shoot over.

I endeavored to show coaches who use both systems how to set them up and make them both work alike as far as the set-up is concerned.

Here is my answer to you. Against a team that is using a man to man defense I use screening plays designed for use against the man to man opposition. And when I get against a team that plays strictly a zone, then I use these plays (80 to 84) with any derivations that are necessary under the situation. But I do plan and work that the boys in dummy or mock scrimmage all these possibilities.

Now, if I have not answered all the questions that you want, then fire another letter back to me but leave enough space so that your questions and diagrams can be answered on the same sheet. You set up your diagrams and ask your questions, and I will fill in my diagrams with the answers.

You state that you will be coming east this summer. I will be here the eight weeks beginning June 14 and ending August 9th. I will be happy to see you and answer any questions, should you come through.
