

k. If you believe they possess high ideals of amatourism, state why you have reached this conclusion.

m. State vocations your candidates are now engaged in.

n. What are their avocations, if any?

We trust that you will act on the 'Tribunal. May we receive your nominations at an early date or not later than November 1st.




