don't believe he will stay here very long. He seems to have the ability to build things rather rapidly.



Dear Coach Mepfers

Answering your kind letter of the 12th instant, may I kindly call attention to the terminology which you have used. "Blocking is personal contact which impedes the progress of an opponent who has not the ball."

"Blocking is a personal foul and therefore there is no such play as a 'legal block'. Legally shutting off the approach of an opponent should be called 'screening'."

I am sure that you meant to seek information on the percentage of teams throughout the country who use a system of screening.

I believe practically all the teems in the big conferences use wither a moving screen or a set screen. This applies also to most of the larger conferences regarding the individual members, all of which use a fast break at times with a slowing up at times, and an indulgence in a set play.

Purdue comes the closest of the Big Ten teams to a rapid fast break. I would suggest that you write H. G. Olsen, the basketball coach at Ohic State University, Columbus, Ohio, and he will be able to give you the information on the Big Ten. For our Big Six Conference, including the Universities of Nebraska, Missouri, Oklahoma and Kansas, as well as Kansas State College and Iowa State College, all of the Big Six teams use a fast break at times, coupled with set screen plays. For the Missouri Valley Conference, which includes Oklahoma. A. and M. College, Drake University, Tulsa University, Creighton University, Grinnell College, Washburn College, Washington University and St. Louis University, the same is true regarding the fast break, coupled with the set plays.

The difficulty with high school teams is that the youngsters are generally immature and the changing condition in schools precludes most of the high school teams using the set plays. Only the larger schools use the set plays. The others use a free moving of the ball around and the teams rotating until they get a favorable shot at the basket.



Weens: Acknowledging your letter of February 7th, I will answer your questions in ordere Yes, our basketball games are played directly upon our permanent auditorium floor. Should you desire to employ a false floor, I suggest that you write to Dean John We Bunn, at Stanford University, Stanford, California. He can give you the arrengement of the false floor in Madison Square Garden, New York. I have seen the floor in operation, but I believe that Mr. Bunn could give you more definite information on it. There are two standard slide-proof surfaces that I definitely know of - the Hillyard Chemical Company, St. Joseph, Hissouri, and the Seal-O-San Company, of Huntington, Indiana, By writing to these people I am sure they would be glad to send you information on their compositions. Madison Square Garden uses the Hillyard product, and a number of colleges and universities use the Seal-O-San floor finish. Both are standard. May we solicit the benefit of your experience in the solution of this problem?

Are your basketball games played directly upon the permanent gymnasium floor or do you employ a false floor of some kind?

If the former, what agent do you use to guarantee a slideproof surface and what is the cost of preparing the floor for a game and restoring it to its original condition after the game?

If your games are played upon a false floor, what type do you use? Is it satisfactory to coaches and players? Does it offer adequate protection to the permanent floor? What was the original cost and what is the upkeep cost? How many hours does it require to install and remove?

Finally, would you please suggest some commercial firms from whom we may gather further suggestions.
