My dear Mrs. Williams:

Your good letter of September 29 received, and I am glad to hear from you, I assure you. It would be good to have a visit with you.

I am glad to know that you are interested in this ambitious young man who is receiving instruction in the physical education department at the teachers college. You ask concerning my football book. Doubtless you refer to my new text on basketball, entitled "Better Basketball", published by McGraw-Hill and Company, of New York.

Some fourteen years ago I published a book called "My Basketball Bible". It had a circulation sale of 15,000 copies, and last year I wrote this new book, "Better Basketball". The publishers spent over \$3,000 in publishing this book. They sell these books, as they do all of their other publications, to athletic goods houses and book concerns. The author gets but ten per cent of their sale price, so you see that as much as I desire to help the young man out, I do not possess copies because I wrote the book. If I should want to purchase a copy I would have to pay for it like anyone else.

I assure you that I forgive you for asking for this because the presumption generally is that because a fellow writes a book he possesses copies of it.

I have this observation to make. Since the young man is in this field it is possible for him to go to the library of the teachers college or any school library and get the information from this book. All libraries handle these books and it is not necessary that he possess a copy until he can get sufficient funds to purchase one. I believe this is one of the values that we get in education. We cannot possess personally all of these things, but we do have access to them through sources provided by educators.



However, since he is in this field he may want to possess a copy of this source book when he is in funds, but until then it is possible for him to get all the information contained in the book by patronizing the library.



I want to bring my son and daughter to see the KU-Nebraska game this coming Saturday--hence will need tickets for them and Mrs. Welty and myself.


I am enclosing herewith a blank check which I wish you would fill in for 3 tickets and reserve my "K" ticket with the 3 others. My K Card is No. 410.

## Makes Many Improvements In Her Office

Many improvements, beneficial both to the public and the legal profession, have been put into ef-

fect since January, 1937, in the office of Mrs. Leah B. Willcuts, clerk of the Shawnee County District Court and a Republican candidate for re-election.

Mrs. Willcuts has made these seven important changes:

1. Adoption of a policy of keeping the office open during the noon hour for the convenience of the public and the lawyers.

2. Installation of a modern triplicate receipt system which insures more accurate handling of county money.

3. Hauling from the attic many books of old records; racks have been built and the records since 1862 now are in order; county commissioners assisted in this project.

4. Arranging all old criminal records so they are readily accessible in the attic; an index directs the way to these records.

5. Tracing down of every old book and record kept by the clerk's office since 1862.

6. Rebinding of many old books in the office vault.

7. Installation of a new flat filing system that will make current

records much more accessible; the new system will be ready for use next week.

Mrs. Willcuts, a native Topekan, was educated in the public schools here and at Washburn College and Kansas State College.

She is the mother of Dorothy Jane Willcuts, a senior at the University of Kansas, and Lois Elaine, sophomore at Topeka High School. She lives at 822 Topeka Avenue.

The office she now holds and to which she was elected in the fall of 1936 is the first public office she ever has held.


