
The government demands that we submit these tests regularly, and for us not to use such apparatus would be an abrogation of our agreement. I do not know what else to do, do you?

REGULATIONS CONCERNING PROPOSED NEW COURSES OR CHANGES IN COURSES

Adopted by the University Senate on May 20, 1935

That the Senate Advisory Committee shall serve as a committee on new courses. No new course or change in the content of a course shall be offered or shall be announced in the University catalogue unless it has been authorized by the following procedure:

When any school has approved a new course, or a change in the content of a course, that school shall notify the Senate Advisory Committee. The Senate Advisory Committee shall notify all deans and chairmen of departments concerned of the proposed action, and of a date prior to which requests for conference may be filed. Any faculty member concerned with or opposed to such proposals may ask the Senate Advisory Committee for a conference on the proposed course or change. If no request is received, and the Senate Advisory Committee itself makes no adverse recommendations, such course or change shall be considered as approved by the committee on the date fixed. If any request for a conference is received the Senate Advisory Committee shall arrange a conference of all interested persons.

If, after conference, the Senate Advisory Committee considers the new course, or the change, unwarranted, and if the school initiating the action does not accept the committee's conclusions, the Senate Advisory Committee shall report its findings and recommendations to the Senate for Senate action.

Owing to the difficulty that national associations have had in arranging their annual meetings no definite out-of-state travel budget has been set up by the University for the fiscal year 1942-43. Any member of the staff desiring to attend an association meeting or make any other trip outside Kansas, the expense for which would be normally borne by the state, should make application in writing directly to the Chancellor somewhat in advance of the date of the propsed trip. Requests for travel to be made under the grants from the Graduate Research Committee should be submitted to the Graduate Office rather than to the Chancellor.

Under the state law, out-of-state travel for which reimbursement is expected must be approved by minute of the Board of Regents in advance of the date of the heginning of the trip, and receipts must be presented for every item of expenditure, except taxi and the like. Travel for the state is exempt from the Federal Transportation Tax if a transportation exemption certificate is filled out at the time the ticket is purchased. Copies of this certificate are available at the Chancellor's Office.

Dear Chancellor Malott:

I talked to Mr. Karl Klooz, the athletic director, concerning a rubber-treated mat cover which was bought by the Athletic Association when I was athletic director some fifteen or eighteen years ago.

In the physical conditioning program both the Army and the Navy teach wrestling. The felt mats here at the gymnasium are in various sizes and it is difficult to hold them together as one single mat surface large enough to wrestle upon. It is impossible to buy a cover the like of which the athletic association possesses. However, we have ordered three cotton flammel mat covers which require laundering when soiled. In the interim we desire to use this mat cover which is not used at all by the athletic association.

Mr. Klooz offered to sell the same to the Physical Education Department. I told him that since there had been so many interchanges between the Physical Education and Athletic Departments that I was not sure you wanted funds to pass from one to the other when it was not necessary. For instance, last fall Coach Henry desired to have mats that the football boys could lie on in the dressing room at the stadium between halves. We selected the more worn mats in the gymnasium and sent them to the stadium where they have been in use by the Athletic Association. We made no charge whatsoever, and this has consistently been our practice between the Physical Education Department and the Athletic Association from year to year - to cooperate as if it were one department.

As I view it, a rubber mat cover is improved by taking it out of storage and using it somewhat. I certainly would have no objection to paying a small rental - something like a dollar a month for the same, but where there has been such close cooperation existing between the two departments I could not agree with Mr. Klooz that we should purchase the same. What is your opinion?

HEADS OF DEPARTMENTS:

Effective immediately, the Board of Regents has ordered that all changes in the payroll be sent to them for consideration not later than the date they are to become effective. This covers both routine minutes that come within the budget, such as resignations and appointments and emergency items which require expansion of the budget, such as salary adjustments and new positions.

In order that this office may meet the requirements of the Board the following suggestions are made to departments:

(1) Resignations should be reported promptly, as far in advance of the date they are to become effective as possible.

(2) Appointments to positions provided in the budget should be made in advance of the effective date, as soon as the new employee has been secured.

(3) Requests for positions not provided for in the budget should be submitted to the Chancellor as far in advance of the date of beginning of employment as possible.

(4) Recommendations on adjustments in salaries should be submitted to the Chancellor considerably in advance of the date they are to be made effective.

(5) Requests for any other expansions of the budget, such as Maintenance Allotment or Assistance Fund, should be submitted in advance.

Since the Board does not have regular meeting dates it is imperative that departments anticipate their needs and submit their requests to the Chancellor considerably in advance of the dates on which they would like to have changes made.

In case of real emergency, the Chancellor will attempt to secure special action of the Board. With the exceptions of these emergency cases it is believed that the new order of the Board will not seriously affect the procedures of appointment which have been followed up to now. With a little planning most of the budget problems in the University can, I am sure, be anticipated and presented to the Board for approval in advance of the dates we want them to become effective.

Immediately upon receipt of your telephonic communication this morning I got busy and engaged Robert Witt, a young man who is doing some extension work. He is not in school but will be at the opening of the fall term. However, I have the matter arranged so that he will police the building from dinner time on. We are working with the officer in the evening so that the best results will be obtained.

I have issued orders that no high school or intermediate boys or anyone else not connected with our physical conditioning program shall have access to this building. This is temporary over the week-end, but I assure you that it will not be necessary for you to give any concern to this matter hereafter as we will definitely take care of it.

There is another matter that I wish to speak to you about as soon as possible. I refer to a necessary place for the officers of the Navy to dress when they take their physical exercise. They are required to exercise three times a week. Our quarters are congested beyond description. Why couldn't the athletic office be fitted up for these men to dress in? There are ten or twelve of them and we simply have no place. This morning I invited them in to our private dressing room, which is already congested with our staff. These men have been exercising out of doors, but now with coller weather coming on they will necessarily have to use the gym. This will be true of the Army and the Air Corps officers.

There is a further matter that I spoke to you about over the phone, and I want to speak to you personally about it. The manpower could be benefitted somewhat in a combat way if some men could be sent to fight. I wish to discuss this personally. We would be much better off.
