I am writing you a progress report concerning the disposition of funds of the National Collegiate Athletic Association Western and National Dasketball Tournament, which was played in Maneas City last March 22, 23 and March 50. There were total each receipts of \$22,829.55, and a not profit of nearly \$10,000 secruing from these games.

In some quarters there has been a misunderstanding that perhaps I, as managing director of the tournament and also as coach of the Kansas team, had not prosecuted the interests of our own University Athletic Association as vigorously as I might have in keeping with my position here at the University.

I am sending you the correspondence between the different officers and the chairmen of the committee to show you that the "big wigs" are the boys who want to keep the money. You can see by the emclosed leaflets the names of the officers and perhaps get well enough acquainted with the general set-up to learn their identity. Upon every occasion I have processed the case quite vigorously. It looks as if we may get \$500.00 as our share, but that is still undetermined at present.

Onio State University; Mr. J.W. St. Clair, Southern Methodist University and myself, mot with the Empeutive Committee in Chicago on September 6 and 7. You will see by our communication dated September 6 that we proposed the participants get some of the money. The Empeutive Committee did not agree with our committee, contending that the schools had no right to any of the money; that the money should be expended by the officers of the Empeutive Committee who handled all sports. Thereupon I offered my resignation as manager of the tournament, and also as an officer of the National Collegiate Athletic Association. I stated that I did not care to be associated any further with the enterprise because I had made certain commitments predicated upon past practices and that I found myself of no further service. My action was supported by the other two members of the committee.

The Executive Committee asked us to withdraw and swait their action. We did so. Upon our return to their quarters they read an action by their group to which our committee was willing to acquiesce. On September 10 Major Criffith sent communication to Harold Olsen setting out the National collegiate Athletic Association Sindings. On September 16 Mr. Olsen replied for the

committee. My letter to Mr. Olsen dated September 27 and Mr. J.W. St. Clair's letter dated September 50 will restate our position.

You will recall that Missouri, Oklahoma and Mansas made \$1,000 net after our expenses were paid in Wichita at the Big Six play-off. The Fifth District play-off between the Oklahoma Aggies and Mansas at Oklahoma City netted an additional \$1,000 to oklahoma and Mansas each, after expenses were paid. The cruz of the whole thing is that the N.C.A.A. Executive Committee is taking the financial plum from the gate receipts when the great erowds assembled in Mansas City for the Western and the Mational play-offs.

Dear Chancellor Malott:

I am sending you the final progress report on the National Basketball Championship finances. In my letter to Mr. Olsen, who is chairman of the Tournament Committee, dated November 18, I endeavored to get him and Major Griffith together on a settlement. I have been the mediator in all of these things and I believe finally we are getting somewhere.

Finding that it was impossible for me to get back to Chicago again for a conference I wrote Major Griffith on November 30 setting forth the things that I had endeavored to get Mr. Olsen to work out for me. On the same date I wrote Mr. Olsen, sending him and Mr. St. Clair, the other member of our Committee, a copy of my correspondence with Major Griffith. On December 5 I received a copy of a letter that Mr. Olsen wrote Major Griffith. All these letters are enclosed for your inspection.

If Major Griffith follows Mr. Olsen's and my suggestions, Kansas and Indiana will receive 3,14 of \$3,511.27 or \$752.40. This makes a net income to Kansas from our three tournaments at Wichita, Oklahoma City and Kansas City of approximately \$2,700.

I am also sending you a financial report which was sent to Mr. Olsen. This shows that the tournaments in Kansas City, the Western and the National, which we supervised, made a net profit of \$9,628.70.

Dear Ole:

I had hoped that you and I could get together between now and one of the Thanksgivings, but I believe that is impossible so I will endeavor to put on paper what I discussed with you over the phone when I was in Chicago.

I dropped into Major Griffith's office and he asked me to the Wailing Wall Luncheon, which was Monday noon. He also asked me to come in and spend some time with him. Then he got out his papers and showed me he had money to the amount of \$8,269.11, and he wanted to know if I would tell him how the money should be distributed; that they were quite anxious that the money be sent to the colleges. He said if I would give his secretary the method of distribution, he would see that the money was sent out. He asked, "Or do you want to send it out?" I insisted that the checks should be written and disbursed by him. I suggested that they all be made out to the Athletic Association of the various schools and universities interested.

Then we tried to arrive at the amount. We deducted \$2500 from the \$8269.11, which left \$5769.11. Then we divided this \$5769.11 in half, giving the NCAA 50%; which left \$2884.56 for distribution in 14 parts. Indiana and Kansas to receive 3/14, Southern California and Duquesne to receive 2/14, and Colorado, Springfield, Massachuetts College, Rice Institute and Kentucky Teachers to receive 1/14.

Then I tried to figure out where the remaining money was and I figured that if you had \$9512.12 as shown on your report, that you had perhaps taken 10% of \$9512.12 and withheld that, which would be \$951.21. Deducting the 10% from \$9512.12 would leave a balance of \$8560.91. There would still be a discrepancy of \$291.80.

Your telephone message explained the situation to me. I went back to Major Griffith's secretary and stated that I thought it would be better if they could get the definite report from you, and of course, I realize that I was the very individual holding it up, but I was holding it up because I could not find this fellow Smith in his office. Tomorrow, Tuesday, I am going to go down to the City and make this settlement, then on Wednesday I will send you what remaining money there is with a check and a report.

Ole, here is what I frankly think. I believe if you and I could sit down with Major Griffith and tell him that the 10% cut and the 5 0% cut is too much, he made me definitely understand that they would make the adjustment in the way we feel would be just and honest. There are just a few men running the NCAA and I know the rest of them would go along. After our "Custer's Last Stand" in the

room with those NCAA people I was not going to rise and bicker over the 10%, but I know that we can get a fair settlement and it certainly is not right for them to take 10% first and then take 50%. I will not quarrel and it would have been out of place for any voice to have been raised at that meeting. But the fact that Major Griffith wrote you and stated that the findings were as those set forth in the letter; namely, that no hotel and traveling expenses would be allowed them, showed me conclusively that they were all mixed up.

Therefore, I think very definitely, befor this money is distributed that we should have a meeting and I am sure Major Griffith will go along with us because we have a set-up wherein we will make the NCAA a lot of money, if they do not "kill the goose that lays the golden egg."

Major Griffith said to me, "Phog, do you think the boys will be satisfied with such a settlement as this?" And the interesting part of it was, Ole, that he was not clear on the settlement and he continued, "Well, Phog, if they are not, you and Ole and Saint and some of us will get together and we will make it right." He stated that the difficulty with a lot of these fellows is that when they make money they want to spend it all. He spoke about Butch Cowell, who passed away last year. He stated that Butch was a good fellow but he was Chairman of the NCAA Boxing Committee and these members would want to have about three meetings a year and spend a lot of money while they were in session, but the meetings were too often and too expensive. I said, "Well, Major Griffith, that is not true in regard to our meetings." and he hastily agreed.

I told Major Griffith that we had been as conservative on our expenditures as if we had been handling University money, Itold him of some of the expenses that were too large and that we refused to approve them, and we made nobody angry. I mentioned the fact that I got letters from you and we presented them in such a way, without using the officers names, and we told them the Committee would not approve such expense accounts. I stated the business manager had perfect confidence in what we had done, and further that President Owens had attended the finals and complimented the Committee most highly in the collegiate atmosphere which the Tournament seemed to possess.

J just know, Ole, that inasmuch as the NCAA Executive Committee set-up is not clear and inasmuch as we are making an agreement to last for NCAA Basketball teams to follow, I still believe that we could benefit by meeting with Major Griffith and getting an agreement; namely, 50% of their net with the NCAA without this first 10% out.

Kansas is to play Loyola in Chicago on January 2. I am wondering if there is any way that we could meet with you and Major Griffith that date, or will he be back from the New York Meeting? Will you please find out and let me know? I imagine you will be busy but thought perhaps I would take a fling

at this. The only other alternative is a meeting before Christmas. Our Christmas recess begins on December 20, Would it be possible to meet you in Chicago and discuss with Major Griffith this problem about that time. I think it is very worthwhile, Ole, because what little we spend on a trip like that will be made back many fold to the teams in the prorations.

Please let me hear from you at your early convience.

Dear Ole:

I beg to accept receipt of your wire of the 18th instant reading as follows: "Please hurry final report if at all possible."

Ole, I want to assure you that I am even more anxious than you are to get this thing cleared up. I have called and endeavored to make appointments with Smith, the printer who printed our programs, and he has either been out of town or something has thwarted my move every time I have made an attempt to settle the bill. Frankly, I feel as if we are going to have bad luck on the proposition, but last week I got hold of his secretary and she stated he would be in town Tuesday morning, November 19. Therefore, as soon as my 10:30 class is over, I am leaving for Kansas City to keep this appointment.

We are not having any luck in our collections, so I am going to put in these bills as uncollectable, so far as my report is concerned. And tomorrow when I pay this fellow I will follow with a report on Wednesday and send you what money we have on hand and call the matter closed up.

If it had not been for this hang-nail, we would have closed the tournament business a long time ago and been rid of the very difficult situation. However, had we closed earlier than a month ago, we would have an old bill to settle to the Kansas City Journal. This is one of the newspapers that Bowles gave the advertising to and they charged it to him instead of to us. And then, not being able to cellect from him, they sent us the statement and wanted to know if there was any way they could collect the bill. This being the first that I had heard of it, I asked them to mail me the bill and I sent them a check. So I am sure now there are no outstanding bills. I believe if I were you I would try to hold back this whole amount for emergencies, but that is up to you.

I am so sorry, Ole, that my teaching schedule and my basketball practice have been such that it has ham-stringed me and prevented me from getting away any one full day in any week. I had October basketball practice due to the fact that I lost most of my regulars and I thought that I would start out on fundamentals and try to develop a bunch of youngsters into a

group of ball handlers. On Mondays, Wednesdays, and Fridays I have classes at 9:30 and 11:30. On Tuesdays and Thursdays I have a class at 9:30. Therefore, it made it very difficult for me to drive to Kansas City and get back in time for 3:30 basketball practice. Then, too, I had complete charge of the Community Chest drive of Lawrence so far as the entire University was concerned, and then we had a Y.M.C.A. drive on here and I was stuck with that. So I have been busier than the proverbial "one-armed paper hanger with the itch."

I guarantee that there will be no such hang-nails attached to the next tournament that I have anything to do with.

I have been doing a great deal of thinking since I have returned from Chicago where you were very kind to me in having me as your guest at the Walling Wall dinner, and also giving me audience which took from your busy administrative life many valuable moments.

When we had our conference regarding the income and disbursement of the National Collegiate Athletic Association basketball fund, you asked so this question: "Do you think all the boys will be satisfied with this distribution?" It would have been a long story and your time was too valuable at that moment for the explanation. However, I am writing you this letter in the hope that you can take it home where you can prop your feet up, rest in an easy chair, and read it, or part of it, and if it becomes too fatiguing or uninteresting, just drop it in the waste basket to your right.

May I give you a little history. In the beginning Harold Claen and John Bunn and I had many conferences. First, we were desirous of seeing that the N. C. A. A. had the finest and the best basketball teams under the finest, cleanest and most efficient suspices that would be possible. Frankly, the money consideration was not the primal consideration. Of course, we wanted to make money, but we did not want the promoters to take the ball away from us regarding our own collegiate attraction. We felt as if the colleges were the ones making the money and the control naturally should be under college administration. Knowing that the N. C. A. A. had always stood for this sort of administration, we were happy indeed to work definitely upon these lines.

After the first N. C. A. A. basketball tournament had lost \$2500 at San Francisco, Philadelphia and Chicago and your executive committee underwrote the loss, we felt responsibilities. It was up to all of us to not only replace that money, but to return a sizable sum in order to show the committee that we were appreciative as well as determined to reciprocate the confidence of the executive committee.

I said, "You give me this tournament in Kansas City and I will not only pay back the deficit, but we will make you some money." We then started definitely upon an aggressive program of retrenchment. First, we worked with the National Coaches Association to the point that one dollar out of each membership should go for a ticket at the final tournament. Inasmuch as each coach paid \$5.00, it was our feeling that \$1.00 going toward a \$1.60 ticket of admission would be a gesture that the coaches also wented this thing to succeed. Secondly, I made a deal with the Eunicipal

Auditorium whoreby we could not fail. I had a minimal charge of \$300 placed on the hall which was ridiculously low. If we made money, of course rental would increase with the size of the income. We arrenged then to take 20% not of the gate from the play-off of the district to go to the %. C. A. A. Although the M. C. A. A. was not guaranteeing any of the expenses, we were arranging to take 20% of the earnings. And in the Big Six play-off at Wichita we held out \$564 as 20% of this earning. In the Fifth District play-off between Oklahoma Aggies and Kansas at Oklahoma City we held out \$398 or 20%. That made \$662 which we had intentionally with-held so that this could be applied toward decreasing the \$2500 deficit.

I am showing you, Major Origith, that every account of ours was bent toward insuring the return of the money to the H. C. A. A., and further than that we desired to show to our competing conches who entered the tournment that we desired also to make a profit for their schools by their solivities. Just off the record, I wish to tell you that for several years we played Oklahoma A. and M. and that they have never been able to pay the full guarantee until long late in August, due to the fact that they always borrow money to belence their budget each year. This is true of almost every one of the schools in our district with the exception of Hebraelma Just as you stated is your editorisls and your comments that there are about 640 colleges in imerica playing football, but only about 80 are making any money out of ethictics. By motive has been to sweeten the pot enough for these teams to keep them interested and make them feel that through their setivity set only are the enjoying the pleasure of competition, but that they are getting a small remuneration which will help just a little toward reducing a budget that does not balance. Certainly our Dational Administration from a poort the same problem that almost all of our athletic administrations experience, that of a bedly impaired budget.

I remember distinctly John Bunn, Ole and I several years ago discussed that if and when we made money that we should recommend to the B. C. A. A. directors that we give 20% of the earnings to the N. C. A. A. It was at that time that Ole thought that this beaketball money could be earmarked "basketball" and that it could be used for expenses to send an American college team to the Olympic game.

It was always my idea and I also thought that it was the thought of our committee that these findings should be transmitted to the N. C. A. A. executive committee and some action taken. The fact that this was not done by your directors naturally left us in a very bad position because we could not go to our coaches with any definite information. Frankly, there was great dissatisfaction from the coaches because they said "We want to know what we are going to get." And I waen't in a position to tell them; this orested misunderstanding.

Major Griffith, these coaches are not chisslers. It is much easier for these fellows to close their season and cuit worrying about basketbell than for them to keep the team in training and face the criticism of certain faculty members who say that the season is elreedy too long and through this

promoters always offer such more in the way of lucrative expense accounts than our N. C. A. A. cosmittee offers. The professional promoters offer to pay expenses for 15 men and they will guarantee you a purse in addition to the guarantee. Very enticing. Therefore, I believe that if we are going to continue this tournament that we should not have to compete in dollars and cents with these fallows, but we must follow along the line of giving our teams enough money that it will be at least a friendly gesture in meeting the competition that the professionals are consistently offering.

In Chicago when our committee met with your group I was pained exceedingly to see your group ask for a 10% cut before all expenses were paid, and then a 50% cut of the total. Then track receives but 10% it seemed to se that if we could pay all expenses and then have the M. C. A. A. take 50% of the total profits and distribute 50% fourteen ways that this would be more than fair. I believe that everybody would be happy with such an arrangement. But the 50% was certainly more than any member of the Pegional Basketball Committee ever thought of.

I was not the one to say that the arrangement which your executive committee proposed was wrong because I did not want to argue any further. I wanted to counsel and mediate but we were in no position to do that because you had bigger business at hand. Then when you wrote Ole setting forth the findings of your committee, we found that that was not what was agreed upon in our meeting—some confusion somewhere. Therefore it seems to me that your group and our committee should mediate, because what was written to Ole was not what was agreed upon as it was read to St. Clair, Olsen and me. Ole sent me a carbon copy of your letter to him. I presume that he also sent St. Clair one.

In closing let me make myself plain. I will agree to do most anything for the good of the order. I also pladge my loyelty to the N. C. A. A.; however I can see no reason why we cannot continue with a fine tournament in which the N. C. A. A. can immediately count on a fine income and where the fourteen colleges participating will have at best a very small sum, but at least enough to make them happy. Therefore, I beg of you to see if it is not possible with some mediation to forget the original low discussed and to pay the railroad, pullman, hotel and meal expenses of all fourteen teams competing in their respective Eastern, western and National play-offs and then to divide a very handsome profit, box of the N. C. A. A., and box of the net to the fourteen teams split in the way that the committee suggests.

Dear Major:

I have just sent on to Jim St. Clair, Chairman of the National Collegiate Basketball Rules Committee, the final report for the 1940 N.C.A.A. Basketball Tournament. Jim will sign this report in accordance with N.C.A.A. regulations and will forward it on to you immediately, I am sure.

This report shows a net profit for the whole tournament business, i.e. Western and Eastern play-offs and Final Game, of \$9,522.55. I have already sent you \$8,000. Accordingly, I am sending you herewith another check for \$1,222.55. I feel that I should retain here in the Tournament checking account \$300 for the 1941 tournament promotion.

Now with respect to the division of this money. I gathered from "Phog" Allen's letter, after his conversation with you, that you had agreed that our method of procedure this season should be as follows: From the total net profit of the 1940 tournament should be deducted the 1939 deficit which the N.C.A.A. made good, i.e. \$9,522.55 minus \$2500 which leaves \$7,022.55. This amount should be divided in two parts— one half, \$3,511.27 to go to the N.C.A.A., the other half to be divided in accordance with the plan agreed upon among the competing teams of the 1940 tournament and to be handled as follows: \$3,511.27 divided into fourteen equal parts; Indiana and Kansas to receive three-fourteenths each, \$752.40; Southern California and Duquesne to receive two-fourteenths each, \$501.60; Colorado, Springfield (Mass.) College, Rice Institute and Kentucky (Western) State Teachers College one-fourteenth each, or \$250.80.

I am sure everybody on the committee is agreed that you as secretary and treasurer of the N.C.A.A. should write these checks and explain that this is their "cut" in the 1940 tournament in accordance with the action of the N.C.A.A. Executive Committee. I have no doubt that such a distribution to the competing schools will be very well received by them and that this action on the part of the N.C.A.A. will go a long way toward solidifying good feeling in respect to future tournaments.

Dr. Allen will forward direct to you all the data, cancelled checks, receipts, etc., supporting the report of the Western play-off and the Final Game, and I will send on to you shortly the data which I have as a basis for this final report.

Sometime ago you mentioned that you would like to have a statement of the results of the 1940 Tournament. There is a complete record of the Tournament in the 1940-41 edition of the Official Basketball Guide. It seems

that a copy of that on file would give you all the information you want in this connection.

I hope to see you even before you get this letter, but at any rate I am happy to be able to get the final report out of the way and into your hands.

On September 10 Major Griffith sent communication to Harold Olsen setting out the National Collegiate Athletic Association findings. On September 16 Mr. Olsen replied for the

committee. My letter to Mr. Olsen dated September 27 and Mr. J.W. St. Clair's letter dated September 30 will restate our position.

You will recall that Missouri, Oklahoma and Kansas made \$1,000 net after our expenses were paid in Wichita at the Big Six play-off. The Fifth District play-off between the Oklahoma Aggies and Kansas at Oklahoma City netted an additional \$1,000 to Oklahoma and Kansas each, after expenses were paid. The crux of the whole thing is that the N.C.A.A. Executive Committee is taking the financial plum from the gate receipts when the great crowds assembled in Kansas City for the Western and the National play-offs.

This report is merely for your information and your office records. The early material enclosed is to show you the metamorphosis of the tournament.

Gentlemen:

The N.C.A.A. Basketball Rules Committee and the N.C.A.A. Tournament Committee, desire to make the following report on the 1940 N.C.A.A. Basketball Tournament, together with some recommendations as to the conduct of future tournaments.

Item 1 - The financial report of the 1940 Tournament (see attached report)

### \* 2 - Recommendations:

- An eastern play-off between teams representing Districts 1, 2, 3 and 4, and a western play-off between teams representing Districts 5, 6, 7 and 8 be held on March . That the Western play-off be held at Kansas City and the eastern play-off at a place to be designated by the Tournament committee. That a final game between the winners of the eastern and western play-offs be held at Kansas City on March to determine the N.C.A.A. Basketball Championship.
- 2. That teams to represent each district be selected by Selection Committees. Selection to be made whenever possible on the basis of the season's record rather than by play-offs. Whenever play-offs within a district become necessary to determine district representative the N.C.A.A. assumes no financial responsibility, and receives no share of the receipts from such a play-off.
- S. That competing teams be allowed expenses for a total party of 15 men, to eastern and Western play-offs and to the final game.
- 4. That not proceeds of N.C.A.A. Tournaments after all expenses (including team expenses) are paid, be divided as follows: 25% to the N.C.A.A., 75% to the competing teams on the following basis: Such amount as constitutes the 75% shall be divided into fourteen equal parts, one part going to each of the eight competing teams and an additional one part to each of the four semi-finalists and an additional one part to each of the finalists.
- 5. That the net proceeds of the 1940 tournament be distributed as follows: 25% to the N.C.A.A., \$2500.00 to the N.C.A.A. to repay deficit of the 1939 tournament. Remainder to be distributed among competing teams in accordance with the method of distribution outlined above in recommendation number four.
- G. That the N.C.A.A. encourage and subsidize out of basketball receipts worthwhile basketball research problems worked out by the National Association of Basketball Coaches.

The committee feels that the Tournament set-up as above outlined provides the following benefits:

l. Will oreate a greater interest in collegiate basketball by enlisting more representative teams from all the districts.

2. Will make for greater cohesion of the eight collegiate districts.

3. Will serve as a definite source of financial income to the N.C.A.A.
4. Offers the means by which this tournament can be developed into the outstanding basketball event in the nation.
