LAWRENCE COMMUNITY CHEST

13 September 1944

Mr. Eby called the meeting to order; the minutes were read, and there being no objections thereto, they were approved as read.

Mr. Woestemeyer moved, seconded by Mrs. Deal Six that the Audit Report prepared by George M. Clem, dated June 9, 1944, be approved, and that the question of considering cancelled the old outstanding checks totaling \$6.75 be left up to the Finance Committee and that whatever action they take on it be accepted by the Board. This motion carried unanimously.

President Eby next presented for the consideration and discussion of the Board, the Minutes of the Budget Committee dated 7 September 1944, copy of which is attached and made a part hereof the same as tho copied herein in full.

Rev. Aszman suggested that in listing the allotments for approval some distinction should be made between the Community Service League and the regular Community Chest payments. Mr. Woestemeyer suggested that an asterisk be placed by any allotments made the Community Service League and a note to the effect that this allotment was made from funds furnished by the National War Fund and not from the Community Chest funds. There was general agreement on this suggestion.

After a general discussion of all items covered in the Budget Committee's Minutes, Rev. Aszman moved to accept the report in toto of the Budget Committee. This motion was seconded by Miss Carpenter and carried unanimously.

Mr. Lowman moved that the Chairman of the Board of Directors of the Community Chest and the Chairman of the Budget Committee and any other Board Members they may desire, act as a committee to contact the proper taxing agent to have included in their budget the \$1200.00 needed by the Lawrence Recreational Council. This motion was seconded by Mrs. Six and carried unanimously.

President Eby, reporting on the question of auditing the books of member agencies, stated that a Committee consisting of Ruben Fox, Warren Decker and George Clem had been appointed with the understanding that Mr. Clem was to do any work that was necessary and that he was to be paid for it.

Mr. J. H. Parsons, Chairman of the Lawrence Community Chest War Fund Drive, attended the meeting as a guest of the Board and gave a brief report on the organization of the campaign to date.

Mrs. Six, seconded by Miss Carpenter, moved to adjourn - carried.

The meeting was called to order by Mr. Fox and the first order of business being a letter from A. E. Woestemeyer of the Community Service League requesting the allocation of \$200.00, same being the balance of the \$3000.00 retained for their use from the National War Fund. It was requested that this \$200.00 be allocated \$100.00 for October and \$100.00 for November. On motion by Mr. Decker, seconded by Mr. Whipple, it was voted to recommend approval of this allocation to the Board of Directors.

The next order of business was the October and November allotments as follows:

On motion of Mr. Whipple, seconded by Mr. Brinkman, the allotments as listed above were approved for recommendation to the Board.

There being a balance unallocated of \$520.90, on motion of Mr. Whipple, seconded by Mr. Jones, it was voted to recommend the allocation of \$364.63 to the National War Fund and \$156.27 to the Community Chest.

The next order of business being the consideration of the following applications as member agencies of the Community Chest:

Minutes, Budget Committee, Community Chest, 9-7-44, 7:30 P.M.

After much discussion, especially of the \$300.00 increase over last year of the Y.W.C.A., Dean Jones moved to recommend to the Board that each of the groups listed be allotted the same as last year with the exception of the Salvation Army, and that their 1944-45 allocation be approved as requested. Mr. Whipple seconded this motion and it carried making the allocations for the coming year as listed below:

It was further resolved that Mr. Hedrick and Mr. Fox take up with the President of the chest the question of advising the Y.W.C.A. of the refusal of their increase in allotment.

The next question was the \$1200.00 requested by the Lawrence Recreational Council. After discussion, Mr. Whipple moved that the Committee recommend to the Chest that the \$1200.00 be placed in the budget as part of the community activity for this year with the understanding that this committee thinks this activity a proper function of some taxing unit and not a proper activity to be included in the community activity funds, and that other arrangements should be made after this year. This motion was seconded by Dean Jones and carried.

The Committee then next approved the following items in the budget:

Total	<u>\$1500.00</u>

On motion by Mr. Whipple, seconded by Mr. Brinkman the \$1500.00 itemized above was approved to be recommended to the Board. It was suggested that campaign costs and administration be combined making a total sum of \$1100.00, and shown as one item on the printed folder.

The next order of business was the disposition of the \$3,873.03 surplus left in the 1943-44 funds. Dean Jones moved that \$2000.00 be placed in the reserve fund and the balance be carried as a credit in computing the 1944-45 funds to be raised. This motion was seconded by Mr. Decker and carried.

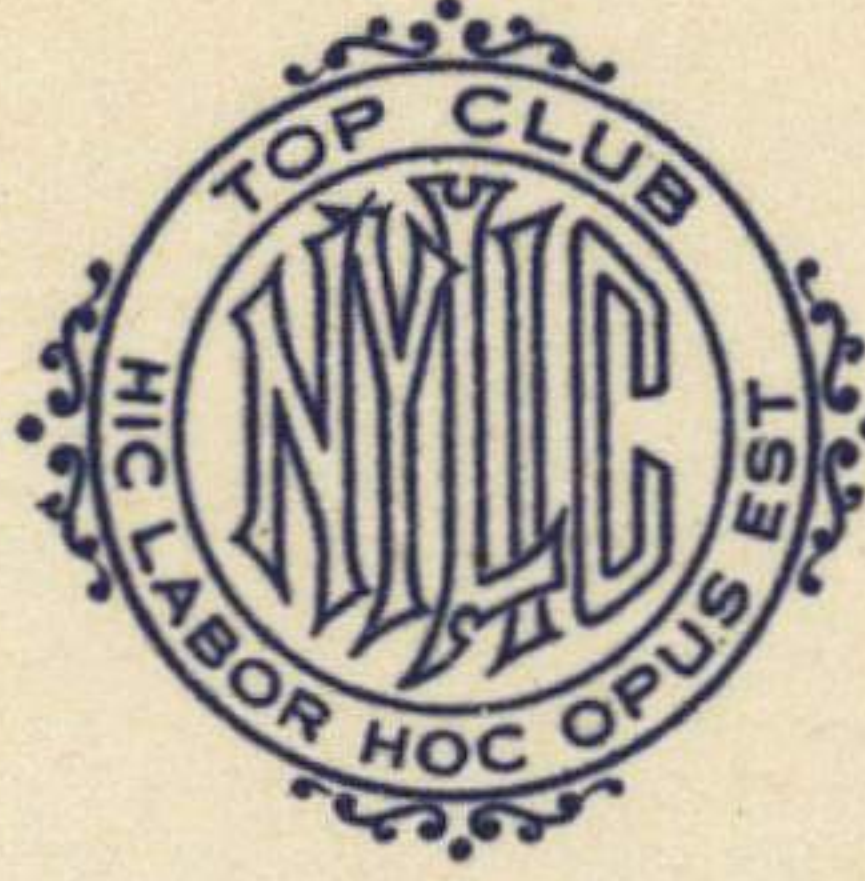
Thanks for your kindness in mailing me a check for my trip to Topeka. I assure you this exceeded the automobile travel expense, but I thank you for it.


Dear Dr. Allen:



The meeting was called to order by Mr. Eby who stated that the chief reason the meeting was called has to do with that section of the By-Laws which calls for an audit of the accounts of each member agency. Mr. Eby read Section 5 of Article X, Member Agency Agreements, which is as follows: "Each member agency shall have its accounts audited annually by an independent auditing committee appointed by the president of the Chest, and shall file a copy of such audit statement with the Community Chest. The Board may hire a competent accountant, or committee of accountants, to perform the above services."

After general discussion, Mr. Woestemeyer moved that the Budget Committee of the Community Chest act as an auditing committee to check up on the audits the member agencies has had, and if they had none to see about getting their books audited. Motion was seconded by Mrs. Deal Six.

Mr. Eby called for a discussion of the above motion and Mr. Lowman suggested a substitute motion to the effect that the President, Mr. Eby appoint an auditing committee smaller than the Budget Committee, and that the amount of money, if any, to be spent to comply with this section of the by-laws be left to the discretion of the President. Substitute motion seconded by Mrs. Six. A vote on the substitute motion called by Mr. Eby approved same unanimously.

Mr. Fox moved that we combine the National War Fund drive and the Community Chest. Mr. Penny seconded the motion and it carried unanimously.

There being no further business, Mr. Fox moved to adjourn, seconded by Mr. Penny. Carried.

Dear Mr. Crawford:

I am leaving for Wichita this evening, but will give you a hasty reply to your letter of November 12 asking for basketball information.

1. I am enclosing a copy of our 1944-45 schedule as it is at the present time.

2. The 1943-44 schedule is also enclosed, with scores of the games played.

3. We have only one returning regular letterman - Charlie Moffett, and he is at present a halfback on the football team. Others returning from last year are Dean Corder, Don Diehl, Louis Goehring, and Kirk Scott. All of these were substitutes, and did not see much action. Scott was restricted by Navy regulations about the first of January.

4. The following of last year's lettermen have been transferred to other Navy V-12 units: McSpadden, Barrington, Sherwood, Turner, Frank. Stucker and Malott have entered the armed services. Lindquist (4F) is doing war defense work in Kansas City, and Dick is doing graduate work at K.U.

5. I am beginning my 27th consecutive year as basketball coach at the University of Kansas.

6. Missouri, with five lettermen, looks like the leader in the Big Six Conference, with Oklahoma next. Little is known about Iowa State, but they have a big Navy contingent there and they have been up in all their competitive sports. The unknowns are Nebraska, Kansas State and Kansas.


