Dear Mr. Allen:

The fifth annual College All-Star Basketball Game will be held at the Chicago Stadium on Friday, December 1, 1944. Fort Wayne, Indiana, winners of the world's championship tournament held at Chicago last March, will be the opposition of the All-Star selections; and indications are that the usual record interest and attendance will be maintained.

As you will no doubt recall, you and the other members of the All-America Basketball Board who have nominated and elected the All-Stars each year, have done your job so well that the All-Stars have in the past four seasons defeated the world's champions.

This year your task is again difficult, and we shall re-employ the method which was used with such marked success last season. You will be permitted to select not only last year's college graduates, but any man currently attending school who deserves selection as an All-Star, except that any player who appeared in any of the previous four All-Star games will not be eligible for selection again. The fact that practically all of the basketball players deserving of consideration are either in the armed forces or are taking special courses at college makes this method the most expedient.

We are going to find it necessary to make a direct approach to the player immediately after selection in an effort to secure necessary furlough or leave. Hence, this original letter will be your only vote on the selections.

We are enclosing herewith a list of players who have thus far received nomination and will ask you to kindly check off fifteen of those whom you would care to select. We suggest that you number them one to fifteen in the order of your preference. Feel free, please, to add any names to this list who have not already been nominated; and when adding names, please advise, if possible, school and where said player may be reached.

I know this is going to take a few moments of your time, but feel certain that we may count upon you for the same interest and cooperation that you have shown in the past.


Dear Dr. Allen:


Dear Dr. Allen:

Dear Mr. Cahill:

I beg your pardon, sir, for not answering your letter which you wrote from the Elks Club on June 22nd.

The Big Six Conference would declare a student ineligible if he signs a professional baseball contract in organized baseball. I am not discussing the merits of the case, but all the organized conferences like the Big Six, Missouri Valley, Big Ten, Pacific Coast, and so forth, declare a boy ineligible when he signs a contract in organized baseball. I appreciate the fact that there are no amateur organizations at the present time that give a boy an opportunity for continuing his play, but this of course is due to the war.

These colleges are not against professional baseball, but they are trying to keep the skills of the participants somewhere nearly equal. I do not justify the rules as they are now written because there are more college athletes disregarding the so-called amateur rule than there are following it, but the rule does still obtain against organized baseball or professional football or any other organized professional sport.

Dear Dr. Allen:

We are about to make an effort to find and do something about cases of Tuberculosis in this region. In a way you are now representing Rotary Club

and I am asking you to assist in this case finding survey.

How? When? What is it all about? This way: The Douglas County Medical Society, the Tuberculosis and Health Association, The State Board of Health, the Kansas Medical Society, and the United States Public Health Service are working together in this effort. The thing itself is an attempt to X-Ray as many chests of Douglas County people as possible. The general plan is to have the X-Ray apparatus set up in the Lawrence Community Building and work there May 25 through June 1, except Sunday and Decoration Day. Then set up in Eudora for June 2, and in Baldwin City for June 3.

Some details are that the hours offered will be 10:00 to 12:00, 1:00 to 5:00 and 7:00 to 9:00, the time units will be quarter hours, so far as convenient, groups should have relatively definite appointments, we can do only about 25 in each 15 minute period so if your group has many more than that in it, you should ask for more than one period. For instance, if you are a service club group, a double period, say 7:30 to 8:00 in one of the evening sessions, might fit you. However, there will be time for all without very long waiting whether you have appointments or not.

Please telephone # 462 (or write to the Health Unit) and give your 1st, 2nd, and 3rd choices for time appointments.

Thank you very much for any information or advise that you may send me. I'll appreciate it very much.

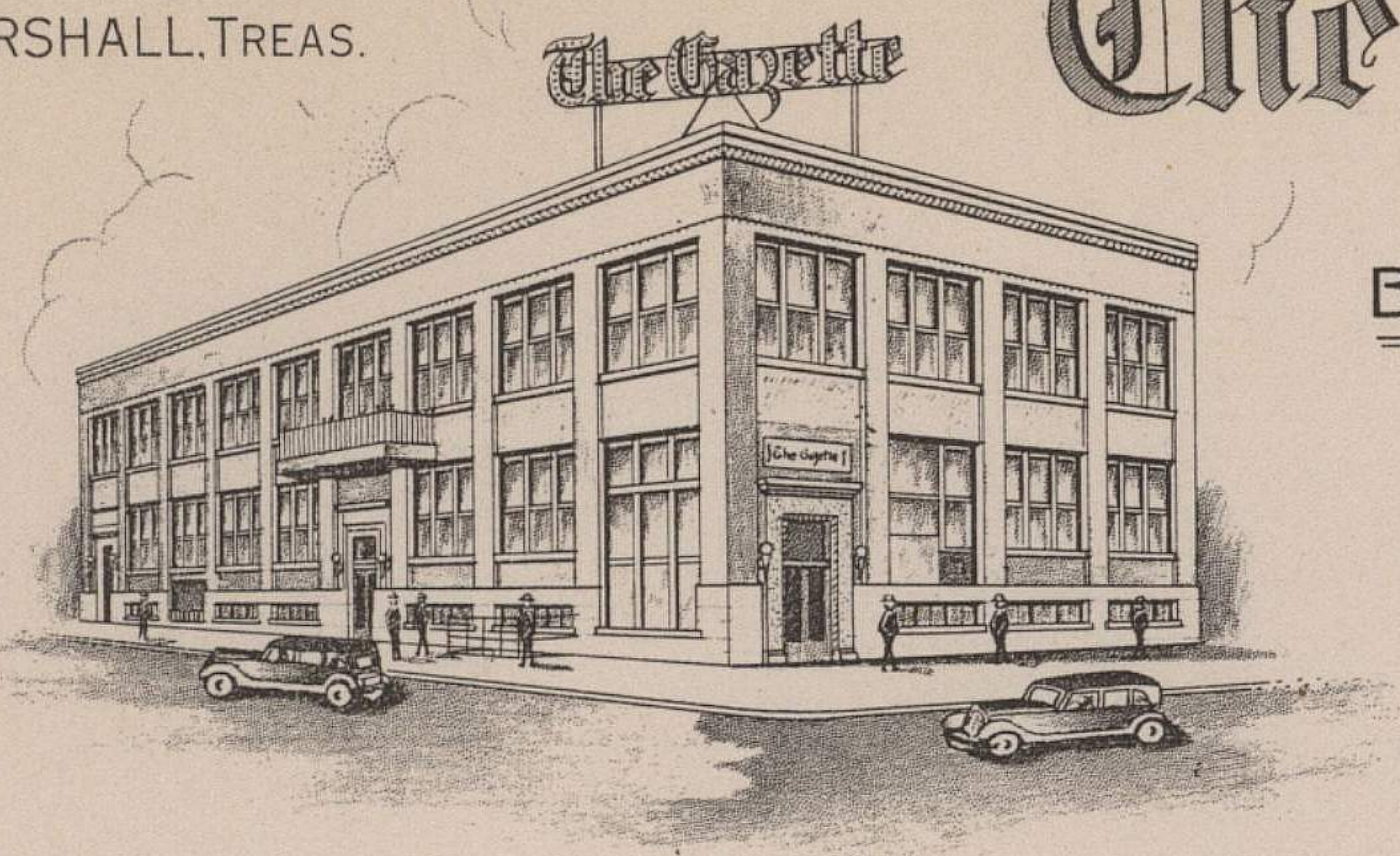

Dear Bob:

I regret that I have not answered your communication sooner. I have been busy with war work, and am at present serving as secretary of our county Selective Service Board. I have just finished our county Red Cross War Fund drive, and have also served the University as chairman of the Third and Fourth War Loan, Community Chest, and Infantile Paralysis drives. This, together with my work as chairman of the Department of Physical Education where we are conditioning V-5, V-12 and ASTP units, added to my basketball coaching this past winter, have kept me busy.

Basketball, along with all intercollegiate sports, has suffered much. Naturally her outstanding material has gone to the war effort, as it should. However, the placing of extremely tall boys in the 4F classification has done more to overbalance basketball than has any other factor affected any of the other sports.

Since each player is entitled to his own position on the floor, the altitudinous player has enjoyed an extreme advantage in war time. The able-bodied and physically fit men of shorter stature than six feet six inches have been drained into the war effort. Therefore, the war has given the gargantuan player in height a most undue advantage. The fact that the basket is but ten feet from the floor enables these seven foot boys to actually reach into the basket. In peace times the especially rugged and aggressive boys would be in the game ready to contest these super-super tall chaps. Therefore, of all times the present gives the mezzanine-peeping jumper in basketball an advantage that he would never enjoy in peace time.

It has always been my conviction, even during the time of the center jump, that the tall player's advantage was under the defensive and the offensive basket. The advocates of the elimination of the center jump said - Eliminate the center jump and you will run the ungainly, tall player out of the game. I have always maintained that there was one way to equitably settle the matter, and that was to raise the basket. The basketball rules committee did a lot of shadow boxing this year in regard to the tall player. A few coaches, selfishly inclined, pressured the rules committee to do something about the tall player on the defense. Therefore, they caused



to be legislated a discriminatory rule against the defense while permitting the offensive player full freedom of action in dunking the ball in the basket and tipping the ball into the basket while it was resting on the basket. Yet they made a silly rule regarding goal tending.

I am submitting herewith some of my criticisms that you are at perfect liberty to print if you wish.


