Thank you, "Clingie", for your good letter as of March 3. The Nebraska game was a corker and we were more than delighted in our ability to whip them. They were a tough crew and the crowd was rougher than pig iron.

Yes, it has been a great pleasure to have Bob on our team. He has been a fine student and an exemplary chap, both in the home and on the athletic field, and he has been what we call a clean player. He has been a great source of pleasure.

I also thank you for your angle on the increased number of basketball players on the court. I would go along with your idea of removing the fouling player from the game for a period of one minute. You know that is the way basketball started. But, Clingie, the greatest benefit to the game would be to raise that basket two feet. You would practically cut out the two foul shots because there would be no great urge to drive into the basket for a lay-up.

You would reduce the number of fouls to nearly one-half, and instead of ganging in and crashing under the basket, the play would be to pass out for shots fifteen feet from the basket rather than under it. And the tall player would lose his importance tremendously because many of these gangling fellows would be forced to shoot the same as the rest of the players do who are not so tall. His marksmanship would not be comparable to the well-knit, well-coordinated versatile athlete who accommodates his muscles of his eyes to height the same as he does to distance. If you will raise the basket two feet and scrimmage a few times, I am sure that you will be sold on that change more than any other.

Again thanking you for your kind words and wishing to be remembered to your good wife and your splendid family, and with one other fond wish; that you have more than one of your four sons who will be a stand-out in games in which you stood out so prominently, I am,

My dear "Phog":

Congratulations on your game Saturday night at Lincoln. It must have been a thriller. We enjoyed the Mo.-KU game the other night and without question the better team won. We were agreed that we have seen better Kansas teams but that is as it should be. Your son, Bobby, was the standout in both defensive and offensive play. I know it makes you feel proud to have a son that can both interpret and execute your coaching. I have four sons and out of that number I may get one athlete. I hope so at least.

I read with interest, a few weeks ago, your suggestion that the number of players in a basketball game be increased. I am in happy accord with you on this, even without enlarging the court. Since but one-half of the court is used now except for the ten second period, why not increase the number of players to, say eight, no more than five(5) of whom can be in any one-half of court but have the privilege of interchange. Hockey rules might be invoked so that in case of fouls where free throws are allowed, remove the fouling player from the game for a period. If a foul involved but one shot, remove player for one minute. If it were a two shot foul, remove him for two minutes. This would unquestionably slow the game down and be less exacting on players.

I think with you that a game as popular as basketball should be played with a larger number -- the Arkansas U. coach's opinion not withstanding. I'm sure the game can be improved and I think your suggestion a good one.
