Let me take this opportunity of congratulating you upon staging such a successful final game, financially and otherwise. Everett Dean, Branch McCracken and Ralph Graham, all three, told me that from reports they heard around Kansas City you could have sold two or three times as many tickets as were sold if it would have been possible to get them in the auditorium. You proved that there is no place up to the present at least that can equal Kansas City in backing such a tournament as you had the week preceding the final game and the final game itself. I read in the papers that the finals are again to be held at Kansas City. If this report is correct, I assure you that Ole Olson and you certainly reached the decision.

I will ask our ticket man to forward a report to you at once. For your information wish to say that ten tickets were sold here and the other forty were turned in by Ralph Graham ~~is~~ to our good old friend Ernest Quigley on Saturday morning.

Coach McCracken and all the members of our team were delighted with the reception and treatment that they received while in Kansas City. Mac told me that the game was very clean, that the fouls committed were all made in the heat of such a terrifically fast and exciting game. He said that your boys were very fine sportsmen and played an excellent clean game of basketball. Of course, you know that we are more than delighted with the outcome of the game and the performance our boys gave. At the same time, I realize that the result was most disappointing to you, but on the other hand I am sure you have satisfaction in knowing that your boys did put up an excellent and sportsmanlike game, and that you yourself conducted the most outstanding tournament that the National Collegiate has ever held.

Dear Clev:

Thank you for your good letter of April 2nd. The game was all that any sportsman would want it to be. Indiana was phenomenal and convincing that night. It is not taking a thing away from any team to say that Indiana could have given any team in the nation a marvelous game, and my bet is they could have beaten any team that I have seen in action in a good while.

Indiana had reached the peak psychologically, and they were ideal from a coaching standpoint. Their fundamentals were perfect and their timing was par excellence. I congratulate you in having such a fine man as Branch McCracken to handle a great group of Indiana ball-hustling specialists. And they were specialists because they did everything right.

The thing that I liked about our boys' play was that after they were beaten badly they stayed in there and scrapped and did not resort to the alibi type of playing by making fouls at every opportunity. They still played ball. We have glory enough in reaching the finals and playing against a fine team like Indiana. We made about 18% of our shots and Indiana made 30-odd per cent. That is the story.

Floyd Rowe, president of the Rules Committee, and assistant superintendent of schools at Cleveland, Ohio, charted the game from his angle and it showed that Kansas had possession of the ball longer periods of time than Indiana. This was during the entire game, yet there was no question about the outcome after the last six minutes of the first half.

Thank you, Clev, for your kind wishes regarding the conduct of the tournament. We were happy about it. We did work hard because we felt we had the support of Kansas City in a splendid tournament where topflight teams represented the National Collegiate.

I am going to leave this note in your mail box at the hotel, so that if I don't get to see you during this busy week, you will receive the information. Nevertheless, I do hope to see you.

There are two sets of Olympic film. The Central A.A.U. office at 39 So. LaSalle Street has the film of the Olympic Games held in Germany. The rental charge is \$10.00 plus transportation. Arrangements for rental can be made through Miss Vivian Stingley. The telephone number is State 4229, in case you want to call her.

On the other hand, Mr. Brown may have mentioned to you the Track and Field film which we have on hand in our own department. These pictures were taken at the Olympic Trials at Randall Island just prior to the Olympic Games.

If the Athletic Department wishes to purchase them, they are available at \$25.00 per four hundred foot reel. These film are in slow motion. They include action shots, posed to show form and action in different events, and also scenes of the actual competition in the Olympic Trials.

Should you have time while here in Chicago, I can make arrangements to have the films we have shown to you at our Administration Building, at the north end of Soldier Field. Should you care to do that, if you don't reach me at the hotel, you can call my secretary at Harrison 5252, extension 426, and she will know how to get in touch with me and I will complete the arrangements.


