Lawrence is overflowing with veterans and it is estimates that there will be 800 veterans who will come to the University for their first time on February 11, the date of the second semester. Dean J. O. Jones is the dean of the Graduate School so I would suggest that your son-in-law write Dean Jones for it. I would also suggest that his high school transcript be mailed in early so that that can be properly taken care of.

I am sure that your daughter, Patty, will not have much difficulty obtaining a stenographic position. The fact that she rates under the Civil Service and works in the O.P.A. office in Cheyenne will insure her a position, I am sure.

I suggest that your son-in-law also write to Dr. Lawrence Woodruff, the Registrar of the University, telling Dr. Woodruff that he is coming to town and that he would like an apartment. The veterans have been renting the apartments of the Sunflower Village. This is out between Eudora and DeSoto and they are lovely apartments. 

Since then I have been to a lot of places, like most servicemen, including Canada, Alaska, the Aleutians, Russia and Korea. During all my travels the I never forgot K.U. and the happy days I spent there.

I never have met another former Jayhawker while I've been in the Infantry (Airborne) but I do remember meeting one or two fellows when I was in the Air Force who had been students at Lawrence. I also remember a B-24 bomber which had the name "Jayhawker" painted on it. It was shot down a few days before the war ended but it had a record of twenty-three missions and seven Jap planes to its credit. I later learned that the pilot was a former Kansas student.

I've always made it a point to keep up with Kansas in the sporting world. It's always a pleasure to hear some boys from the east start talking about their great basketball teams. December 6, 1945 Mr. R. L. Dennen, Superintendent Colby Public Schools Colby, Lansas Dear Superintendent Dennen: I am sorry indeed that I failed to answer your letter sooner. It was just one of those things I didn't get around to early enough. We use powder in boxes and it is much superior to liquid. We have been using it in boxes now for two years and we would not think of going back to the solution. The powder aids in drying their feet, but, of course, the feet should be thoroughly dry before the boy uses the powder box. The Cramer Chemical Company handles the powder and I think it is quite reasonable because of the high efficiency that is had by the use of the powder. I happen to be president of the Lawrence Country Club and we are using the powder out there also. We are utilizing the rubber bath tub that we used the liquid in. However, I think that at least a pine box six inches high and three feet square would be much better and to avoid any splinters on the bottom we use a composition paper bottom. You know what I mean, the heavy wallpaper board about three inches to 5/8 of an inch deep and we nail it to the wood and use it as the bottom of the box. I believe you will see the efficacy of this type of box. Since it rests on the floor and has no hard usage, we have had no difficulty with it. 




