

Dear Dean Schwegler:

I am sorry that I was forced to leave the Senate meeting yesterday afternoon. I had my boys on the floor in varsity basketball practice and it was necessary for me to return to them. I slipped over for the action on the Equitation courses, and as soon as that was over I returned to my boys.

I am sorry that I was not present to aid in what discussion was necessary in regard to the Committee on Physical Welfare and Recreation. Dr. Elbel came in and explained to Mrs. Hulteen the discussion that took place after my leaving. It was his feeling that the Senate wanted to combine the two committees, the Athletic Committee and the Committee on Physical Welfare and Recreation.

I just had an opportunity to talk to Dr. Kester over the phone regarding my application to him as chairman of the Senate Advisory Committee regarding the course in Equitation, and in discussing with him the matter of the two committees I explain to him that the Board of Regents had stated that no coach could be a member of the Athletic Committee and that of course precluded my name from being on that committee, if they had one Athletic Committee. However, the Board rescinded that rule when they put Mr. Gwinn Henry back on the Athletic Committee.

I would feel much embarrassed to be on that committee at the present time with the present Board of Regents. For that reason I am hoping, as I told Dr. Kester, that they will not combine those committees because I am much interested in being on the Committee on Physical Welfare and Recreation. But I am adverse to being a member of the athletic board. For that reason I trust they will keep them separate.

I am merely explaining these points to you so that you will understand my reaction. I am hoping that we can go forward with the Physical Welfare and Recreation Committee in a way that will be a positive benefit to the student body and the University as a whole.

The Committee on the Administration of the University Teachers' Diploma sympathetically considered both of your letters of recommendation but felt that in view of the fact that it was rigidly insisting on the scholastic requirements in all other departments common fairness demanded that the same standards be asked for in physical education which are currently observed by other departments of the University.

I am sending you a formal request in regard to our course in Tests and Measurements, and this letter is being sent as an explanation •

I had a conference with Dean Stouffer yesterday afternoon, and he has approved our recommendation that #176 be substituted in our schedule for #74 to accommodate our graduate students. We are hoping that we can make this arrangement in time for enrollment this fall.

Here is the problem that brought the matter to our attention: Frank Anneberg, who desires to take his Master's degree this year, would have so many hours of "Special Problems" on his transcript in order to get the required amount of graduate work, that we felt it best to arrange for at least another course that he could take.

During the summer I had planmed to meet with Dr. Elbel and make definite plans for enlarging our graduate program, but, as you know, Dr. Elbel became ill and it was impossible for us to work out our plans. We have too few courses for graduate credit, particularly for our undergraduate majors, and it seems imperative that we make progress on this situation very soon.

This is merely a progress report, and I shall be glad to talk with you more fully at your convenience.
