

My dear Dr. Allen:

There appears to be some misunderstanding with reference to enrollments in Physical Education course 35, Football, and Education course M194, Content and Methods of Physical Education.

In connection with both of these courses there are certain prerequisites which are explicitly stated in the catalog. For instance, your course 35 is open to sophomores only, and M194 has as a prerequisite the Fundamentals courses in Education.

It may be that on your course 35 you wish to change the prerequisites. In that case, the matter should be presented to the committee on curriculum and be duly acted on by the faculty. If no change is formally made, we must require the prerequisites as they are lawfully established. If we do not do so, we find ourselves here in the office in an impossible situation.

Certain snarls have arisen in connection with current enrollments. These difficulties ought to be taken up and adjusted at once. May we count on your assistance?

Catalog copy for the next issue is now being worked over. If any changes are made by the faculty these changes can be incorporated in the new publication.

I should be greatly pleased if you would give these matters your early attention, and I shall, of course, be very happy to cooperate with you in unraveling the complications. Will you not plan to come over to see me concerning these matters as soon as you can?

Wish to acknowledge receipt of your recent wire. You said answer by Western Union, but did not say wire collect, therefore I did not feel able financially to do it at my own expense. I was unable to report for class Friday as you suggested.

Since my salary there has been reduced materially, I thought maybe you might be willing to carry me on the pay roll during the coming school year. I think there are a few that have been carried on the pay roll one way or the other. If a deal of this nature can be arranged, it would be a great help to me in getting adjusted elsewhere.

Before I resign formally, there is a matter I would like to have brought to the attention of the University. I came to Kansas University in the fall of 1925 at a salary of \$2200 for twelve months. The fiscal year on the contract reads from September 1925. July 1st 1926 the contract was changed to read fiscal year from July 1st.

This case carries the same status as that of Cappon, Steele, Lockabaugh and Sabe. According to my addition I have \$366.66 due me from the University of Kansas. What do you intend to do about it?

Dear Dean Schwegler:

I have just had a letter from Hale B. Blair of Ottawa, Kansas, regarding his son Don. I called Hr. Blair on the phone at Ottawa and had quite a long conversation with him.

Mr. Blair states that after a conference with you that you permitted Don to enroll in three hours of Algebra and five hours of English History. He now does not desire to take English History but did go over and enroll in a course in Football, which is a sophomore course.

I called Miss Rich and she was over at the Institute meeting in Clathe with Miss Litchen, but upon her return I got in touch with her and I find that you have written denying the right of Don Blair to take the course in Football because he is a few hours shy of his sophomore standing requirements. Don Blair played football four years in high school in Clathe, and three years of basketball, and it is my frank opinion that the reason the Blairs switched from English History to football was because they desired that Don use the two-hour course for his eligibility rather than for the academic credit he might get, and naturally, it was easier, having had a lot of football, to work on the Football course than on English History.

I recognize that Football is a sophomore course and Don does not have enough hours to rate him a sophomore. However, the fact that he is enrolled in Football at the present time, has done several lessons in it, I can see the channel of thinking that the Blairs employ. I can easily see that if they could reason that if you permitted him to take the three and five hour courses that he had a perfect right to take a two-hour course, because it was in correspondence study. For that reason I can see a very definite point in their favor. If you would ask the Head of the Department of Physical Education, I would unquestionably recommend that Don Blair be permitted to continue this course inasmuch as he has already started it and I honestly believe there was no thought or desire on his part to evade or to break any rule. By permitting him to take this for eligibility and not for academic credit we have injured neither the University, the School of Education, or the Department of Physical Education.

permits the boys to take a Pootball or Basketball course with the thought that they are to use it for athletic credit and not for academic credit that he has done no one any harm. I can see no difference to this boy taking it for eligibility and some other boy over the State of Kansas enrolling and taking it just for the pleasure that he can get out of the course. Don Blair's reward for doing this work for the Extension Division is to have two hours of credit that he can apply toward his eligibility.

The fact that the Missouri Valley Conference Big-Six requires 27 hours of a boy is a conference requirement. They state emphatically in that conference that a boy may take work towards eligibility that may not be applied as credit toward his Bachelor Degree, so there was no thought in the mind of the boy to do anything underhand or secretive. Many educators feel that 27 hours required of the two semester by the Eligibility Committee is too much. There is a sharp difference of opinion, but the rule helds and we must observe it.

I have heard you say often that, why not give the boy a chance when he fails because the only thing that a boy may do is wear off some of the varnish from the seats or absorb a few molecules of heat. Now I am in exactly the same position in appealing for this boy. He is doing some manual labor in addition to his courses and trying to fit himself to meet the needs of the conference without violating any rules. The fact that this course is in the School of Education curriculum, to my way of thinking, does not proclude him from taking this source for no academic oredit but for athletic credit. The athletic rules are barred to his playing unless he gets enough hours for athletic credit required by the conference.

I would respectfully petition that the two-hour course in Football be permitted Don Blair for his athletic credit.

Dear Dean Schwegler:

It has come to my attention that George Stapleton is in need of course #200. Theory and Practice of Athletic Training, to complete his requirements for graduation.

You will recall that we sent an inquiry to the principals and to the coaches of basketball asking their preference on the courses to be offered - either Theory and Practice of Athletic Training, or Advanced Basketball. For a time the choice was about equal, but after our games with Oklahoma, Oklahoma A. & M., Rice, University of Southern California, and Indiana, the preference shot markedly toward Advanced Basketball. And too, I think it well that we drop this course for one summer, perhaps, in favor of Advanced Basketball, and next year the swing will definitely be for the Theory and Practice of Athletic Training.

Referring again to the George Stapleton situation, I would be willing that he take Advanced Basketball to fill his requirement. During the time that I will be offering this course I believe that I would be safe in saying that there will be over fifty cases of basketball injuries that will be offered to me. Coaches enrolled in this course will have high school boys with injuries and they invariably ask that these boys be permitted to come to lawrence for examination. I do much outside class work of this sort and I would be willing to give George Stapleton extra work along this line so that he could satisfy his requirements. George has been in athletic competition a great number of years and this experience in this sport would help him appreciate the work. If agreeable to you I will be glad to make arrangements to work along this line to satisfy his requirements.

#### REQUIREMENTS FOR THE UNIVERSITY TEACHER'S DIPLOMA

#### I. GENERAL TRAINING:

The requirements for a degree from the School of Education, the College, the School of Business, the School of Engineering, or the Graduate School.

The average scholarship level must be not less than 1.1 grade points; the level of the work done in the major subject must be at least 1.5 grade points, and credit for not less than 124 hours of work must be submitted.

II. SELECTED COLLEGE COURSES (for freshmen and sophomores):
Sociology, Economics, Political Science, or History

III. PROFESSIONAL COURSES:

Fundamentals of Education Group 9 hours
The Teaching of the Special Subject (teacher's course) 3 hours

Additional Education courses to make a total of 15 semester hours,
exclusive of supervised teaching.

- IV. A MINOR (in addition to the major prescribed by the school in which candidate is enrolled, a minor of 20 hours selected from the following):
  - A. English (English Language and Literature, Speech and Dramatic Art, and Journalism): At least 5 hours of Rhetoric. Not less than 15 hours in one of the three departments named.

B. Foreign Language (Ancient Languages, Germanic Languages, and Romance Languages): Twenty hours in any one language.

C. Mathematics (Mathematics): Fifteen hours in Mathematics in addition to two units of high school work in mathematics. The remainder in the following departments: Mathematics, Physics, Chemistry, and Geology.

D. Biological Science (Bacteriology, Botany, Entomology, Physiology, and Zoclogy): At least 12 hours in some one department and not more than 15 hours in any department. A maximum of 5 hours of Physical Science may be presented.

E. Physical Science (Chemistry, Geology and Mineralogy, Physics and Astronomy): At least 12 hours in some one department and not more than 15 hours in any department. A maximum of 5 hours of Biological Science may be presented.

F. Social Science (Economics, History, Political Science, and Sociology): At least 10 hours in History and 5 hours in Political Science. Not more than 15 hours in either Economics, Political Science, or Sociology. Twenty hours may be taken in the History Department.

G. Philosophy and Psychology (Philosophy and Psychology): At least 10 hours in Philosophy and Psychology. The remainder in Economics, Political Science, and Sociology, or in Zoölogy, Anatomy, and Physiology.

H. Home Economics (Home Economics): Twenty hours in Home Economics.

Physical Education and Health (Physical Education and Athletics,
Physiology, Zoology, and Anatomy): Physiology, 5 hours; Zoology,
5 hours; Physical Education and Athletics, 10 hours.

J. Fine Arts (Music, Drawing and Design): Drawing and Design not permitted by College regulations, but accepted by the School of Education.

#### REQUIREMENTS FOR SUPERVISED TEACHING

Pursuant to a rule of the Kansas State Board of Education all applicants for teachers' certificates must present satisfactory credit for at least three semester hours of supervised teaching, or its equivalent in satisfactory teaching experience.

Candidates applying for enrollment for supervised teaching must present satisfactory credentials, showing the following items:

1. They must be recommended by the head of the department in which the major work was done.

2. They must present a transcript showing, in the case of undergraduates, credit for not less than 90 hours of work in the school in which the candidate is enrolled.

3. They must have completed not less than 5 hours each of Social Science and Psychology; not less than 2 hours of Public Speaking; and not less than 9 hours of the required courses in Education.

4. The transcript must show an average of 1.1 grade points for all work done previous to application for enrollment for practice teaching, and in the major the average must not be less than 1.5 grade points.

Application for enrollment in supervised teaching must be made in advance in the office of the dean of the School of Education on blanks provided for that purpose.
