



It was brought to my attention just a few days ago that an invitation has been extended to Glenn Cunningham through Daniel Ferris, national secretary of the A.A.U., to appear in two exhibition races in Honolulu, on May 11th and May 18th.

We K.U. alumni in Honolulu feel it would be a good boost for better athlectic relations between Kansas University and the University of Hawaii, were Glenn to appear in the two meets mentioned above. Furthermore, Basketball is coming to the front as a sport and interest in the game has been so good that the Athletic Board of the University of Hawaii has invited the champions of the Pacific Coast conference to appear in a series of games against local quintets in February or early March.

We, from the Big Six conference do not know how good basketball is played in the Pacific coast conference, but we do know that the finest basketball is played in our conference, and most often the best team in that conference is the Kansas team.

The appearance of Cunningham here in May would help lots toward the appearance of Kansas U. basketball teams here in December 1940, or March 1941. If arrangements cannot be completed for the next basketball season, maybe the following season could be arranged, that is, Dec. 1941 or March 1942.

It has been suggested that a famous basketball coach be brought to Hawaii to give a basketball coaching course sometime soon, and we feel that Phog Allen should be the coach invited,. The appearance of his team in conjunction with his coaching course would be an ideal setup. We suggest that the Athletic Board look into this matter and start correspondence with the Uni. of Hawaii Athletic Board and see whether some satisfactory arrangements can be made. Should a trip of this distance meet with the approval of our athletic board and negotiations are started with Hawaii, we alumni here would be very glad to assist in whatever way you deem advisable.

Thank you very much for your lovely letter of the 13th instant. I took your letter home and read it to Mrs. Allen and let Bob see it, and of course they were delighted. It was mighty nice of you to say the things that you did, because kind words are always helpful to us.

George, it was a pleasure to do anything that I could for your good mother and dad. They are wonderful people and there is nothing that I enjoy so much as doing things for our friends. I was down to see him the other morning and he is nearing top form again so far as health and vivacity are concerned.

We are still in the basketball race, but we have a very slim outside chance to do any good. The team members are not large. We leave tonight for Lincoln where we battle the Huskers Saturday night, and them on to Ames to play Iowa State Monday night. We are pretty badly bruised up as a result of our game with Kansas State last Tuesday night, and I do not know whether we have enough rugged boys to stand the racket as Nebraska is especially tough on their own court. A boy named Fitz has been out with a bad knee - a big, tough fellow, and he will be in the game again. He is only one of about six of those boys six feet four or over who will give us plenty of trouble there. They pile in on you and the referees let them go, so I do not know whether our boys will be able to take it or not.

Iowa State is double tough on their court. They have been in a very severe slump, but they have come out of it during the last week. Missouri has five seniors, one of whom is 6 feet 7%, one 6 feet 5%, and one 6 feet 4. It is an interesting thing that all of these tall boys are from out of the state of Missouri. Tison is from El Dorado, Illinois, Currence from Phillipsburg, Kansas, and Lobsiger from Gary, Indiana.

The tallest man we have on our squad is 6 feet 22, John Kline.

But anyhow, Goorge, it is just a basketball race, and when it is over maybe I can breathe a little easier than I can at the present time.

I have charge of the National Collegiate play-off for this district, and then the semi-finals which will be played in Kensas City on March 22 and 23, and the National Basketball Championship of America final which will be played in the Municipal Auditorium in Kensas City on March 30. I have arranged to have at the same time a gathering of the National Association of Basketball Coaches and the National Rules Committee of the United States and Canada. I had the pleasure of engineering this arrangement and Kansas City for once will be the basketball center of the universe. I wish you might be here, but I am sure that your duties call you to more important places.

I want you to know that I fully understand your inability to make a contribution to the Phi Psi Christmas fund. You bet, I understand, George, and you are steeped in Phi Psi enthusiasm and love more than ninety per cent of the boys. It is not always the fellow who makes the contribution that has the fraternity most at heart, but if we do strike some of them who have the extra shockels that is well and good. It was not even necessary for you to write a letter of explanation. I know the obligations and duties that a young man has, and I know how heavy are your administrative duties.

Across the top of the article Mother wrote this comment about Bob. "Such a splendid boy and an A student also."

Mother mentioned in her letter that you had called at their home to give Dad a treatment in his recent difficulty. Apparently Mother thinks canned lobster was the cause of the upset as on the list of food to be avoided is that item. I guess I am truly my Father's son because I can't keep from eating things that I know are not good for me to eat. However, Mother told me that Dad was feeling much better again which, of course, makes me very happy. Being so far from Lawrence, I naturally worry when he is not feeling well.

Through the Journal World I have been following the success of your team, and naturally I am most hopeful that you win all the remaining games. Recently I saw an article in one of our papers concerning you and intended to clip it out, but I must admit that I was negligent. Our own basketball team does rather well when it stays within the limits of the North Jersey Intercollegiate League, but when we poke our necks out with New York University and Long Island University, we are considerably out of our class. This results in our being roundly beaten. However, our coach is a man in whom we have great confidence. I like his attitude, particularly concerning scholastic eligibility which somewhat parallels yours. He feels that first of all his athletes must be good students, and secondly they must be good basketball players. Somewhat following your line of thinking in asking for C averages from your players, he encourages any of his men who are having difficulty with their studies to ease up on basketball until their grades are in line. Of course, he is in an ideal spot because there is absolutely no pressure from alumni, students, or administration for him to win most of his games.
