In reply to your kind favor of the 23rd instant I am very happy to give you the information you ask concerning the personnel of the Athletic Board of the University of Kansas.

ation, known as "The University of Kansas Physical Education Corporation".
This naturally causes it to assume certain responsibilities that your board will not be called upon to assume.

We have eight faculty members here on the board. These faculty members are nominated by the University Senate and elected to membership by the corporation. We have four alumni members who are nominated by the Alumni Association and elected by the board. The two student members, one the president of the Men's Student Council, and the other an athlete at large, are both nominated by the student body and are elected by the board. There is quite a careful procedure about this thing because of the fact that the Athletic Board is a corporation.

For a number of years we had what is known as the Athletic Association, but when the University of Kansas Physical Education Corporation was formed in 1925 the old Athletic Board was merged into the new corporation. At that time the Chancellor was president of the Athletic Board, and Dr. Naismith, of the Department of Physical Education, and I as Director of the Division of Physical Education and Athletics, were also members of the Board.

The Board of Regents at their meeting on January 2, 1937, specified that no member of the coaching staff or the Physical Education Department could be a member of the Board, and the Chancellor was also made an ex-officio member of the Board. The chairman was selected from the corporate members. Professor W. W. Davis is now the chairman of the Board.

I might add that the student member other than the president of the Men's Student Council, is always a "K" man.

It is my opinion that the program regarding your formation of the new athletic board is quite workable, and doubtless you will like it very much. There is one thing to be said, however; this puts a terrific strain on the chairman of the board. If you have an old, experienced man in point of years of service but who is young enough to bear the burden of such a responsibility, then well and good. But too

often the school selects a very busy man, either a dean or chairman of a department. This burden is excessively heavy on a man who is called upon to decide so many vexing and perplexing problems, especially in the fall when the athletic hysteria is at its height. Many of these troublesome situations carry over throughout the year, entailing a terrific strain on a man who does not know the inside of this high-pressure game.

But on the whole I think you are arriving at a very fine solution, and doubtless you will select the right man to head up this most important committee.

An impression I got at the time of the interpretation meeting in Kansas City, September 3, was that the Big 6 Conference is planning on appointing a Commissioner of Officials. It goes without saying that I would like to be considered in that capacity. If there is anything that you could do to help me, I surely would appreciate it.

As far back as 1924, the assignment of officials was made from this office, as you will remember; and then, too, there were ten institutions in the Conference. In view of the fact that I have been doing this for a number of years, I feel confident that an arrangement whereby one man making the assignments for both Conferences would work out most advantageously. I don't believe there would be any criticism due to my being connected with Washington University and identified with the Missouri Valley Conference. For your information, I made the assignments for the Missouri School of Mines this year.

Had a chance to talk to Dr. Ewerhardt the other day after the Doctor had returned from the NCAA executive meeting in Chicago. The basketball situation was talked of at great length with the feeling that it may be possible that a championship in basketball be worked out at the end of the present season, just as we determine the champion in track and swimming. To this end there was a committee appointed—one from each district.

If I remember correctly, he told me that you were appointed from this district. In fact, there are three coaches and five athletic directors to make up the committee, and you were one of the coaches selected. Thought you would be interested in getting this information.



I do not know of a knee brace that would be entirely adequate for your boy. Any brace that you get will not support the internal and external lateral ligaments of the knee. It almost takes a job of expert taping to contribute much in supporting them.

In my book, "Better Basketball", in the section devoted to Athletic Injuries and Emergencies, pages 376-377, I have very definitely explained how the knee may be taped.

An aluminum hinged brace, which you can get at most sporting goods houses like Lowe and Campbell, is about as good a brace that I know about. There is also an elastic knee bandage that can be put on over the tape which gives a snug support, probably better than any other device. Or you can use an Ace Bandage over the adhesive tape. They all do the same thing as the elastic knee bandage.

I have been able to treat these knees for many boys and infithere is any way that your boy could come up here I would be glad to look at it for him without any charge, of course, to him.

Personally. I doubt the floating cartilage diagnosis, because if it were that when he would run it would float from its normal position to a position that would cause the knee to lock and the boy would be thrown violently on his face. From what I can get from your letter I do not believe that thing is happening.

You may rest assured that I shall be glad to do whatever I can.

We have a boy here at Georgetown, who is an excellent basketball player, that has had quite a bit of trouble with a bad knee. We have had some success with taping, but I am wondering if you could not recommend a brace of some kind that would do the trick better.

This knee doesnt' bother the actions of the boy at all and the trouble only comes after a bad twist. The trouble has been diagnosed as a floating cartilage. This is the boys' senior year and he is extremely anxious to finish out his career.

I would certainly appreciate it if you could recommend to me a knee brace that would give the maximum protection against a twist.
