John Buescher got a hig slam on his back last night and is a little lame today. He doesn't stand much jarring up, you know, but I believe he will be all right for the game Tuesday night. You are undoubtely acquainted with the various formations used by the Soomers in past years. This year's team uses a single and double pivot with the third man passing by the pivot man receiving the ball for a shot. Gerald Tucker is a second Joe Reif on offense, and a Wells(KU) on defense. Richard Reich, also, plays the pivot, but his strength is limited. Note, Tucker is not dangerous when in the free throw zone with exception of clever passing to teammates.

Oklahoma's weaknesses can be placed on poor reserves, now rebounding on offense, and inability to stop a fast break. Early in the second half, Bradley turned on the heat, and scored fifteen points before the Norman team could get their bearings. The three men out in front talking sone defense was effective while they were ahead, but the Peoria's team stall, and delayed offense broke it up.
