## FORM OF CHAPTER AND BRANCH CHAPTER BY-LAWS

### Article I

#### Name, Seal and Offices.

Section 1. Name. This Chapter shall be known as the . . . . . Chapter of The National Foundation for Infantile Paralysis, Inc. (hereinafter called the National Foundation).

Section 2. Seal. The seal of the Chapter shall be in such form as the Executive Committee may from time to time prescribe.

Section 3. Offices. The headquarters and principal office of the Chapter shall be in the City (Town) of . . . . . County of . . . . ., State of . . . . .

The Chapter may also have offices at such other places as the Executive Committee may from time to time designate.

### Article II.

#### Purpose.

The purpose of the Chapter shall be to act locally for the National Foundation in accordance with the Certificate of Incorporation and By-Laws of the National Foundation and in conformity with its Manual for Chapters and such rules, regulations and policies as the National Foundation may from time to time prescribe.

### Article III

#### Territory

The territory assigned to the Chapter by the National Foundation is. . . . .

(State the territory as described in the Authority to Organize a Chapter) subject to any change therein as may be made from time to time by the President of the National Foundation.

### Article IV

#### Members and Meetings of Members

Section 1. Membership. The membership of the Chapter shall consist of the signers of its Certificate of Organization, the members of the Executive Committee and such persons as may be elected to membership. Payment of dues shall entitle any person to membership for one year, but for reasons deemed satisfactory to it, the Executive Committee, by two-

### Article IV

thirds vote of the whole Committee at any regular or special meeting, may terminate any membership in the Chapter by giving written notice to the member concerned. The right of a member to vote and every other right with respect to the Chapter, shall cease on the termination of his membership. The Executive Committee may at any time establish different classes of membership and at any later time abolish the same.

Section 2. Dues. The annual dues of each member of the Chapter shall be \$ . . . . .

Section 3. Annual Meetings. The Chapter shall hold a meeting of its members annually on the third Monday in June of each year, if not a legal holiday, and if a legal holiday, then on the next succeeding day not a legal holiday, at such convenient hour and place in the City (Town) of . . . . . as the Executive Committee, may designate, for the purposes of electing an Executive Committee, considering the annual report of the Executive Committee, the annual audit report of the accounts of the Chapter and any other reports that may be presented, and for the transaction of such other business as may properly come before the meeting.

Section 4. Special Meetings. Special meetings of the Chapter members may be called at any time by the Chairman or by three members of the Executive Committee and must be called by the Chairman or Secretary on receipt of the written request of one-third of the members of the Chapter.

Section 5. Notice of Meetings. Notice of the time, place and purpose or purposes of annual and special meetings shall be given by mail to each member of the Chapter, not less than five (5) nor more than thirty (30) days before the meeting. Such notice shall be directed to the member at his address as it appears on the books of the Chapter unless he shall have filed with the Secretary of the Chapter a written request that notices intended for him be mailed to some other address, in which case it shall be mailed to the address designated in such a request.

Section 6. Quorum. At any meeting of members, one-third of the members, or if one-third of the members be seven or more, then seven of the members, present in person or by proxy, shall be a quorum. In the absence of a quorum, or when a quorum is present, a meeting may be adjourned from time to time by a vote of the majority of the members present in person or by proxy, without notice other than by announcement at the meeting, but the Secretary of the Chapter shall immediately notify the absent members in writing of the time and place to which said meeting was adjourned. At any adjourned meeting at which a quorum shall be present in person or by proxy, any business may be transacted which might have been transacted at the meeting as originally notified.

Section 7. Voting. At every meeting of members each member present shall be entitled to vote, in person or by proxy, duly appointed by an instrument in writing subscribed by such member and bearing a date not more than eleven (11) months prior to said meeting, unless said instrument provides for a longer period. Each member of the Chapter shall be entitled to one vote. The vote for members of the Executive Committee, and upon the demand of any member, the vote upon any question before the meeting shall be by ballot. All elections shall be had and all questions decided by a majority vote of the members present in person or by proxy, unless otherwise in these By-Laws provided.

Section 8. Waiver of Notice. Whenever under the provisions of these By-Laws, the Chapter or the Executive Committee is authorized to take any action after notice to the members thereof or after the lapse of a prescribed period of time, such action may be taken without notice and without the lapse of any period of time, if at any time before or after such action be completed such requirements be waived in writing by the person or persons entitled to said notice or entitled to participate in the action to be taken.

Article V

Executive Committee

Section 1. Number. The business and affairs of the Chapter shall be managed and controlled by an Executive Committee of not less than five or more than . . . . . members of the Chapter and shall include the Chairman, the Vice Chairman, the Treasurer and the Secretary of the Chapter.

Section 2. Election. The members of the Executive Committee shall be elected at the annual meeting of the members of the Chapter for the term of one (1) year and shall serve for such term and until the election and qualification of their respective successors, except as hereinafter otherwise provided for filling vacancies.

Section 3. Regular Meetings. One the same day and immediately following each annual meeting of members, the newly elected members of the Executive Committee shall meet for the purpose of organization, the election of officers of the Chapter and the transaction of any other business, and if a quorum of the members of the Executive Committee be then present, no prior notice of such meeting shall be required to be given. The place and time of such first meeting may, however, be fixed by written consent of all such members.

Section 4. Special Meetings. Special meetings of the Executive Committee may be called by the Chairman or the Vice Chairman and must be called by either of them on the written request of three members of the Committee.

Section 5. Notice of Meetings. Notice of all meetings of the Executive Committee shall be given by mailing the same at least five (5) days or by telegraphing the same at least two (2) days before the meeting, but such notice may be waived in writing by any member of the Committee. No notice of, or waiver of notice of any meeting shall be necessary where every member of the Committee is present. Notice need not be given of the nature of the business to be transacted at any meeting of the Executive Committee.

Section 6. Quorum. At all meetings of the Executive Committee a majority of its members shall be necessary and sufficient to constitute a quorum for the transaction of business, and the act of a majority, but not less than three, of the members present at any meeting at which there is a quorum shall be the act of the Committee. If at any meeting there is less than a quorum present, a majority of those present may adjourn the meeting from time to time, but the Secretary of the Chapter shall immediately notify the absent members of the Committee in writing of the time and place to which said meeting was adjourned.

Section 7. Vacancies. Any vacancy in the Executive Committee may be filled for the unexpired portion of the term by the vote of a majority but not less than three of the remaining members of the Committee, although less than a quorum, and any member so appointed shall hold office until the next succeeding annual meeting of the members of the Chapter and the election and qualifications of his successor. Any vacancy that cannot be filled by the vote of at least three remaining members of the Committee shall be filled by the members of the Chapter at an annual or special meeting. If the number of members of the Committee be increased by the members of the Chapter, such increased membership shall be deemed to create vacancies in the Committee to the extent of the number of the increase therein and if said vacancies are not filled by the members of the Chapter at the meeting at which said increase was voted, they may be filled by the Executive Committee in the manner therein provided, the new member or members to serve until the next annual meeting of the members of the Chapter and the election and qualification of their respective successors.

Section 8. Powers. All the Chapter powers, except such as are otherwise provided for in these By-Laws, shall be and are hereby vested in and shall be exercised by the Executive Committee, subject to the Manual for Chapters and the rules, regulations and policies prescribed and to be prescribed by the National Foundation. The Executive Committee, may by general resolution, delegate to committees of its own number or to officers of the Chapter, such powers as it may see fit.

Section 9. Annual Report. The Executive Committee shall present at the annual meeting of members of the Chapter an Annual Report as of the previous May 31st, including its branch chapters, if any, signed by the Treasurer, on a form to be supplied for that purpose by the National Foundation. The original of said Annual Report shall be filed with the records of the Chapter and a duplicate original thereof shall be mailed to the National Foundation before July 15th of each year.

Article VI

Officers

Section 1. Number. The officers of the Chapter shall be a Chairman, a Vice Chairman, a Secretary, a Treasurer and such other officers with such powers and duties not inconsistent with these By-Laws as from time to time may be appointed by the Executive Committee.

Section 2. Election. The officers shall be elected annually by the Executive Committee of the Chapter at its first meeting after the annual meeting of the members for the term of one (1) year and shall serve for such term and until the election and qualification of their respective successors. Each year within ten (10) days after their election, the Secretary shall notify the National Foundation of the names and addresses of the officers so elected.

Section 3. Vacancies. If any office of the Chapter becomes vacant, the Executive Committee shall elect an officer to fill such vacancy, and the officer so elected shall serve until the next annual meeting of the Executive Committee and until the election and qualification of his successor. Within ten (10) days thereafter the Secretary shall notify the National Foundation of the name and address of the officer so elected.

Section 4. The Chairman. The Chairman shall preside at all meetings of members of the Chapter and of the Executive Committee. He may, with the Treasurer, sign and execute all authorized contracts, notes or other obligations in the name and on behalf of the Chapter. He shall have general charge and supervision of the affairs of the Chapter, and shall perform such other duties as may be assigned to him from time to time by the Executive Committee.

Section 5. The Vice Chairman. At the request of the Chairman, or in the event of his absence or disability, the Vice Chairman at any time, and from time to time, may perform any and all of the duties of the Chairman and shall have such other powers and perform such other duties as the Executive Committee may from time to time assign to him.

Section 6. The Secretary. The Secretary shall attend and keep the minutes of all meetings of the Executive Committee and members of the Chapter. He shall attend to the giving and serving of all notices of the Chapter. He shall have charge of such books, documents and papers as the Executive Committee may determine. He shall in general perform all the duties incident to the office of Secretary, subject to the control of the Executive Committee, and such other duties as may be assigned to him from time to time by the Executive Committee.

Section 6. (Cont'd)

Page (6)

He shall also keep a record, containing the names, alphabetically arranged, of all persons who are members of the Chapter in good standing showing their places of residence. Such record shall be available for inspection by all members at annual and special meetings of members of the Chapter, and by all officers, and members of the Executive Committee of the Chapter at any time on reasonable notice. He shall at any time, and from time to time, furnish the National Foundation, upon its written or telegraphic request, with a copy of said record.

Section 7. The Treasurer. The Treasurer shall have control of all funds of the Chapter, subject to such regulations as may be imposed by the Executive Committee. When necessary or proper, he may endorse on behalf of the Chapter for collection, checks, notes and other obligations, and shall promptly deposit the same and any receipts received in cash in a bank or banks or depository designated by the Executive Committee in the name of "The National Foundation for Infantile Paralysis, Inc. . . . . . Chapter (or branch chapter)." He shall sign all receipts and vouchers, and, together with the Chairman or the Vice Chairman, he shall sign all checks of the Chapter. He shall enter regularly on the books of the Chapter to be kept by him for that purpose, full and accurate account of all moneys and property received and all moneys and obligations paid or incurred by him for the account of the Chapter and shall exhibit such books at all reasonable times to any member of the Executive Committee and to any accredited representative of the National Foundation. He shall, in general, perform all the duties incident to the office of Treasurer, subject to the control of the Executive Committee.

Article VII

Contracts

Unless specifically authorized in writing by the Executive Committee, no officer, agent or member of the Chapter shall have any power or authority to bind the Chapter by any contract or engagement or to pledge its credit or render it liable financially for any purpose or to any amount.

Article VIII

Fiscal Year

The fiscal year of the Chapter shall begin on the 1st day of June and terminate on the 31st day of May.

Article IX

Audit

The accounts of the Chapter and all its branch chapters shall be audited each year as of May 31st, by an independent public accountant who is not an officer or employee of the Chapter or any branch chapter and the signed certificate of said accountant must appear on the duplicate original of the Annual Report to be sent to the National Foundation pursuant to the provisions of Section 9 of Article V hereof.

Article X

Liability

The National Foundation shall not be liable for any act or any failure to act of the members of the Chapter, its Executive Committee, officers, agents, servants or employees, nor for any obligation assumed or incurred by the Chapter.

Article XI

Amendments

These By-Laws may be altered, amended or repealed at any meeting of the members of the Chapter by a majority vote of all the members in person, provided that the proposed action be inserted in the notice of such meeting, and provided further that no such alteration, amendment or repeal shall be valid until approved in writing by the National Foundation.


Dear Dr. Allen:




