No, I had not forgotten our conversation with you on the subject of the basketball. It was very brief, and at that time I thought quite unsatisfactory, but I hesitated whether I should discuss the whole matter with you or whether I should discuss it with Keedy and George at the same time.

I certainly did not know that you were not using my name on a basketball since 1934. If you told me, I did not understand it that way. I certainly would never have bought a single "Phog Allen" basketball after you had ceased to use my name on it. And if you were just stamping my name on it to sell to me, I think that is the height of folly, bordering on the radiculous.

Lear, in fact, I am rather hazy regarding the expiration date. If I remember it correctly, it seems to me the basketball had a five-year renewal, while the goal did not, but based on the same agreement that we had for basketball.

From a standpoint of equity, I think I suggested that since I had initiated all the work as far as the thought on the goal, the promotion of the goal, and the real sales talk in getting the goal put into the firm, I thiught I was entitled to a courtesy extension of five years as the spirit of the contract.

Two years before the goal was built I went to Keedy and George and sold them the idea of the goal, much against their judgment. They did not think it would go. They stated, or you stated, that you had so many on hand of the old Lowe and Campbell goals that you didn't want to attempt it. I still pressed the case, and after the goal was made up it was sold at a greatly increased figure, so that I always felt that that was my product from its inception. I also promoted several excellent ads, I thought, on the ball.

Now, as far as merely being paid for an autographed ball, I have never been in that sort of a racket, and I do not ever went to be. I remember you saying that your firm was going to discontinue all coaches names on equipment, but this has not been done, nor is it being done at the present time, so that sort of an argument doesn't hold water with me.

You will remember that I had a "Phog Allen" war bag, a "Phog Allen" basketball score book, a "Phog Allen" ball, a "Phog Allen" shoe, and several other features. I appeared before the Lowe and Campbell salesmen a number of times and endeavored to do everything that I could, not as much to help myself as it was to contribute to a part of the Lowe and Campbell sales setup.

I do not feel that Lowe and Campbell owe me anything, but I certainly do feel that I do not owe Lowe and Campbell a single penny for any money that was paid me.

I remember when I was in Dallas a few years ago that Dee Ford told me the summer I appeared before the whole Lowe and Campbell sales force and instructed the salesmen in the use of the material in the "Phog Allen" war bag that he had sold all of his stuff (and he sold a lot of it) on the instruction that we gave him then. It was not long until Cramer started making a kit, and I think they paid me the royalty that Lowe and Campbell used to pay on the war bag. I think they paid me about \$4 or \$5, and then discontinued the payments, and I got nothing out of it.

Perhaps in business a fellow has to be cold steel, but I have never worked at it that way. I am very sorry for the misunder-standing on the subject, and I felt all along that the minimum paid on the ball was the minimum paid on any ball. In fact, it is the only minimum I know of that small that was paid on a ball, but I did not think anything of it because I was wanting to contribute my part and was not trying to levy an assessment that would be in the nature of a graft for an autograph. I will drop in, but I do not feel very happy about the matter.

You will perhaps remember that the only communication I have ever had in the matter is when I dropped into your place, except on one or two occasions when the check went out there was just a short statement that they were discontinuing this or that. In the light of our many years of doing business I feel like there should have been a more ample explanation of such business situations.

Dear Doctor:

We believe that you may have forgotten your conversation with me on the subject of your name on basket ball which we discussed over a year ago. I thought that you thoroughly understood the situation - at least I attempted to explain it to you at that time.

We have not used your name on a basket ball in our catalog since the season of 1934-35, and it was the very next year when you came in and I discussed the reasons why we had dropped the ball with your name on it. Therefore, I sincerely regret the present misunderstanding.

Your contract on the basket ball with us was dated May 23rd, 1927 and expired five years later, or May 23rd, 1932. This was never renewed although we continued to pay you the royalty as agreed upon as long as we continued with the ball, and our last payment was up to June 26th, 1937.

The ball that we had your name on was a metal valve, laced with a black and red colored lace - then when your contract with us was up and this type of ball was rapidly diminishing in popularity and all factories were dropping coaches names from merchandise, so it was only the natural thing to do that the ball carrying your name passed out of the picture.

We have used Chuck Taylor's name on a laceless basket ball for the past several years but we believe that you are thoroughly familiar with his capacity as a promotion salesman for our organization. He is not connected with any institution and is more or less a missionary or good will ambassador, so his name has been used on the laceless basket ball right along for these reasons.

Now we have the advent of the Last Bilt Ball which we feel will replace the laceless ball, and again Chuck is doing the same sort of work on this ball as he did on the laceless so we are using his name. Besides this, on account of our factory connections, we are using George Keogan's name. He did a lot of promotional work for the factory this past summer and as the factory had him signed up and we did want to be in position to furnish this ball with his name on it when the demand arose, we have it in the line.

We have on hand the other dozen basket balls for you, holding awaiting shipping date, but since you feel it is advisable to make cancellation

we will go ahead and do so. However, with our explanation above we hope you will let us go ahead and send.

Again let me express my sorrow for any misunderstanding on this subject. We have thought all along you were fully acquainted with the circumstances. At your convenience drop in and let's discuss this matter which we can do a whole lot better than by correspondence.
