Dear Sir:

I have your letters of May 24th and May 27th, respectively, and thank you for both of them.

I can well understand your position and attitude in this matter. I have read your letters to Mrs. Uhrlaub. I assure you that Mrs. Uhrlaub has no desire to be unreasonable, but when it appeared that Mr. Uhrlaub was profiting from her credulity, quite naturally she resented it.

I think I might say that Mrs. Uhrlaub will be willing to accept a reasonable sum at all times, but that means that he shall share with her in the hardships entailed by the present situation.

It is true there is a court order out -- it is the divorce decree which was obtained at Mr. Uhrlaub's importunity. As I told you in my letter of May 23rd, the Uhrlaubs entered into an agreement in May, 1939, -- Mr. Uhrlaub could show you his copy of this agreement if he so desired -- and paragraph 9 reads as follows:

"In the event either party hereto shall secure a divorce from the other party, that party shall cause this separation agreement and property settlement to be presented to the court for its approval, and consent is hereby given that said wife may have judgment herein for payments herein agreed to be paid to her for her use and benefit and to her for the use and benefit of said Children."

I have just talked to kinst Uhrlaub and he chowed me a money order receipt for \$50.00 which he had sent to the Court. Uhrlaub stated that there was some court order now out to the effect that he pay \$75.00 per month from June lat on, and pay a stipulated sum something like \$700.00.

You and I both know that he doesn't have this money and there will be no opportunity for him to earn much money until next school year rolls around. If there are any court proceedings that become public and cause a disturbance in a public way, then I am sure that he will not be able to get a job in any of the schools, and the purpost of his gotting an advanced degree will be defeated so far as earning power is concerned.

I endouvored to get him a recreation job here this summer in Lawrence, but it fell through. I thought that I could swing the thing, but a woman with large experience got the job, so frankly, I do not see how he will earn much until school starts. Uhrlaub told me that if he procured a job he had expected to borrow some money on his contract and send it ahead. But he has no job at the present. Any disturbing fuctor may defeat him.

I am convinced that he is willing to pay his obligation if and when he can get a lucrative job. Anyone knows that a student in college never carns much money even though he is pursuing a master's degree. When he gets out is the time to capitalize on his carning power.

I wish that you would write me and tell me what your intentions are, because I on willing to help so long as I feel both sides are playing the game conducive to the

best returns for everybody concerned. Frankly, if there is any enforcement of unreasonable demand, then I will not be interested further in the case, I essure you.

Dear Mr. Dyers:

I am very happy to have your very frank letter. First, I want to assure you that I am one hundred per cent for placing the responsibility exactly where it belongs, and I believe that you have set forth in your letter a very fair exposition of the case.

I have just checked with the Athletic Office and find that they paid "Dutch" Uhrlaub for his services as a coach and for transportation expenses for his car at five cents a mile, the sum of \$85.57.

During the time that he assisted me in basketball and when he served as tennis coach he was paid at the rate of fifty cents an hour. Of course, this runs into no big money. I have watched him pretty carefully and I am convinced that he has been very frugal in his living here and very economical in all of his expenses. He has maintained a car. He depended on officiating high school basketball games to keep up the car payments. At the same time, I can forgive no man for doing less than he should for his children and the mother of the children.

I have talked to Mrs. Frederick, and this letter from you convinces me that he should have done more, regardless of what has been possible for him to do.

I will not elaborate upon this, but I will call him in today and see that he definitely gets your message emphatically put. And further, I will emphasize that he send some money at once. I do not know where he will get it and I do not know how much he owes out of his \$80.00.

I am definitely impressing upon him that he must make a substantial financial contribution at once, or he will be cited for contampt of the District Court at Salina without further notice.

In closing, I might state that I perhaps was responsible more than anyone else in insisting that Uhrlaub get his master's degree here, but I assure you I knew nothing of his financial obligation. If I had I would have not used the same argument or the same persuasion in requesting that he work toward his master's degree so that he could more efficiently obtain a lucrative position for this coming year.

Dear Sir;

As you have been advised I am representing Mrs. Ernst A. Uhrlaub. For that reason and because of your attitude generally, as reported to me, I feel that you should have the full picture so far as I can give it in reasonable space and time.

First, may I say that in all this unfortunate affair of separation and divorce, Mr. Uhrlaub has been very definitely the aggressor. I know, because he has been in my office a number of times, and in order to get her to file suit he entered into a separation agreement and property settlement on May 20, 1939, wherein he agreed to pay to Mrs. Uhrlaub \$1,065.00 alimony, payable \$197.00 at the time of the execution of the agreement and \$25.00 per month beginning June 1, 1939. He further agreed to pay Mrs. Uhrlaub \$50.00 per month for the maintenance and education of the two boys beginning June 1, 1939, and continuing until the older boy is 21 and \$25.00 per month until the younger boy is 21. Mrs. Uhrlaub says that since making this agreement Mr. Uhrlaub has paid \$235.27 in alimony and \$155.00 for child support.

During the winter months Mrs. Uhrlaub has worked as beauty parlor operator in the afternoons and has been employed in the mornings preparing and serving food to the underprivileged children in the Salina schools, but this last job was terminated last Friday and her earnings as beauty parlor operator are very small indeed.

She has planned on going to Colorado to live with her parents and has asked for help from Mr. Uhrlaub in the sum of \$50.00, but Mr. Uhrlaub finally wrote to his attorney here that he could not send any money.

Now, it has simply come to this -- we believe we have ample evidence to throw Mr. Uhrlaub into jail for contempt of court because of his willful failure to pay anything all these months. I might say that we have waited this long so that Mr. Uhrlaub might finish at Kansas University and get a position this year. We have been very careful not to embarrass him in any way to that end, but now she has neither the funds to go to Colorado or to stay here. She is trying desperately to get a position here. It is best under present conditions for her to remain here. It is utterly out of the question for Mrs. Uhrlaub to continue as she is. People who might otherwise help her, including relatives, refuse to do anything unless she goes the limit in trying to compel Mr. Uhrlaub to do his part, and, of course, that, if he compels, requires that we bring him back here to Salina for a hearing before our District Court.

You see, in other days, he has told Mrs. Uhrlaub that he would never pay alimony in the event that they separated, and naturally that is rankling in her mind and heart now.

I do not know how far you want to go into this, but I do feel that you are deeply interested as a man, as a parent and as an educator. I am interested, first, in protecting his family, and, second, in saving him from himself. I have been on the Salina Board of Education a number of years and know Mr. Uhrlaub very well and the kind of work he did here.

Please impress upon Mr. Uhrlaub, if you will, that he must make a substantial financial contribution to his family at once or he will be cited to appear before the District Court in Saline County without further notice.
