Dear Doc:

Just returned from the field house and sending a wire to you. As I mentioned in the wire Kistler decided that he could not afford to take the drop but was rather reluctant at that because as I have explained there are some things in the situation here that do not look too good. While I was over there I met Voltmer, whom I mentioned for the situation last fall. Of course he is out of our price range now. I talked with him at length regarding Lapp and Wendler. I have a great deal of faith in Voltmer and he was very outspoken regarding Lapp. He said that henas often been amazed at the ability of Lapp to hold his own before a critical audience.

Voltmer said that granting the fact that one's first impression of Lapp may not be too good, this is soon overcome by his outstanding intellectual ability.

I have talked to several others since last writing to you and the balance seems much in favor of Lapp for his wearing ability and possibility of development. It may seem to you that I have not at times been consistent regarding my statements but I have tried to keep you informed as to the best information I could get. Voltmer settled one doubt in my mind and that was as to Lapp's ability to carry on before a group. He feels that this is one of his strongest points.

While at the field house I also learned that the failure of the Physical Ed. office to turn in the results of my qualifying exam. and my French exam. abefore last Friday may cost me an extra summer here. Of course it would not make a great deal of difference to the University of the wathout four texts in make naagreat deal of difference to me if they cannot get it straightened out.

Dear Doc:

Your letter came this morning. I had planned to write you this afternoon because Kistler was to let me know today whether he would be interested enough inthe situation there to take a trip down to see you. However, my arrangements went haywire and I have not been able to see him thus far today. I am so confident that he will decide not to look into the situation that I will write without seeing him. Will write you immediately if he is interested. I had a long talk with him Friday, and as I said before there seems to be a chance for advancement here and the salary there would be about 500 dollars under what we have to offer, but even at that he liked the idea of the straight teaching position there.

Kistler put me out on a limb a couple of times and I found that a couple of his questions were pretty hard to answer, In the light of my own experience, of course I could not assure him as to salary advancements and advancement in rank and so on. In any event, I told him that twenty eight hundred was the limit and put the proposition as fairly as I could to him.

Had a conference with Dad Schroeder regarding Lapp and have talked to several others regarding him. Aside from that I had the opportunity to observe him around here for sometime before he left town. As near as I can find he has but one great draw back and that is the fact that he certainly does not look the part for Physical Education. He certainly does not have that drive that one would want and he is very large and loosly hung together. Depends upon his belt to assume the responsibility of his abdominal muscles. In this respect I cannot see him in the light of Dean Schwegler's critical eye as to posture. I told Lapp that he could get about \$2600 and I am sure that he would come for even less than that..

Dad says that by far our best bet would be Arthur Wendler. Has his PhD but only a couple of years experience. I have met him, but he is not here this summer. Is teaching Physical Ed theory classes for graduate students at Alabama Tech at Auburn, Alabama for the summer. He will go on full time here when he comes back in the fall but since Kistler is ahead of him he will not get a very good salary. Kistler himself would favor Wendler over Lapp. He graduated from one of the Normal Schools in Wisconsin, I think La Crosse. Could coach golf and tennis, if necessary. Is an expert gymnast and Dad says would be willing to

do practical work if necessary. Could teach the course in Tests and Measurements since he used to be employed by the Physiology Department and has done much statistical work for the Physical Education Department. I just talked with Dr McCloy's secretary regarding him and she feels much the same as Dad. Neither have any thing particular against Lapp other than that he does seem to lack that drive. Miss Metheney says that after you learn to know him he is really a "grand person". She points out that you could not go wrong but leans toward Wendler as the type who would work himself to death to help put a job over. Dad says that he would be a good investment and that seems to be the general opinion. He has worked hard all his life. By the way he is married and has a boy six years old.

I asked Miss Metheney if she would have the placement bureau send his material to you. Dad says both of them are smart boys but Wendler leans a little heavier toward the personality that will cause him to grow more rapidly. Dad thinks that you could get Wendler for \$2500 for the nine months.

Well there is the dope and I will write you as soon as I see Kistler but I am sure that he would not be satisfied at what we have to offer.

After reading this over it seems that I have not done Lapp any favors certainly, but I want you to get my impression. Although short and stocky it seems that Wendler would fit a little better with the undergraduate student.

I got the courses that I wanted, but now I wonder why. They are centainly keeping me on the go, Physiology of the Nervous system and Physiology of Exercise are both interesting but the gooddold prof won't let me catch up with him.

Dear Doc:

Had a long talk with Kistler. His is the boy that you had in mind. He is much interested, or rather will be interested if the proposition which they have before the president here does not go thru. The new plan for him would net a total of thirty six hundred for the year including work in the regular session and during the summer. To me, his position here would not appear to be a very interesting one since them will have his attentions divided from coaching freshmen teams in three sports to continuing his charge of practice teaching in the Experimental School to teaching theory courses in Physical Education and directing of Graduate Theses and a few other things. He would keep the job here and be perfectly happy, though he may work himself to death. As I mentioned in the night letter to you Dr. McCloy indicated as his second choice. Vernon Lapp, who wrote you very early in the game from Kansas City where he is employed. He has had five years experience in all. In the five years ought to have a pretty good idea as to the public school situation. He has been making a special study of the work in the past three years in Kansas City. In his previous position he taught all of the Physical Ed. (girls and boys) in a town of two thousand in Wisconsin. He comes from a long line of University people. His father is onthe faculty at the University of Michigan and his brother is in the Physics Department here. He came out here to see me last night. He and his wife are stopping a couple of days enroute to a small town in Wisconsin where they will spend a good part of the summer. Lapp is a very large chap-not

> too trim in appearance. But apparently from what I can learn he is very bright and talks intelligently on Physical Education, which is not always the case with PhDs. He is very enthusiastic regarding a University position and has possibility of development. He worked in research under McCloy and Mc feels that he has the possibility of developing almong that line in a manner that few men will develop in the field of research in Physical education. He has a mathematical turn of mind, and that feature should be an aid to any department. He is an excellent student.

How are you progressing with the matter of appointments on your staff concerning which I wrote you about a month ago? Not having had any reply I am assuming that you did not find the applicant recommended highly desirable, consequently I am taking the liberty of including herewith the credentials concerning one other man in whose qualifications I believe you will find many, if not all, of the requirements for the appointment you have in mind.
