

Dear Mr. Allen: Twice since I have been here young men from this school have consulted you about injuries which were keeping them out of athletics. In both cases you put them in condition to continue their athletics till graduation. People here know what you did in these cases and have much confidence in your judgment in such matters.

There is a boy who will enter <sup>high school</sup> as a Freshman this fall that shows promise in athletics. He is large enough and mature enough to be of value his first year and he is very eager to participate in football and basketball.

This fellow had some accident to his shoulder. Since then it jumps out of place sometimes when playing. Can you spare the time to examine his shoulder and give him advice on how to care for it?

The father, Dr. Hurley, a dentist here, will bring the boy anytime you suggest. He would like to know when you can examine the boy, about a week ahead in order to schedule his patients.

I hope you can spare the time to meet them.

Dear Principal Miller:

In reply to your favor of June 16th, beg to state that I will be glad to look at young Hurley's shoulder. You state that since he has had an accident it jumps out of place sometimes while playing. This is something that would require a special brace.

If you have a copy of my book entitled "Better Basketball" published by McGraw-Hill and Company, - doubtless you have one in the library - turn to page 361 for a description of the brace for shoulders susceptible to dislocation. On page 362 you will find a photograph of the brace. It is the only thing that I know that permits a boy to continue to play and keep that shoulder in the socket.

The capillary is partially ruptured and every time the humerus or upper arm gets at a certain height and there happens to be a blow on the elbow it will knock the head of the humerus out of the socket. I have recommended Lowe & Campbell of Kansas City as a firm who makes this brace. They have made a number of them for boys who played without any difficulty thereafter. You will notice that it keeps the arm from being raised at a height where the shoulder will be dislocated.

I am teaching here every morning from 7:30 until 10:30, exclusive of Saturday. The best time for Dr. Hurley would be to come about 9 o'clock any morning. I have a course in Theory and Practice of Athletic Injuries, and the few coaches who are in the class would have an opportunity of viewing this kind of an injury. I make no charge, of course, for any of the boys, but I would like him here at a time when it is convenient for me to see him.

Thank you for your very gracious letter of June 17th. If it was my good fortune to be of any assistance to you at all on your recent trip to St. Louis, please understand that I was grateful for the opportunity to be of service to you.

Your inquiry about football at Washington University this coming Fall is just as problematic as it was when you were here. In other words, certain of we alumni cannot possibly see how a team can be created to represent Washington University unless Army students are permitted to participate. Washington University is now practically an army post as all the fraternity houses and dormitories have been made into barracks. Therefore, it seems that, unless these army men are permitted to participate, there will be an inadequate number of men students to formulate a team. With that thought in mind, I believe I would be guided by future announcements from army headquarters as to whether or not army students will be permitted to represent the colleges where they are studying, on the football field.

I might further add that the whole Washington coaching staff,

, has departed for service and to date; there hasn't been one replacement. So it is apparent that things are really at a low ebb, athletically speaking, at Washington. In this statement I do not commit Washington one way or the other but it is "one man's opinion."


Dear Phog:
