- THE WESTERN SECTIONAL WITH THE OUTSTANDING TEAMS IN DISTRICTS FIVE, SIX, SEVEN AND EIGHT WILL BE HELD AT THE GOLDEN GATE EXPOSITION GROUNDS, SAN FRANCISCO, MONDAY AND TUESDAY MARCH 20 AND 21 UNDER THE SUPERVISION OF JOHN BUNN OF STANFORD.
- The selection of the teams playing in these sectional meets, of a necessity, must be postponed until late in the regular playing season. However, most sports writers will be able within the next week or so to tell pretty well which team in their respective district is outstanding.
- THE WINNER, IN THE EASTERN AND WESTERN SECTIONAL WILL MEET FOR THE NCAA CHAMPIONSHIP THE NIGHT OF MARCH 25 AT NORTH-WESTERN UNIVERSITY, EVANSTON, ILL. THE CHAMPIONSHIP PLAYOFF WILL BE IN CHARGE OF A.C. (DUTCH) LONBORG.

Dear Dr. Allen:

I have read over carefully your letter to "Ole" Olsen with respect to expenses for your district tournament. I would suggest that we go into the matter of expenses to teams rather thoroughly when we meet in Chicago. I am not in favor of subsidizing the teams that attend tournaments to the extent that they are all in search of a crown of gold.

Legitimate expenses are all right but if we make a commercial proposition out of the event then we place it in the same category as track. "Bill" Owens, who is president of the N.C.A.A., has some very definite convictions concerning expenses to teams. I suggest therefore that we proceed in this matter with some caution. Our next meeting will give us an opportunity to deal with the problem face to face.

Dear Mr. Cross:

This will anknowledge the carbon of the letter which you addressed to Major McChrystal concerning the expenses of the University of Oklahoma basketball team.

You were quite right in your statement that the Oklahoma team should have been reimbursed for the amount of their taxi fare on the night of the final game at Treasure Island. This evidently was an oversight which Major McChrystal will be eager to rectify.

The customary policy in figuring Pullman expenses for the transportation of college athletic teams is on the basis of a full section. During my seventeen years of coaching and traveling with teams both in the Big Six Conference and on the Pacific Coast, we used both upper and lower berths equally. Reimbursements to all the teams were made on this basis. These were my instructions to Major McChrystal when we figured the expenses of the teams. If there has been an error in this procedure, then I am at fault for taking for granted that all teams travel in this fashion and for not notifying the contestants in the tournament accordingly. Therefore I do not think it will be possible to make any adjustment on this particular account. I am sorry for this difficulty.

I am hoping to come in to Kansas City some time soon and have a conference with you. It is very good of you to offer to place at our disposal your cooperation. Mr. C. E. McBride, sports editor of the Kansas City Star, is on the committee with me, and for that reason I preferred to have a meeting of our committee before I went further. Mr. McBride has been so busy with his baseball program that I have hesitated to bother him. I do want to talk with you on attendance building promotion and publicity, as I am sure you will be very helpful to us. I will give you a ring prior to my coming to Kansas City.

As you know, we have already made arrangements and have our contracts signed for the final playoff games in the Municipal Auditorium on March 50. Doubtless you know that the

National Collegiate Athletic Association comprises all the national universities and large colleges in the United States, and this tournament together with the Rules body, which comprises members from the United States and Canada, plus the Coaches Association should make Mansas City next year the basketball center of the world.




