

I am enclosing a copy of a letter I received from Dean Bunn of Stanford, under date of February 23rd.

Since I did not know what the status of affairs was in the Seventh District I asked Dr. Gilmore, as President of the Rocky Mountain Conference, to write Dutch Witte to see just what the situation was. I have just received a copy of his reply and in it he states that the University of Colorado would probably be invited to participate in the Tournament. This I think is appropriate under the method of selection of teams as it has been worked out this year, but I do not like the method, and I think we will have a discussion of the whole matter at a meeting of the Executive Committee of the N.C.A.A. this coming Saturday.

You know, of course, that I have no desire nor inclination even to suggest to the athletic authorities at the University of Colorado what they should do in a matter such as this. I do feel, however, it is important if the National Collegiate is to sponsor a championship that the most representative teams compete.

I think this Tournament will become, if properly handled, an outstanding event nationally and you know how strong a believer I am in the necessity for a national organization, such as the N.C.A.A. to run championship events if we concede at all the necessity for their being run.



Dear Major Griffiths I am sending you some copies of correspondence that I have had with H. C. Olsen and John Bunn regarding the N.C.A.A. besketball tournement. In the light of the deficit that the basketball committee incurred, I want you to know that I am using my utmost energy to put this project over in the way it should be done I believe the letters are fairly self-explanatory, but if there is any question that you should like to raise, I would be happy to have you advise me. I feel that the heavy indebtedness that the N.C.A.A. has taken on puts it up to the basketball committee to clear their skirts financially. I am wondering how you feel toward all of our discussions, tentatively agreeing so far as practical, to play on the home court of one of the winning teams.

For instance, if Missouri and Oklahoma should tie for the Big Six championship I would be agreeable to tossing a coin to see whether they should play at Columbia or Morman for the play-off. Or I would let them settle it my may agreeable to them. If they wanted to play two out of three games, or one game to determine it, that would be agreeable, the M.C.A.A. to get a major portion of the cut, of course.

And then if we had a situation like we had last year with Oklahoma A. and M. in the district play-off and tied with Drake, I would be agreeable to having the play-off at Still—water. Last year Iba said if we would have given him the tournament he would have guaranteed us somewhere around five or six thousand dellars. Of course, I think his figures were high, but if we could go into a deal like this all over the country and then have the sami-finals and finals, we ought to have some money in the bank. I am wondering what you think about it.

You can see by the enclosed letter that I have written Ole that I am much in favor of getting out of debt and being on the right side of the ledger. It would be too big a boom for the Ned Irish tournament for us to fall down again.
