Here is the proposition that I offered Mr. Liston. I proposed that we take the cash receipts of the National Intercollegiate Tournament for their first two nights last year, and that our N.C.A.A. committee allow him that amount of money for his rental plus an added sum this year. I proposed that we then, as a determiner for the added sum, take the entire total gross receipts of Liston's Intercollegiate Tournament for last year and compare them with the total receipts this year, and that we increase the rental for the first two nights of this year, namely Monday and Tuesday, according to the proportion of the increase in total gate receipts of this year over last year's tournament.

In other words, if Liston's tournament this year grossed twice as much as last year, we would pay double the rental for Monday and Tuesday nights.

It must be taken into consideration that Liston's tournament would go on and not be interrupted only by pushing some of their games so they would be played during the day rather than at night. This would be velvet for Liston's tournament, and I considered it a very fair proposition.

Furthermore, I agreed that he could count his advance sale that has been made by the Chamber of Commerce in this year's gross. Liston stated that he had about 2,000 tickets sold. We had agreed to admit these tickets free so far as deductions on our part were conserned regarding the totals.

Gentlemen:

I desire to give you some information to bring you up to date on our Fifth District N.C.A.A. play-off.

The University of Oklahoma and the University of Missouri tied in the Big Six Conference with seven won and three lost. Oklahoma A. & M. and Drake tied in the Missouri Valley Conference with nine won and three lost.

Our Fifth Mistrict committee met in Kansas City at the Continental Hotel at 2:30 p.m. on March 7th, all members being present. At 10:50 the same morning the Intercollegiate Athletic Committee of the University of Missouri met at Columbia, Mo., and decided not to enter the tournament. Mr. George Edwards, a member of our committee and varsity basketball coach at the University of Missouri, stated that he did not know anything about the action of this athletic committee save what was printed in the paper, - that the committee desired that the team members have no further absences from school. I am sending each of you a clipping from the Kansas City Star which will explain the action better than the chairman has been able to get it from anyone else.

of the other three teams and asked if they would abide by the drawings made by the committee. Buch stated that they would.

When the four teems were in I endeavored to get over a proposition with Mr. Mail Liston, the manager of the Collegiate Tournament in Mansas City. I offered Mr. Liston approximately \$1,000 a night for rental of his hall on Monday and Tuesday, the 13th and 14th of March, so that we might play the four-way tie off and determine the team that would go to Frisco. I found Mr. Liston very difficult to deal with. But I will explain this detail to you later, in person. It would not have been impossible at all for Mr. Liston to have played his tournament genes in the morning and afternoon and two genes at night, both Monday and Tuesday nights, and they would have profited by the \$2,000 net take very definitely.

When Missouri withdrew from the tournament then the chiefest interest in the tournament would naturally be in Oklahoma. At our Kansas City meeting it was voted that the chairman would go to Oklahoma City and endeavor to make arrangements for the play-off down there. This thing was done, and on Tuesday night the chairman left for Oklahoma City and met Coaches Bruce Drake, of the University of Oklahoma, and Henry The, of Oklahoma A. & M., together with Mr. Tom Stidham, Athletic Director of the University of Oklahoma, and Mr. Bus Ham, sports editor of the Daily Oklahoma. It was arranged that the genes would be played in the auditorium in Oklahoma City.

The drawings were made in Kansas City, Missouri, in the presence of all the committee members. The University of Oklahoma draw a bye and Drake and Oklahoma A. & M. are to play the first game on Monday night, March 15, in Oklahoma City. The valuer of the Drake-Oklahoma A. & M. game on Monday night will play the University of Oklahoma on Tuesday night, March 14, to determine the winner and the representative of the Fifth District which will play in San Francisco on the 20th and 21st.

I have stressed that the winning team will furnish much added publicity together with some unusual snapshots, a great number of them, to his John Burn ismediately upon the completion of the tournament. We will have some flashlights and snapshots of the winners ismediately after the game.

I am very happy to have your good letter of the 9th instant.

T think I can appreciate your concern when you voiced your anxiety to me over the telephone Wednesday afternoon when I was in Oklahoma City. I assure you that I tried by every fair means to give everybody a square deal from beginning to end.

It was unfortunate that Missouri withdrew from the tournament. Our committee was faced with a very embarrassing situation, and when George Edwards, John Truesdale and C. E. McBride and myself met I felt that the disposition would be utterly unbiased and fair from every standpoint.

The committee acted upon the matter of the court being neutral, they passed upon game officials, admission prices, game ball, playing rules, and any other administrative affair not covered during the discussion at the time. Finally the drawings were made. Mr. Edwards suggested that since Mr. Mc-Bride was not a member of either conference that McBride draw. Mr. Edwards, the secretary, prepared the slips, placed them in the hat, and the chairman held the hat high above the table. Mr. McBride draw. On his first draw he drew a bye. On the second draw it was the University of Oklahoma. It was just the chance of the draw and it might have gone any other way, but I can understand how people not being at a meeting might wonder.

When I was asked to take the chairmanship of this Fifth District N.C.A.A. play-off I asked the basketball coaches and athletic directors of the Missouri Valley to nominate a man

as representative from their conference. They nominated Mr. Truesdale, and I appointed him. In conversing with Mr. Truesdale he informed me that it would be impossible for him to be in attendance at the Kansas City meeting. I called him by phone on Monday night and insisted that he attend the meeting by all means. I also insisted that Mr. Edwards and the other members of the committee all be present, which they were.

Our committee felt that they should nominate officials and they asked the cooperation of Mr. Truesdale in order to represent both conferences. The committee thought that they were picking officials that were fair, but the committee did give the chairman authority over anything not covered by their action, or if he should find them wholly unsatisfactory to any member of the group, to mediate the situation. That was exactly what I endeavored to do in your and Drake's behalf. I found to my great pleasure that Mr. Henry Iba and Mr. Bruce Drake were pleasingly cooperative and they showed a disposition to play the game one hundred per cent.

I again want to assure you of my desire to please, as I felt that I was representing the National Collegiate Athletic Association, and since your institution is a member along with all of ours on the committee, we should never at any time permit ourselves to be anything but servants of our group.



I am sorry that I did not have an opportunity to visit with you longer at Oklahoma City. Bus Ham tried to get in touch with you a couple of times so we could have a game of golf together. On Monday Bus, Henry Iba and I played nine holes. We tried to get in touch with you, but missed you. Then on Tuesday we planned to play again but the sand storm came up and it turned cool so we called it off.

I got your note together with your expense account and I want you to know that personally I very much appreciate your very generous attitude in offering to waive your fee due to the fine interest that you had in the N.C.A.A. tournament. I want you to know that while that is appreciated, I would not for a moment think of accepting your generous offer. Therefore, when I left I instructed Earl Jones to have a voucher made out to you for your expenses plus the \$40.00 for your fee for the two evenings.

Certainly a fellow that would go to the hardships that you did to make connections should not be penalized because he is interested in seeing a project like this succeed. We made money, and since all expense for everybody else, including any honorarium or fee, was paid I certainly would not think of you not receiving your fee. So it is with my thanks to you for your exceptional work under very difficult circumstances that I am insisting that you have your expenses plus your fee.

I have never been too lavish in my praise of an official because I have always felt that when a coach was less fulsome in his praise at the next game the arbiter might officiate, then the official would wonder why the praise was not forthcoming at the next game. The Fifth District National Collegiate Athletic Association championship basketball was decided before a hilarious crowd of 5,000 Oklahoma Sooners and Oklahoma Aggie Wildcats at the Oklahoma City auditorium Tuesday night, March 14. On Monday night the Aggies had defeated Drake in a one-sided contest. Drake and the Aggies had wound up the Missouri Valley season as co-champions of their conference.

Coach Bruce Drake's Sooners showed a marked superiority in the last half over Henry Iba's clever basketeers. Two contrasting types of balls were used in the final play-off game. Big Six games have been played with sewed seam basketballs, while the Missouri Valley conference teams have used a moulded type of ball. The championship committee decided that both types of balls be used in the play-off games, each ball being used for a half. The choice of which half either type was to be used belonged to the team winning the toss of a coin. Bruce Drake won the toss and elected to play with the Big Six ball the first half.

Iba told me previous to the game that if he won the toss he would play with the moulded ball the second half. So it turned out that both coaches got exactly what each desired.

The moulded type of ball uses 7 pounds of pressure and the resiliency bounce of the moulded type ball is 4 feet 6 inches when the ball is dropped from a height of 6 feet. On the other hand, it is necessary to inflate the sewed seam basketball to a pressure of 13 pounds to get the same resiliency. The moulded ball is very slick and difficult to handle when wet with the perspiration of the players, while the sewed seam basketball is made of natural leather and absorbs perspiration readily. So there is much speculation as to the outcome of the game depending upon the toss of the coin. As it turned out, Oklahoma outplayed the Aggies by a greater margin with the moulded ball than with the sewed seam ball.

This may seem like a trivial point, but it affected the players of both teams more visibly than any other single item.

The officials were Parke Carroll, of the Kansas City Journal, and Jack North, of the Des Moines Register.

The prices were \$1.68 top price and 40% for the upper balcony. The attendance was nearly 5,000 and the income averaged \$1.00 per head, making a total of \$5,000 income the second night and \$600 the first night. This play-off tournament made money for the three participating teams and also for the N.C.A.A., the governing body.

The basketball committee of the Fifth District of the N.C.A.A. is: C. E. McBride, of the Kansas City Star, George R. Edwards, of the University of Missouri, John C. Truesdale, of Grinnell College, and Forrest C. Allen, University of Kansas, chairman.

The University of Oklahoma is now on its way to San Francisco where they play with the district winners - University of Texas, of the 6th district, Utah State College, of the 7th district, and the winner of the California-Oregon game which is decided tonight for the Pacific Coast championship, the 8th district. Entire expenses are paid for 15 men, including the coach, of all these district winners.

The winner of these four districts, which will be decided on Monday and Tuesday nights, March 20 and 21, will meet the winner of the four eastern districts, 1-2-3-4, east of the Mississippi River. These eastern districts will play at the University of Pennsylvania palestra in Philadelphia on Friday and Saturday nights, March 17 and 18. Then the national championship will be determined between the first place winners of these two districts, the game to be played at Northwestern University at Evanston, Illinois, on Monday night, March 27.

This will be the first time in the history of basketball that a national collegiate championship has been determined. This tournament is the only tournament that has the sanction of the National Collegiate Athletic Association. This basketball tournament is comparable to the National Collegiate Track Meet which is held annually under the auspices of the N.C.A.A. There is no other national basketball tournament in the United States that is a bona fide college tournament administered by collegiate authorities. President Owens of Stanford University, together with Major Griffith, Director L. W. St. John of Ohio State, and other officials of the N.C.A.A. set up the tournament plans last December at their meeting in Chicago. It was then approved by all the conferences in the United States, including the Big Six and the Missouri Valley conferences, and in a few years basketball will gain the recognition that the other major sports have gained, and in addition it will be benefited by the supervision of this parent body.

It is not an idea of this N.C.A.A. that nomads will be made out of the basketball players. Rather, a legitimate champion will be crowned each year and upon the next occasion of the Olympics where basketball will be played the N.C.A.A. will present a basketball team

to challenge the A.A.U. for their leadership in the United States, and the right of the United States to be perpesented in the Olympics by the N.C.A.A. participation. In other words, the colleges will pick an Olympic team from the N.C.A.A. It may not be a single team, but it will be the all-stars of the colleges of the United States and they will play the all-stars of the A.A.U. for their right to represent America in the Olympic Games. Had the Games been held in Tokio, Japan, basketball would have a place, but since they have been transferred to Stockholm basketball will not be one of the participating sports. But in 1944 it is the aim of the colleges of America to challenge for a right to Olympic representation.

John W. Bunn, of Stanford University, an old Kansas player and ceach, is in general charge of the play-off tournament at San Francisco. I will assist him and am leaving tonight at 11:10 on the Union Pacific, arriving in San Francisco Monday merning, March 20. June Salmon, of Princeton University, a member of the national executive N.C.A.A. basket-ball committee, will supervise the eastern play-off at Philadelphia, assisted by S. Jamieson Schwartz, of the University of Pennsylvania.

The five members of the executive committee for N.C.A.A. basketball are H. G. Olsen, of Ohio State University, chairman, June Salmon, of Princeton University, W. S. Chandler, of Marquette University, president of the National Basketball Coaches Association, John W. Bunn, and Forrest C. Allen.
