Dear Oles

This will acknowledge receipt of your favor of the 31st ultimo regarding the planned meeting of the Executive Committee of the McC.A.A. at Hotel Sherman in Chicago on September 6 and 7.

I think it would be a good plan to have the three of us in session with the Executive Committee when we discuss basketball. I am not definitely sure that the eight-team tournament in Kensas City will be the answer, but Sam Barry and the other boys were strong for this set-up.

Why would it not be a good idea for you to write John Burn, even though he is off of our Committee, Sam Barry, Hobbie Hobson, Frosty Cox, Henry Iba and some of the men who have been at these sectional, regional playoffs as well as national, and get their reaction? We do receive some criticisms when we have a Western, Bastern playoff and then the finals. So many people think that we take too much time from school and Sam Barry's contention is that one tournament would do the job; all of us would lose less time away from school, especially if we could play the tournament during the Baster vacation. I know there is some religious objection to that but I think that is the best time. If we can always consider putting the tournament during Baster vacation then very few teams would lose time from their classes.

The contract that I signed with the Municipal Auditorium said that in October we would be forced to make a decision if and when the Municipal Auditorium had been asked for dates by other outside parties. We are holding an option on several dates.

I have been corresponding with Floyd Rowe concerning the dates that the Basketball Rules Executive Committee are to decide on for their rules meeting, and the place. I was trying to play ball with you and endeavoring to have the basketball rules meeting at the same place and near the dates of the basketball playoff. This may not be at all necessary but I wrote Floyd that I was holding for the meeting to be held in Kansas City on account of the tournament dates tentatively planned there. Floyd wrote me confidentially stating that the vote was largely against me. I thought I would pass this on to you in confidence so that if you considered it important you might see what you could do with him. So far as I am concerned, if you feel that the

I am making a canvass of the members of our selection committees, etc., plus a number of other coaches, to find out if they have any definite reaction about the relative merits of the eight team tournament as compared with the present setup of Eastern and Western play-offs with the final game between the two winners.

I do not believe there is any particular advantage in the eight team tournament idea. First of all, I think it has less chance of succeeding financially, and, secondly, I think the total time away from classes would be greater under the eight team tournament than it is under the present plan. The only teams that suffer under the present arrangement are the two teams who go through to the finals and I have the feeling they for the most part are rather glad to make a sacrifice of this kind in order to play for the National Collegiate Basketball championship.

I suppose by this time you have had word from either John Griffith or Bill Owens to the effect that they want you to come along to Chicago for the meetings on September 6 and 7. I hope to have some reactions from these letters so that we can dispose of the matter of whether we are going to run a eight team tournament or continue with the present scheme.

As to the place of meeting for the Basketball Rules Committee, I have not heard further from Floyd Rowe but I also registered with him the definite opinion that the Rules Committee should again meet in Kansas City at the time of the N.C.A.A. Tournament or shortly thereafter. I hate to see Nat Holman and some of that Eastern gang succeed in pulling the Rules Committee to New York after the way they selected their place of meeting.

I am here in Columbus only for a couple of days and am going back up to camp, but in case you have anything to write me about, mail addressed to me here at Columbus will be forwarded immediately. I will be looking forward to seeing you in Chicago if I don't hear from you prior to that time.

By the way, I had a letter from John Doyle, Editor of the American Sports Publishing Company in New York. He tells me that Dan Partner's article was too sketchy and sparse. I am in hopes you have been able to get Partner to write a better article including more of the highlights of the tournament at Kansas City. If you are not too busy with things I wonder if you would follow this up and see that he gets something suitable into John Doyle's hands just as soon as possible. Also, was there a N.C.A.A. "All" team picked? If there was, please get that into the write-up.

Dear "Phog":

After the National Collegiate Basketball Tournament last season, there was some comment to the effect that we would be following a better procedure if we had one tournament of eight teams, representing the eight districts of the N.C.A.A., play off at some good spot like Kansas City, for example, rather than to conduct the tournament as we have been doing heretofore through a Eastern play-off and a Western play-off, followed by the final game between the winners of these two tournaments.

I am wondering if you have any definite reaction as to the relative merits of the two plans. The objection to the prosent plan, as offered by a few coaches, was that it moant too much time away from classes. I am not sure that this is a valid objection, because the time away from classes would probably bo greater, on the whole, if we were to have the single eight team tournament. The only teams that would be forced to be away from classes under the present plan would be the two teams who play in the final game. There is no question but what a single eight team tournament would be a big tournament, but I am pretty definitely of the opinion that such a tournament would have less chance of succeeding financially (unfortunately, we do have to look at this side of the picture) than the plan we have had in effect.

Thoro is to be a meeting very shortly of the Executive Committee of the National Collegiate Athletic Association and the matter of the basketball tournament will come up for discussion. I wonder if you wouldn't be kind enough to forward to me immediately any reaction you might have concerning the tournament. It is our hope that we can announce definite plans for the coming N.C.A.A. Tournament much earlier than we have been able to do in the past. I am sure you will agree the earlier we can make definite plans the better satisfied all coaches will be. So won't you please write to me at once, if you care to register an opinion in regard to this matter?

Dear Oles

A copy of the attached wire was sent to you yesterday. I feel very strongly that St. Clair should be present at our Chicago meeting, and the fact that we made enough money this year to justify his attendance causes me to appeal to you for such a decision. This meeting with the Executive Committee should be a history making meeting. Bither we will set out a plan whereby the ccaches of the nation will support this tournament, or we will make rules which will cause them not to support it, and the N.C.A.A. basketball tournament will die. It will take much patience, careful planning, and the best brains that we have to put the N.C.A.A. basketball tournament among the top-ranking N.C.A.A. activities, and with all of that it can be made a definite money maker.

My notion was to have an eight-team tournament during the week of Easter vacation and not during the regular academic term. Easter falls a little late this year but I believe with the success of the Rose Bowl games and the Christmas games which come a month after football season that it would be an easy matter to keep these successful teams in training for a month. In fact, a two-weeks rest after the basketball season is over would be the very thing a team needs, and then light practices up until the time the trip is made, Easter week would be a stimulating thing. Ole, I am looking at the thing from the standpoint of reducing the objections by educators to this basketball tournament. The fact that we would take no time away from school and would give the boys an educational trip would put the basketball tournament in the same position as the Rose Bowl game, or the East-Nest game. As a matter of fact, the coast games do take some time away from the boys' study, but if you played this tournament during Easter week you would lose no time from school.

I may face a possible protest by the Ministerial Alliance on the possible project of playing the games during Easter vacation. You will remember we played the finals last year during Easter vacation and I called the Ministerial Alliance and told them that I regretted that the games were held at that time but that there was no alternative. The President of the Alliance said, "Don't worry about that. They have rodeos and shoots and all sorts of things, so I see no reason why you shouldn't have basketball games." In fact, many ministers attended the games and then flew home either Saturday might or Sunday morning. So, my suggestion, Ole, was to set the national play-off during Easter week so that there would be as little time as possible lost.

In your circular letter I noted that, of course, you did not mention Easter vacation time. Also in the letter you asked for an opinion, and at the same time argued against the eight-team tournament idea. You would hardly get an unbiased vote by this procedure.

On August 12 Bill Owens wrote me from Stanford saying that the Executive Committee meets in Chicago on September 6 and 7 at the Sherman Hotel. He says:

"You will recall at the time of our discussion in Kansas City last Spring, that I suggested that representatives of the Basketball Committee attend the next meeting of our Executive Committee to discuss problems in connection with the basketball tournament. Our Executive Committee meets in Chicago September 6th and 7th at the Sherman Hotel. I will be very glad to have you attend if possible at that time.

"I am also asking Mr. Olsen of Ohio State to be present."

I am replying to him this morning, sending a copy of my wire to him and imploring him to have Mr. St. Clair. Personally, I would not want to take the responsibility of you and I alone doing this job without Saint. And too, since I have borne the blunt of this distribution problem in my conversation with Mr. Owens and Professor May, I would not want to put myself in a position of opposing these gentlemen who feel that the N.C.A.A. organization should have all the money. In my opinion, this scheme of President Owens' is doomed to failure and our tournament is whipped forever. So I prefer to let them outline their strategy and policy rather than to have me oppose it because I would be misunderstood if I presented the case as I see it.

If the three of us meet together we could so temper our reasoning so that all of us could be agreed upon the policy presented to the N.C.A.A. and no one individual in particular could be put in a position of opposing the men of high authority. For that reason, I stand on my former statement that I would not care to attend the meeting unless Saint, you and I were there to discuss the matters in fullest detail before we presented them to the N.C.A.A. Executive Committee.

I would have felt very much better last year had I not been represented by a team. I could have then without stint of selfishness presented the case even more vehemently for the team members who participated. I am not for the individuals getting a pot of gold, in fact, I see eye to eye with the officials of the Executive Committee having the players assume the role as pot hunter, but I do believe that these institutions who go to the finals should have their treasuries enriched in a small degree because it then gives that sport prestige with their own athletic committee and their University. Every administrative officer of any institution that I have talked with thinks that the

teams that go to the semi-finals and finals should have a proportionate part of the earnings that they create. While it may be under the auspices of the N.C.A.A., it is actually the teams participating that draw the crowd and the N.C.A.A. in turn share in the returns on account of being the fraternal body. But in my opinion it is wrong to expect to take it all.

I will be very happy to cooperate with the National Collegiate in every way possible. I am happy to comply with your request No. 1. I fear, however, that I would not be a good contact man with A.A.U. organizations because we have not had pleasant relations since 1936 when I refused to have anything to do with basketball when it was under their domination. This refers to the trip to Berlin. I withdrew and labeled the outfit as a quadrennial, oceanic, hitch-hiking crew. Doubtless you could get someone else in this district to serve a better purpose and who would be more harmonious with the A.A.U. than I am. Yes, I realize that more than 90% of all our Olympic participants are either undergraduates or recent college graduates. I heartily agree that the A.A.U. has assumed a lot more authority than they should possess. When we realize that the A.A.U. does not own a hurdle, an athletic field or a single building that is used for athletic participation. then we realize their inherent weakness. The N.C.A.A. serves a clientele so much differently that no like comparison can be made. I emphatically feel that the college should and must see to it that qualified men are in charge of the program. You may count on my active participation but I am afraid that I am not the best man in this locality to do this job. Will you please advise me of your choice? Dear Dr. Allen:-

The Quadrennial Meeting of the Olympic Association is scheduled to be held this November in Washington, D. C. The National Collegiate Athletic Association is interested in securing the selection of proper officials for the conduct of the Olympic Games, which we assume will be continued when the present disturbed world conditions are over.

I am asking several men in different parts of the country to take steps to insure proper representation at the Olympic Association Meeting of the organizations in their districts which are entitled to vote. I would like to have you serve in this way in your area. The important steps to be taken appear to be these:-

- (1) To contact the college conferences which are, or have been, members of the Olympic Association, and urge them to see that their dues are paid, and further to urge them to send a representative to the Association Meeting. Proxy voting is not permitted.
- (2) To contact local A.A.U. organizations which are entitled to vote and endeavor to secure their cooperation in the selection of proper officials for the conduct of the Olympic program.

As you know, in several of the major sports on the Olympic program, college undergraduates, or recent graduates, constitute over 90% of the competing athletes. We feel that the colleges should, and must, see to it that properly qualified men are in charge of this program.

May I count on your active cooperation? Time is short and we must act at once.

August 25, 1940 Mr. Floyd Robb, Chairman National Basketball Committee of United States and Canada Board of Education Cleveland, Ohio Dear Floyd: I do not believe that I answered your good letter of the 26th ultimo. I have been in Temas at a coaching school and have been scurring around over the country so that I could get back to the Kansas State High School Coaching School which I am just finishing in Topeka. On my way from Austin I drove through Dellas and had a nice visit with J. W. St. Claire last night I visited with He V. Porter who is on the faculty of the Kansas State High School Coaching. School. I did not discuss at all with Porter the vote for New York, but I did mention it to St. Clair and he said he had forgotten how he had voted. He has a wife who is very ill and I can understand how he might forget these things. All I desired was that Olsen and St. John be notified because if Nat Holman placed the cards so as to throw the meeting to New York, then I wanted them to be fully appraised. And I did not believe that Saint or Ole or you would want the New York group as it is now constituted to control movement of the committee. In other words, to put the national rules committee in New York at the time of that tournament would be doing exactly what the New York group wanted. Personally I would just as well like to meet in Chicago, if they did not have the meeting at the time of the play-off of the N.C.A.A. I do not want to build Nat Holman and the New York writers group up any more than it has been possible for them to build themselves up. I have been corresponding with John T. Doyle, Oswald Tower and other different individuals and I am glad that you like the angle of shifting some of the data in the rule book from time to time. I had a letter from Os and he states that he had taken the matter up with Doyle and John T. was against changing. John T. is tied up with Ralph Morgan. It happens that Ralph Morgan was for years the guardian angel of the eastern intercollegiate league and the N.A.U., and the American Sports Publishing Company and Ralph Morgan are tied up because it happens that Morgan and that group have worked closely together. In fact, Mr. and Mrs. Morgan were great friends of John T. and it would break John T. 's heart to do something that was not pleasing to Ralph Morgan. That is the background. So when this is done it will, of course, be handled in a diplomatic way and I am sure that you can handle it. Oscis o.k. and so are all the rest of the group. I thank you for your expression.

I had not planned that we do anything this year because the book was too far set, but Os sent it on to John T. and I also sent a copy of Harold Keith's communication on to Mr. Doyle so I was letting him know there was quite a bit of objection in including all the Ralph Morgan stuff in the front of the book.

I have not written Dr. Keene as yet but I have planned that you should keep all the stuff I have sent you. I have learned that Dr. Keene would be away on a vacation during the summer and I thought it would be better to communicate with him during the school period than at present. I do know that there are many medical men who are irate regarding the fast break game in basketball. That caused me to develop the Goal-Hi because many people are concerned about the hearts of the youngsters. The circular goal causes the focus of the activity to be toward the center of the goal, thereby causing the ball not to go out of bounds. By this method the ball is kept in play and ball handling and shifting and goal shooting are developed to the maximum with the amount of shifting back and forth reduced considerably.

As an answer to the protest of the physicians on the fast break

I am still of the opinion that the rotation of the center jump by having a
jumping order the same as we have a batting order in baseball, may be the
logical solution. Certainly we should consider the possibility of taking
the ball from out of bounds from after a goal and putting it in place
at the division line as one of the possible solutions for slowing up this
hectic game that is causing much excitement and too much unfavorable
comment toward the game. Basketball is too good a game to draw all
the fire of the critics. We should be able to lessen the fire of
criticism against this game because it has too many educational qualities
to be subjected to this machine gumning by the medical profession.

I am like you, I am tied up in a mass of detail, but when you clear your desk for this fall, I would appreciate your checking on me regarding the Keene article, and if I have not sent it I certainly want to write him a personal letter and present to him my best thought for the elimination of as many evils as possible, as I see it.

I am leaving with my family to drive to Louisville to visit my daughter and grandchildren, and then I may be called to Chicago on September 6 and 7 to meet with the N.C.A.A. Executive Committee. We have not ironed out all of our difficulties regarding tournament possibilities.

I trust you have had a very pleasant summer and that you are feeling 100% again. Somewhere in my agenda I have a letter concerning the politics of the Big-6 and the N.C.A.A., etc. I want you to know I greatly appreciate

what you have written because I still think there are some boys down that way that would be delighted in seeing some change. I am not a jealous cuss at heart but sometimes I recognize situations.


