PART I. Concerning rule changes made last spring:

1. Any player may request a time-out. Is present rule satisfactory? Yes...**32**... No.....
2. After a technical foul, the throwing team keeps possession at mid-court. Is present rule satisfactory? Yes...**28**... No...**4**.....
