My dear Mr. Schabinger:

Glad to have your letter giving acceptances of McLaughry of Brown, Novak of Westpoint, McDermott of Oklahoma, and Hagen of Oregon Aggie. Shabby, as soon as you get these acceptances, why would it not be a good plan for you to go ahead, with authority from the president and anyone else that you may want, and have some stationery run out. 
Have heard from all of the appointees on committees except Murray of Marquette and McNichol of Pennsylvania. I am sure about Murray but do not know about McNichol.
