

Dear Dan:

Congratulations to you, sir, upon the matrimonial step that I learn you are about to take: May you have a very long, prosperous and happy wedded life is my sincere wish.

I talked with you regarding the write up of the Western N.C.A.A. play-off and the National Collegiate A. A. Finals in Kansas City. Since you attended those sessions of the play-offs I am sure that by reference to your own sport files you can get ample data and material for the spectacular feature.

Just to refresh your memory I thought I might suggest some events, although I think these suggestions are superfluous.

I would suggest elaborating upon Kansas City as the outstanding sports center of the country. You know the games were a sell-out two or three nights before the finals. And then there was the spectacular feature between halves of each game with the University of Kansas band, the Lawrence High School band, and the Wyandotte High School band. The University of Kansas band under the direction of Russell Wiley, put on a great demonstration. There was a splendid memorial tribute to Dr. James Maismith, the originator of the game of basketball.

And then the National Rules Committee of the United States and Canada was in session on March 30, 31, and April 1, and the National Association of Basketball Coaches met on March 28, 29 and 30. It is the first time in the history of basketball that there was a bona fide National Collegiate play-off at which the Rules Committee and the Basketball Coaches Association were in attendance.

As you know, this was the second N.C.A.A. Basketball Tournament. The first was a year ago, which took place at the Golden Cate Exposition at Treasure Island, was won by Oregon by their defeating the University of Oklahoma 55 to 37. The eastern play-off was held at the Palestra, University of Pennsylvania, Ohio State defeating Villanova 53 to 36. Then the two teams met, as above mentioned, at Chicago. Last year was the first venture, and they lost \$2500.00.

This year, by the play-offs in Kansas City, the deficit was wiped out and a very tidy sum was realized. The western play-off this year was in Kansas City, and you know the result, and you can write on the four teams in that, I am sure. The eastern play-off was at Butler fieldhouse at Indianapolis, with Kentucky State, Springfield Y.M.C.A. College, Duquesne, and Indiana, and of course your play-off reports will give you the information on that.

The winners of the eastern and western received beautiful gold belt buckles and appropriate emblematic cup trophies. For the winners of the National, the first and second teams were presented with beautiful gold Elgin strap watches with the N.C.A.A. insignia, and gold and silver basketballs. The National Basketball Coaches Association presented the National winner with the James Naismith Memorial Trophy, and the N.C.A.A. presented the runner-up with a beautiful N.C.A.A. trophy.

The N.C.A.A. Basketball Tournament Committee was comprised of H. G. Olsen, of Chio State, chairman, John Bunn, of Stanford University, and Forrest C. Allen. Burn resigned, and C. S. "Hec" Edmundson, of Washington State, was appointed in Burn's place. I was named as manager of the western play-off and the National finals, and made all arrangements for the set-up. E. C. Cuigley was named as supervisor of officials. The following officials were used for the games: Ted O'Sullivan, Hansas City; Abb Curtis, Fort Worth; Dudley S. DeGroot, Rochester, N.Y.; L. B. Vidal, Denver; and R. L. Barton, of Denver, and Gilbert McDonald, of Madison, as alternates.

I believe everybody agreed that it was one of the most successful tournaments that was ever held, and I am told by Jimmy Nixon and Mr. Zachman that the paid attendance at the Municipal Auditorium topped the paid attendance figures of any basketball crowds, not even excluding the National A.A.U. basketball championships that were held in old Convention Hall. If you desire a figure on this Jimmy Nixon will give it to you. Many people were under the impression that the old A.A.U. crowds outranked this attendance at the Municipal Auditorium, but this is not true.

Dan, I will appreciate your writing this at your earliest convenience, and I assure you I do not want to put you to undue pressure just prior to your stepping off, but I would appreciate it at your convenience. This, as you know, is to be the feature article that will be in the front spot of the Baskethall Guide for next year.
