Dear Ole:

I beg to accept receipt of your wire of the 18th instant reading as follows: "Please hurry final report if at all possible."

Ole, I want to assure you that I am even more anxious than you are to get this thing cleared up. I have called and endeavored to make appointments with Smith, the printer who printed our programs, and he has either been out of town or something has thwarted my move every time I have made an attempt to settle the bill. Frankly, I feel as if we are going to have bad luck on the proposition, but last week I got hold of his secretary and she stated he would be in town Tuesday morning, November 19. Therefore, as soon as my 10:30 class is over, I am leaving for Kansas City to keep this appointment.

We are not having any luck in our collections, so I am going to put in these bills as uncollectable, so far as my report is concerned. And tomorrow when I pay this fellow I will follow with a report on Wednesday and send you what money we have on hand and call the matter closed up.

If it had not been for this hang-nail, we would have closed the tournament business a long time ago and been rid of the very difficult situation. However, had we closed earlier than a month ago, we would have an old bill to settle to the Kansas City Journal. This is one of the newspapers that Bowles gave the advertising to and they charged it to him instead of to us. And then, not being able to collect from him, they sent us the statement and wanted to know if there was any way they could collect the bill. This being the first that I had heard of it, I asked them to mail me the bill and I sent them a check. So I am sure now there are no outstanding bills. I believe if I were you I would try to hold back this whole amount for emergencies, but that is up to you.

I am so sorry, Ole, that my teaching schedule and my basketball practice have been such that it has ham-stringed me and prevented me from getting away any one full day in any week. I had October basketball practice due to the fact that I lost most of my regulars and I thought that I would start out on fundamentals and try to develop a bunch of youngsters into a better group of ball

handlers. On Mondays, Wednesdays, and Fridays I have classes at 9:30 and 11:30. On Tuesdays and Thursdays I have a class at 9:30. Therefore, it made it very difficult for me to drive to Kansas City and get back in time for 3:30 basketball practice. Then, too, I had complete charge of the Community Chest drive of Lawrence so far as the entire University was concerned, and then we had a Y. M. C. A. drive on here and I was stuck with that. So I have been busier than the proverbial "one-armed paper hanger with the itch."

I guarantee that there will be no such hang-nails attached to the next tournament that I have anything to do with.

Dear Ole:

I had hoped that you and I could get together between now and one of the Thanksgivings, but I believe that is impossible so I will endeavor to put on paper what I discussed with you over the phone when I was in Chicago.

I dropped into Major Griffith's office and he asked me to the Wailing Wall Luncheon, which was Monday noon. He also asked me to come in and spend some time with him. Then he got out his papers and showed me he had money to the amount of \$8,269.11, and he wanted to know if I would tell him how the money should be distributed; that they were quite anxious that the money be sent to the colleges. He said if I would give his secretary the method of distribution, he would see that the money was sent out. He asked, "Or do you want to send it out?" I insisted that the checks should be written and disbursed by him. I suggested that they all be made out to the Athletic Association of the various schools and universities interested.

Then we tried to arrive at the amount. We deducted \$2500 from the \$8269.11, which left \$5769.11. Then we divided this \$5769.11 in half, giving the NCAA 50%; which left \$2884.56 for distribution in 14 parts. Indiana and Kansas to receive 3/14, Southern California and Duquesne to receive 2/14, and Colorado, Springfield, Massachusetts College, Rice Institute and Kentucky Teachers to receive 1/14.

Then I tried to figure out where the remaining money was and I figured that if you had \$9512.12 as shown on your report, that you had perhaps taken 10% of \$9512.12 and withheld that, which would be \$951.21. Deducting the 10% from \$9512.12 would leave a balance of \$8560.91. There would still be a discrepancy of \$291.80.

Your telephone message explained the situation to me. I went back to Major Griffith's secretary and stated that I thought it would be better if they could get the definite report from you, and of course, I realize that I was the very individual holding it up, but I was holding it up because I could not find this fellow Smith in his office. Tomorrow, Tuesday, I am going to go down to the City and make this settlement, then on Wednesday I will send you what remaining money there is with a check and a report.

Ole, here is what I frankly think. I believe if you and I could sit down with Major Griffith and tell him that the 10% cut and the 50% cut is too much, he made me definitely understand that they would make the adjustment in the way we feel would be just and honest. There are just a few men running the NCAA and I know the rest of them would go along. After our "Custer's Last Stand" in the

room with those NCAA people I was not going to rise and bicker over the 10%, but I know that we can get a fair settlement and it certainly is not right for them to take 10% first and then take 50%. I will not quarrel and it would have been out of place for any voice to have been raised at that meeting. But the fact that Major Griffith wrote you and stated that the findings were as those set forth in the letter; namely, that no hotel and traveling expenses would be allowed them, showed me conclusively that they were all mixed up.

Therefore, I think very definitely, before this money is distributed that we should have a meeting and I am sure Major Griffith will go along with us because we have a set-up wherein we will make the NCAA a lot of money, if they do not "kill the goose that lays the golden egg."

Major Griffith said to me, "Phog, do you think the boys will be satisfied with such a settlement as this?" And the interesting part of it was, Ole, that he was not clear on the settlement, and he continued, "Well, Phog, if they are not, you and Ole and Saint and some of us will get together and we will make it right." He stated that the difficulty with a lot of these fellows is that when they make money they want to spend it all. He spoke about Butch Cowell, who passed away last year. He stated that Butch was a good fellow but he was Chairman of the NCAA Boxing Committee and these members would want to have about three meetings a year and spend a lot of money while they were in session, but the meetings were too often and too expensive. I said, "Well, Major Griffith, that is not true in regard to our meetings," and he hastily agreed.

I told Major Griffith that we had been as conservative on our expenditures as if we had been handling University money; I told him of some of the expenses that were too large and that we refused to approve them, and we made nobody angry. I mentioned the fact that I got letters from you and we presented them in such a way, without using the officers names, and we told them the Committee would not approve such expense accounts. I stated the business manager had perfect confidence in what we had done, and further that President Owens had attended the finals and complimented the Committee most highly in the collegiate atmosphere which the Tournament seemed to possess.

I just know, Ole, that inasmuch as the NCAA Executive Committee set-up is not clear and inasmuch as we are making an agreement to last for the NCAA Basketball teams to follow, I still believe that we could benefit by meeting with Major Griffith and getting an agreement; namely, 50% of their net with the NCAA without this first 10% cut.

Kansas is to play Loyola in Chicago on January 2. I am wondering if there is any way that we could meet with you and Major Griffith that date, or will he be back from the New York Meeting? Will you please find out and let me know? I imagine you will be busy but thought perhaps I would take a fling

at this. The only other alternative is a meeting before Christmas. Our Christmas recess begins on December 20. Would it be possible to meet you in Chicago and discuss with Major Griffith this problem about that time. I think it is very worthwhile, Ole, because what little we spend on a trip like that will be made back many fold to the teams in the prorations.

Please let me hear from you at your early convenience.

Dear Ole:

Please find enclosed a copy of the financial report of the Western and National NCAA Tournament, held in the Municipal Auditorium in Kansas City, Missouri on March 22, 23, 30, 1940. The original copy has been sent to J.W. St. Clair for his signature, and he in turn will forward it to you.

Since the two tournaments were held in such close proximity, from a calendar standpoint, I am letting one financial report do the job. If you desire to have this broken down into two tournaments we can do it, but it is only a matter of clerical work and at the present time I have not had the opportunity. Last summer my secretary who had done all the bookkeeping and clerical work resigned, and at the beginning of the school year a new secretary came in. This makes for added work at this moment and for that reason, and the fact that school is on in full swing, prohibits my doing this at the present time. However, it is an easy matter to break this down into two separate tournaments, if you desire.

You will also find enclosed a check which will balance the income and the expenditure. I have deducted the expense of my trips to Kansas City and also the trips to Chicago from the amount remaining in my hands. I am sending you a check for the difference.

A short summary of the Tournament may be in order:

Newspaper publicity:

I advertised in all the newspapers within a radius of 150 miles of Kansas City. I used two-inch double column and found that it got excellent results.

Clerical expense:

Clerical expense had to do with bookkeeping, ticket selling, public address system, the Naismith Memorial (between halves) as well as telegrams and telephone calls.

Luncheons:

The luncheon expense was for the four teams that gathered together prior to the first game of the Western Championship.

Ticket sellers & clerical help:

The ticket sellers and clerical help expense is for services at the Kansas City Municipal Auditorium.

Games Committee and Officials Expense:
This item is self-explanatory.

Guarantees and travel expense to competitors:
This item is self-explanatory.

Equipment:

Equipment and balls used in the tournaments. A bill for \$7.57 from Herff-Jones, which is included, is for one belt buckle that seemed to have been lost during the distribution in the Auditorium. It was necessary to buy one of the boys a belt buckle.

Motion pictures and permanent records:
This item is self-explanatory.

Buildings and Grounds expense:
This item is self-explanatory.

We received \$840.90 from the programs as income, and they cost us \$727.52. We would have made some money had it not been for the promoter going bad who handled the programs.

I am also sending you canceled checks and bills. If there is any additional information you desire I will be very happy to send it to you.





So - I marked your file up to September 15th. But, we still haven't received your check.


Seriously, Phog, I don't like writing these letters any more than you like to receive them, but I just can't understand why you haven't straightened out this bill.



Dear Harold:

I have your letter of the 11th instant, and I have just now put in a long distance call for George Bowles and have had a messenger sent for him. The operator has reported that there is no one in his office but they have left a message under his door for him to call. So we are having the same bad luck.

I am planning to come to Kansas City in the very near future, but today and tomorrow I have appointments here coaching the varsity basketball team. Wednesday I go to Hill City for a commencement address, and on Thursday to Seneca, Kansas, for a commencement address. On Friday and Saturday I go to the Big Six Conference meet at Lincoln, Nebraska. Next week I go to Humboldt on the 21st, to Marysville on the 22nd, and to Wamego on the 24th - all for high school commencement engagements.

I am hoping that you can put some pressure on George Bowles. Why would it not be better to send some one over to the Finance Building and get a report on Bowles' whereabouts. The fact that he does not have a telephone makes it difficult for me at this distance to get in touch with him, but your firm being there in Kansas City could send a collector or some emissary over there and get the background. Then you could write me, and we three could get together.

I gave Bowles a check for \$145.00 as his one-fourth of the advertising that he had solicited and the amount that he was supposed to collect for us. He stated that the advertising was payable as soon as they obtained it. So the amount of revenue that you mentioned in your letter is not the net revenue. Before paying this check I would much rather have a conference with you and with Bowles.


We would appreciate that.

Dear Harold:

I was shocked and chagrined on receiving your bill for \$727.52. This program printing is an entirely separate proposition from the receipts of the National Collegiate Athletic Association and cannot be paid for from those funds.

George Bowles came to me and wanted to get out a program, stating that he could make several hundred dollars on it. I presumed that he would keep the printing costs within bounds. For the life of me I cannot understand it. I think we are going to find it necessary to have a conference.

The programs sold for 15¢ a copy and it was my understanding that most of them were sold. I do not understand how programs could cost more than their printed face sales value.

Bowles received 25% for soliciting the advertising, and the rest of it is to be used for paying expenses and supposedly making a profit. We have the money taken in from the sale, less the 25% paid to Bowles for advertising. I suggest that you and Bowles have a conference at once with a view of Bowles collecting the advertising money and applying it on your bill.

I am expecting to leave for Chicago today at noon on the one o'clock streamliner and then I am going to Wichita for a Monday noon Rotary meeting, and on Tuesday I am to be at Russell, Kansas, for a Chamber of Commerce meeting. After that time I will return to Lawrence and I will be glad to discuss this proposition with you.

Dear George:

I was shocked to receive the bill of \$727.52 from Smith-Grievess for the programs of the Western championship semi-finals and the N.C.A.A. finals. You represented to me that the programs would be something like \$400 and that there would be a profit in the programs.

According to the bill submitted by you we would be lucky if we get out with our lives. Inasmuch as I delivered the N.C.A.A. letterheads to you so that you could send out the bills, and since we have not received one dollar from this advertising as yet, we are in a very precarious situation.

We expected you to make the business arrangement with Smith-Grievess to keep inside of the expenditure. This apparently you have not done and I do not see how we are going to make both ends meet. I am asking that you kindly take immediate steps with the people who have advertised and see if we can get enough money to reduce this indebtedness. Frankly, I do not see how we are going to pay the bill.

You are familiar, I believe, with the shortness of time we were given to produce these programs. It was really handled under terrific pressure.


We understood that you were well pleased with our performance and our billing on this job we consider to be fair and entirely in line with the amount of work done.
