As a matter of formal record I am attaching excerpts from minutes of the Executive Committee meetings bearing on disposition of matters pertaining to the basketball tournament:

- 1. Recommendation of the Rules Committee for holding the 1941 tournament finals in Kansas City, Mo. was approved.
- 2. Following a full discussion of the recommendations of the Basketball Rules Committee regarding the prorating of tournament receipts, it was voted to amend the Executive Regulations as follows:

Section 4 of Division II of the Executive Regulations was amended to read:

Distribution of Receipts. The income from championship meets and tournaments shall be applied and distributed as follows:

- (1) To pay the expenses of conducting and promoting the meet or tournament.
- (2) Ten percent of the net receipts (after deducting the expenses specified in Subdivision 1) shall be paid to the general fund of the Association.
- (3) The balance of net receipts, up to the amount of the traveling expenses of competitors, may be prorated among the competing institutions. Such traveling expenses shall be limited to first class railroad fare and standard (lower berth) pullman, with no coverage for hotel bills, meals and other expenses. In the case of track and field championships the prorating for payment of traveling expenses shall be limited to point winners in the meet.
- (4) Any balance of net receipts (after deduction of the items specified in Subdivisions 1, 2 and 3) shall be paid to the Treasurer of the Association and distributed by him as follows:
- a. To repay to the general fund of the Association the amount of any deficit incurred in previous years in the sport involved.

b. If any balance remains, fifty percent thereof shall be paid to the general fund of the Association and fifty percent may be prorated to the competing institutions, on a basis determined by the rules committee of the sport and approved by the Executive Committee.

It was understood that this Regulation was to be made retroactive to apply to the 1940 basketball tournament; and that in the case of the basketball tournament, playoffs and finals be dealt with, for accounting purposes, as a single tournament.

3. The recommendations of the basketball rules committee for the proration of receipts (under paragraph b, section (4) above) for the 1940 and 1941 basketball tournaments was approved, as follows: Such amount shall be divided into fourteen equal parts, one part going to each of the eight competing teams and an additional one part of each of the four semi-finalists and an additional one part to each of the finalists.

The full text of these actions will, of course, be published in the Bulletin.

Dear Johns

I have your letter in which you give me as a formal record excerpts from the Executive Committee meetings on the disposition of matters pertaining to the basketball tournament. I want to thank you for sending on this information so promptly. Just as soon as I hear from "Phog" Allen with the final report on the Kansas City end of the tournament, I will be able to get the final report of this year's business into you.

Basketball Rules Committee had with the Executive Committee was very fine and will be productive of a lot of good. We have now a much clearer understanding of how the Executive Committee desires us to handle the tournament matter and we will, therefore, be able to present a much clearer picture to basketball men throughout the United States.

There is one matter however which I still think is not properly set forth in your letter of September 10. You will recall we had considerable discussion in the meeting as to the N.C.A.A. guaranteeing expenses of teams to the tournament and it was agreed that the N.C.A.A. was not going to assume any responsibility for the expenses, etc., to play-offs within any district; that those play-offs within a district which were looking forward to selecting the representative from that district would be handled by the teams involved; that they would stand the risk and that they would get any profits which came from such play-offs. As to the Western play-off and Eastern play-off and the final game however, it was my understanding we should be able to guarantee expenses of the teams which are involved.

Now, in your notations regarding the distribution of receipts, your third item dealing with the balance of net receipts states that traveling expenses, that is, first class railroad fare and standard lower berth pullman only should bepaid, that there should be no payment of hotel bills, meals and other expenses. That was not my understanding and I don't believe we should be operating on that basis in our basketball tournament. In other words, I believe there should be a slight change in this matter of distribution of receipts to conform with what, I am sure, was the understanding of our Rules Committee men with respect to item three under the general heading "Distribution of Receipts" in your letter of September 10.

I know you were endeavoring to have a uniform method of accounting for all tournament events, however, I notice you do make one special citation with regard to track and field championships and it seems to me we should make another special notation with respect to the basketball tournaments which would permit the Tournament Committee to guarantee all expenses including hotel, meals, etc., instead of just railroad fare and pullman. While there is no doubt in my mind that the tournament will bring in enough revenue to the teams which compete to care for hotel and meals, still I am very sure that the Tournament Committee will find it embarrassing to talk to teams about coming into the tournament if we can't tell them flatly that we are going to guarantee all expenses to the tournament, and also hold out to them a chance of some additional income through the method of prorating which we have agreed upon.

Inasmuch as all expenses were paid in this manner for the 1940 tournament, I would feel I would have to make my report on this year's tournament on that basis and I feel sure the 1941 tournament should be handled in this same manner.

I would appreciate some word from you as to whether this would be a proper method for us to follow.

You know, Ole, I will agree to most anything for the sake of harmony and compatibility, but I think after we had a clear out and out understanding with these people and then for them to come back with the statement that they did, that it can hardly be charged to misunderstanding or even neglect. The way that it was worded made me definitely feel that while they were trying to make a rule that would apply to everything, it was definitely crippling our sports so that we could not have gone through with another tournament with anything but a failure sign tacked to it before we started.

For that reason I think we had better guard our tournament all that we can since basketball has made money and will make money everywhere that we play it if we use any reasonable course in a fair degree of business acumen. Dear "Phog":

I have received a reply to my letter to Major Griffith, with respect to our being able to guarantee expenses for basketball teams in the Eastern and Western play-offs and the final game. He has agreed that that was the understanding and was the way basketball should be handled. I think the statement as sent out in his letter was a hangover from their idea that they wanted some rule that would cover all sports. Well, that just doesn't work out in our case and I have his agreement to make an exception for basketball, the same as they have made to the general rule for the track event, so we are at liberty to go ahead with the matter of guaranteeing the teams' expenses when they participate in the Tournament. That does not include however the play-offs within any district.

President Owens, at one time or another, has suggested allowing expenses at the rate of \$5 per day per man and Griffith asked me what I thought of that amount. I, in turn, am asking you if you think that is adequate and I would like to hear from you on this point before I answer Griffith. I know that out on the Coast when you are traveling there, most of the time you can secure accommodations, hotel and meals, for the flat rate of \$5 per day. Possibly that would be a good figure for us to adopt, but if we think that isn't adequate it seems to me we should so indicate now. Please write me about this.
