





Dear Friend:

In the development of any project certain problems arise that at first were not anticipated, problems that must be solved as the project progresses. It was our original plan to build a Student Union Building, costing \$200,000.00 or more, as a memorial to Dr. Francisco. Our campaign has brought us approximately \$10,000.00, most of which has been paid in cash.

At a recent meeting of the Endowment Committee the fact was stressed that perhaps we should not dedicate a building of this magnitude to one man. It was, rather, decided to set aside part of this building as a memorial to Dr. Francisco and to go ahead with our campaign to build a building with that thought in mind. The exact form that this Francisco Memorial will take, of course, cannot be determined until funds are available. It may be a social hall, a gymnasium, or a wing of the building. We are emphasizing the fact that there are two projects. We have been trying for five years to got a Student Union Building. This building will, because of its nature, never be supplied by the state. We see an opportunity to establish a memorial to Dr. Francisco in this building. Our School of Medicine has many friends, some of whom were not well acquainted with Dr. Francisco, who will help in the erection of a Student Union Building but who would not contribute to a Francisco Memorial. On the other hand, we have already found a great many individuals, you to whom this letter is being directed, who are interested in a Francisco Memorial. We hope to attain our goal of building a Student Union Building in which there will be a Francisco Memorial by asking for help from those who have a specific interest in each problem.

We want those who have contributed to the Francisco Memorial to know that their money will be spent for a memorial but we feel it will be impossible to raise sufficient money to erect a building on this appeal alone. We must have help from those who are anxious to see a Student Union Building on our campus but are not as much interested in the Francisco Memorial.

A new impetus has been given to the project by a group of individuals who have agreed to give a total of \$500.00 during the next three years to the project. These pledges are being given with the understanding that at least forty must agree to give this amount also. If you have the vision of a greater Kansas University School of Medicine, and if you have sufficient interest in the comfort and happiness of our medical students to help on this committee of forty, your pledge will be greatly appreciated.

Gentlemen:

I observe that the floor of the shower room is in rather an unsanitary condition, so far as the possibility of the spread of athlete's foot is concerned.

My only purpose in writing this letter is to endeavor to improve the situation. We have had a very profitable experience in our gymmasium where we have over five thousand men a week using the showers in the basement of Robinson Gymmasium.

It may sound boastful, but we have had no knowledge of any cases of athlete's foot come to our attention by hospital authorities. It has been more than a year ago that the Cramer Chemical Company, of Gardner, Kansas, installed some three-foot-square wooden boxes. The boxes are about six inches high. They did this as an experiment with no cost to us. An antiseptic powder - a fungus germicide - was used. This powder was perfected by Dr. L. L. Boughton, Dr. A. J. Mix, and Dr. E. L. Treece, and it has done a wonderful job. It is rather a departure from the old liquid antiseptic used in so many shower rooms because the feet should be dried first before the individual steps into the box. This insures a dryness between the toes, which is more beneficial than moisture where athlete's foot develops.

The old name of athlete's foot was "Hongkong" or "Asiatic" foot, developed in warm climates where the temperature was very high.

Cramer Company retails this powder at 16% a pound. We buy it in 100 pound lots. If the Country Club would like to experiment with this we would be glad to let the Board of Directors have any amount that they would like to try out before they purchast it, at the regular cost to us.

There is a rubber container propped up against the wall near the shower bath. It is not as large as would be most satisfactory for a number of bathers, but it would serve the purpose for a trial.

I bring this to your attention because I have heard a number of old time members say the reason they do not bathe at the Country Club is because they are afraid of athlete's foot. You can easily see they feel the Country Club shower room floor is not kept in a hygienic condition.

I had a speaking engagement at Salina, Kansas, on June 6, but yester-day they called and cancelled it, and was I happy. I am practically through now with most of my speaking dates and feel a great relief. When Mother and Eleanor went with me to Slater, Missouri, we drove back that night and got in about 2:30. It has been that way on almost all of the automobile trips.

This is just a short note to let you know that I did recall the first note after I had mailed the second one. Hope you are all well and happy. And of course we must include Stormy because Mother tells me that he is one of the prize possessions of the Mons household. I also read your letter about the friend of yours that shot himself. I was so sorry to learn of the unhappy incident.
