## MANUAL FOR BASKETBALL SCORERS

### Equipment:

1. Scorebook
2. Pencils
3. Substitution slips

### General:

The Official Scorer is to be a member of the athletic department of the host institution. The scorer for the visiting team is to be seated between the Official timer and the official scorer.

### Before the Game:

1. Provide opportunity for coaches to submit line-up at least two minutes before game time.
2. Do not permit changes in the line-up until after a play has ensued unless there is an injury or another emergency.
3. Report to the Referee if the line-up is not submitted on time.
4. As play is about to start check the five players who appear to be ready to start and their numbers with the line-up in your book.
5. Notify Referee if there is any discrepancy. It is not necessary for you to wait until he has tossed the ball.

### Before the Second Half:

Check starting players with your line-up and report to the Official if any new player is starting without having reported to you.

### Communication with Officials:

#### Notify Nearest Official:

1) When a team has had five charged time-outs during regular playing time.

a) One additional time-out may be granted each team for each over time period of a tie game.

2) Immediately when a player is charged with his fourth personal foul.

3) As soon as the ball is dead in case there is a dispute about the score or in case there is doubt about an Official's decision.

4) As soon as ball is dead or in control of offending team in case a player is discovered who has not reported to the proper officials or who has changed his number without reporting it.

The Official will indicate the number of free throws which are to be tried by standing at the free throw line with the proper number of fingers held up. The number indicates how many free throws remain.

He will indicate a personal foul by holding his hand above his head as specified in the rules.

He will indicate the number of the player who fouled by some system which he should explain to you before the game starts.

### Scoring Technique:

Become familiar with the technique outlined in the scorebook you are using. You should observe the following:

#### FUNDAMENTALS:

Use: P for personal foul.

X in loop of P when two free throws are awarded.

T for technical fouls.



2 for each field goal.

0 for a missed free throw and 1 for a successful free throw.

Have running score available at all times.

List the number of charged time-outs for each team.

Making Substitutions:

When a substitute reports, signal as soon as the ball is dead. Allow substitute to go on court only when the Official has signalled by motion of his hand or hands.

Do not signal after a free thrower has started his throw. In the case of multiple throw or throw for a double foul, a substitution may be made between throws. If the thrower is to be replaced, be sure that it is permissible for another player to attempt that particular throw.

The Scorer is not to recognize a substitute unless the substitute is ready to enter the game for immediate competition.

Questions:

May the Scorer signal for a substitution when the ball is in possession of the Substitute's team but not dead? Answer: No.

May he signal after a successful goal before the opponent throws the ball in? Answer: Yes.

Should Scorer sound his horn if a substitution is made during a period when time is out? Answer: Yes.

Miscellaneous:

Do not take chances by guessing at the Official's decision. If there is doubt relative to data which must appear in your book consult the nearest Official as soon as the ball is dead.

In order to avoid mistakes it is mandatory for the Official to designate the player who has committed the foul by having the player turn his back to the Scorer's table so that his number may be seen.

To All Big-Six Coaches:

I understand that the Big-Six Athletic Directors will meet on March 1 at the Big-Six Indoor Track Meet and that one of the subjects that they are to discuss regards the scouting of basketball games.

Nothing has been said to me about the matter, but I believe that Big-Six Coaches should take it up with their Athletic Directors and present the legitimacy of scouting basketball games the same as the legitimacy of scouting football games.

Of course, scouting can be overdone in basketball as in football. But since scouting is done on a big scale in the Big-Ten perhaps it might be well to agree to some sort of a scouting schedule for the Big-Six.

Perhaps it might be well to agree to some sort of a scouting schedule, but since nothing has been said to the Coaches, it might be up to the Coaches to protect themselves by contacting the directors.

While this is being done would it not be fair and equitable to protest the discrimination that is now practiced by the Big-Six in limiting the number of players on visiting and home-team rosters? Certainly no other sport is discriminated against as is basketball, and it is unfair and certainly not in keeping with the professed public utterances of the conferences in regard to the Defense Program of the U. S. A. If we as coaches remain supine and inherent, then we have no one else to thank but ourselves.

Would it not be the proper thing to have Mr. Menze, our secretary, take it up with George Veenker, secretary of the directors, and present our case? Certainly we have one.

BIG SIX CONFERENCE

March 3, 1941

To Basketball Coaches:

At a meeting of the Directors of Athletics of the Big Six Conference on Saturday, March 1, I was assigned the job of selecting the basketball officials. The assigning of officials for basketball will be handled in the same manner as the football assignments. Detailed information concerning the manner in which this is to be done will be presented at your meeting here on March 22. Here are some suggestions that you might be thinking about between now and March 22.

You will be asked to make out a preferential list of at least ten officials and in the order of your preference. We will decide at the meeting the limit to this list.

Officials are to<sup>be</sup> appointed by this office for all games.

Assignments will be made as soon after your meeting here on March 22 as possible.

When your preferential list is made, you will have the privilege of listing any exceptions you care to make at the bottom of the list. It would be much easier if officials on your list were to be available on all courts; at least we can work towards this idea.

Regardless of any plan that may be used for the selection of officials this thought must be always kept in mind, namely, that coaches are to be given the officials they want. It is a part of our job to improve these officials wherever possible.

Selections will be made from the top of your list whenever possible.

Be ready to decide, as a group, on a limited list of officials; it will be necessary for two or more coaches to agree on an official for that official to get on the list. Some plan will be made whereby new officials may be worked in your non-conference games that we may have an opportunity to judge the ability of new men. This can be done between this office and the individual schools.

Will you have as much of your non-conference schedule completed by the time of the meeting as possible.
