Dear Henry:

I acknowledge receipt of your Western Union telegram of this date. I immediately called you on long distance this morning and found that you were to be in St. Louis at the Nelborn Notel, so I thought I had better write you at Stillwater as you will get the full information when you return home. We are playing at Nebraska Saturday night and at Iowa State Monday, so will not return until Tuesday. I imagine this is about the time you will return to your campus.

On February 7 I received a wire from Joe Mayfield asking when the dates of the N.C.A.A. tournament were scheduled. I gave him the full data. At first, when the wire was received, I presumed it was from your office, but later I learned it was from the O. Collegian. I presume, therefore, that you have before you all the dates for the N.C.A.A. play-off.

Last year when the Rules Committee met in New York in April these dates were set. They were agreed upon because of the fact that many schools like the Pacific Coast Conference had a northern and southern play-off at the close of their regular playing season. This was to determine the Pacific Coast championship, and of course not having a champion determined before that date it would be impossible to push up the finals or semi-finals.

All of us in the Big Six Conference endeavored to close our playing season by March 1, but it was not possible to do so. Even had we done so there would have been just as long a lapse between the semi-finals and the finals as there is now. These are the same relative playing dates that they had last year. If it were not for the Pacific Coast Conference we could have pushed up our playing dates all around one week.

I realize that any schedule that you make would inconvenience someone. But I do trust that you will understand that the National Collegiate Athletic Association Basketball Tournament Committee is striving their level best to do everything within their power to please every one of the competitive members.

This morning's issue of the Topeka Daily Capital, dated February 23, carries an A.P. article out of Stillwater blasting the Big Six and the N.C.A.A. for late basketball climaxes. I can not believe that they are quoting you correctly, although some of the statements they allegedly give you credit for are as follows: "I am not going to be yokeled into playing two games. We have already won our conference championship. Let them determine their winner and then we will play their champion. This whole thing should be set up in advance so that everybody would know what is coming off, because Big Six teams spread fifteen or eighteen games out until well in March. We should be going into the play-off right away, not that late when interest in basketball is beginning to lag. If the Big Six ends up in a two-way or three-way tie, it is a cook-eyed cinch those fellows will settle their own champion-ship before we get matched up with any of them."

Now, Henry, you know that no one has endeavored to take advantage of you in any way, and if there is a two or three-way tie, certainly the Big Six would want to settle that of themselves before they would play the Missouri Valley champion in the play-off. The only reason for the extra teams in last year was because there was a two-way tie in each circuit.

made by you are injurious to basketball. We must permit each conference to handle their affairs as they see fit and not question the motives of any of the men in it. If the Oklahoma Aggies win the Big Six champion play-off you will find everybody behind your team one hundred per cent. Frankly, I believe the N.C.A.A. should be commended for their effort to elevate basketball beyond the promotional stage.

been planmed that if it was an all-Oklahoma event it would be played off the week-end of March 15th, and I cannot see that it makes any difference when the Big Six champion is determined so long as they are ready to play the play-off with you that week-end.

No member of the N.C.A.A. Basketball Committee draws one penny, and I am sure you will agree they draw a lot of grief in promoting this game for the sport and for nothing else.

The personnel of this Fifth District N.C.A.A. Basketball Play-off Committee is as follows: Dr. H. H. King, faculty representative, Kansas State College, chairman; C. E. McBride, of the Entative, Kansas City Star; Bill Williams, athletic director, Drake University; George Edwards, of the University of Missouri, and myself.

It has long been a practice of the N.C.A.A. that any member of this committee who has a teem in the play-off shall eliminate himself from the committee. Therefore, if either Missouri or Kansas should win the Big Six, then the coach of that school will be automatically eliminated from sitting in the committee and determining his team's chances. And too, Hank, it is impossible to set a place for the play-off until the two winners can be determined. I personally committed myself for Oklahoma City if Oklahoma and Oklahoma A. and Me won. When the two winners are determined then this committee must make the decision as to the location of the play-off, and I am sure they will be infinitely fair in every respect.

Last night Harold Olsen called me from Columbus, Ohio. I told him of the fine record that you had made and he is very anxious that you be represented in the tournament. I assured him that you had made a statement to me last year in the presence of Tom Stidham, Bruce Drake, Bus Ham and Cob Burnside at Oklahoma City that you would stick by the N.C.A.A. basketball play-off, and I am very sure that your loyalties are with the organization of which you are definitely a member. By bringing up college basketball in its finest way you are making durable contributions.


