

I hesitated in writing to Eilers or Peters as you suggested in your letter of July 13 for fear I could not correctly interpret our previous correspondence respecting choice of officials.

I have no particular interest in having Van Reen at either place. I think his work would be satisfactory if he is assigned with Gibbs or Curtis. I have the same feeling respecting Oberhelman although I believe him to be some what inexperienced. I interpreted your letter of July 13 as desiring Gibbs or Curtis to work with either Van Reen or Oberhelman. Since you mentioned Van Reen as a first choice on June 30, I thought he was next in line.

Regardless of this previous correspondence, we definitely want the choice of officials to correctly reflect our honest judgment. I will gladly write to Eilers and Peters and stress the fact that Oberhelman should be considered in the same respect as Van Reen.

Why note use Oberhelman at Omaha and Van Reen at Lawrence? In each game Gibbs or Curtis to be the first choice. Also in the interest of less travel and expense, why not forget Van Reen and use Oberhelman at Lawrence and Roper at Omaha along with Curtis or Gibbs, depending on which ever of these two would be available. I have your letter of June 30th. Undoubtedly Gibbs and Curtis are the best basketball officials in the middle west. I also believe that Van Reen is most capable. Oberhelman is satisfactory but lacks experience. Probably he should not be required to work unless he is assigned with one of the better officials.

I hesitate in attempting to choose the better officials because of the expense involved for their travel. I would like to suggest using Oberhelman at Lawrence with either Gibbs or Curtis. At Omaha, if we can secure Gibbs, I would like to suggest Roper or Harrison to work with him. Thus, in both games the additional expense of the distant officials can be offset.

Van Reen would be satisfactory at either place. We have used Quigley some in Omaha and I suggest Parke Carroll. I do not believe I would be satisfied with Oberhelman and Van Reen together.

Let me have your reactions to these suggestions and as soon as we have agreed on the officials, we can have Eilers and Peters make these assignments.
