INSTRUCTIONS

For Editing Lineage Records

Please bear in mind that the accompanying Lineage Record, when published in The Compendium of American Genealogy, will be accepted as accurate and therefore every care should be taken to see that each name and date is accurate.

The fact that this work is distributed to the principal libraries thruout the world as well as to practically every public library of any size in the United States makes for certainty that this record will be consulted by many kinsfolk, not only of the present generations but also of generations yet to come. It will hold a greater value one hundred years hence than it holds today and future generations will be under obligation to you for having compiled these data and made them available.

Therefore, please edit this record with particular care, giving especial attention to the spelling of names, and the years of birth, marriage, and decease. If any names or dates are missing and can be supplied, please do so.

Where blank spaces appear in the syllabus please add the missing data if available.

EXPLANATION AND ANALYSIS OF LINEAGE RECORDS

- A—Your name at the head of the record is numbered 1.

 Please see that the names are written in full and properly spelled. Verify the date of your birth, and, if any, the date of your marriage, and the dates of birth of your children.

 This is important.
- B—The first known ancestor in America bears the highest number, which is the number of generations in this country including yourself. By this system of numbering your parents are always numbered 2; your grandparents are always numbered 3; and so on, regardless of the different number of generations in each lineage.
- C—Where the cross reference (qv) occurs (meaning "which see"), following the name of an immigrant ancestor, it means refer to the "List of Immigrant Ancestors," a separate section of the book containing the biographies of over 2,500 immigrant ancestors. This plan avoids duplicating identical data and also brings together into one section the largest list of biographies of immigrant ancestors ever compiled for a single volume.
- D—It will be noted that the surname of the earliest ancestor, in each line, appears in Bold-face type; this is to emphasize that the following generations, whose Christian names only are given, are all of the same surname as the name in the Bold-face type. When the surname is changed by the marriage of a daughter, her husband's name appears also in Bold-face type to emphasize the change in surname.
- By referring to the page of specimen records herewith the above explanations will be readily understood.

ILLUSTRATIONS

Illustrations had no place in the original plan and scope of this work but this feature was granted in response to numerous requests for the opportunity to preserve in print for posterity, portraits and other illustrations of family and genealogical interest as well as the data.

The portraits take on a new meaning when included as a Memorial to the subject and in conjunction with the full family data, together with his, or her, biography. A more lasting and distinctive tribute to a member of the family could scarcely be devised, and it should be regarded a privilege to create such a Memorial.

The Coat of Arms of the family, significant of respectability, dignity and achievement, has its proper place in the family history and lineage comparable to the insignia conferred in the present day for notable achievement. "Sentiment should lead us to treasure the symbol of our sires."

The picture of the ancestral home, shrine of reverence and cradle of tradition, has only too often been lost to posterity thru fading out or loss of the original illustration. Also, photographic evidence of gravestones and other historic spots, facsimiles of signatures, and family heirlooms have their place among the family archives and should be preserved.

Perhaps the fading photograph or daguerreotype of grandfather in the dress of his generation; or that of father in uniform, with an account of his services perhaps never before published; or of mother, brother or husband, whose character and achievements should be an inspiration to his, or her, descendants; or it may be a son whose services in the World War are examples for future generations to honor; any such are welcome.

However, illustrations, the insertion of which is optional, must be regarded as features extraneous to the publication of purely genealogical data, and must, of necessity, be charged for. The cost is \$20.00 each, which tariff, however, barely covers the cost of plates, the space occupied in the work, and the labor incidental to their publication. The plate becomes your property after publication of the volume and will be delivered to you upon request.

ENGRAVING PLATES

Half-tone plates will be made from all photographs. The size of photographs is immaterial. The photographs will be "framed" in order to simulate reproductions of oil portraits whenever it is feasible to do so. Faded photographs will be retouched by the photo-engraving process to recover indistinct features as much as possible.

Send photographs by registered mail. They will be returned, registered, after publication of this volume.

Copies of Coats of Arms for reproduction should be black and white drawings or black and white printed copies. But colored copies can be used if none other is available.

If you have no copy of the Coat of Arms of your family (entitled to bear it) and wish to procure a copy for reproduction in this work we will undertake to procure it without extra charge.
